In response to your memorandum dated June 2, 1999, the Division of Records and Elections has examined the signatures contained on the petition filed in support of the proposed no shooting area located in the vicinity of Ames Lake Plateau (Vincent Precinct), pursuant to the reference.

A review of the legal description attached to the petition indicates that most of the proposed no shooting area is contained within Vincent Precinct. Those areas outside of Vincent precinct were slight and contained few if any registered voters, none of whom signed the petition.

Of the signatures contained on the petition, at least ten were determined to be registered voters of Vincent Precinct. Since that number meets the requirements of the referenced section of the Code to certify, it is determined that the petition for a no shooting area within Vincent Precinct is sufficient.
