BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to the department of transportation, road services

9

division, traffic engineering studies and as authorized by chapter 46.90 RCW,

10

Ordinance 5292, Section 16, as amended, which prohibits parking from 7:00 a.m.

11

to 2:00 p.m. – school days only, along county roads, is amended to add the

12

following roadways:

A. 91st Avenue Northeast, 225 feet south of Northeast 176th Street to

14

92nd Avenue Northeast, east and west sides.

15

B. 92nd Avenue Northeast, from Northeast 175th Street to Northeast

16

178th Street, east and west sides.

17 C. Northeast 175th Street, on the north side between 92nd Avenue
18 Northeast, to a point 250 feet east of 92nd Avenue Northeast.

19 D. Northeast 175th Street, on the south side between 92nd Avenue
20 Northeast and 93rd Avenue Northeast.

21 SECTION 2. Signs posted to evidence the restriction described in section
22 1 of this ordinance shall be installed by the proper authority.

The proposed neighborhood to be affected by this ordinance is adjacent to another neighborhood, which currently has this type of time-restricted parking zone. This ordinance will expand the zone encompassing the existing parking restrictions.

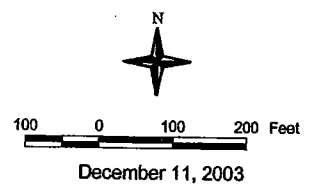
Neighborhood complaints include:

- High School Commuter parking is creating litter and vandalism issues in the neighborhood.
- Large vehicles i.e. school buses have difficulty-navigating roadway due to parked vehicles.
- Parked vehicles reduce the street to one-lane roadway, thereby creating potential access hazard for emergency vehicles.
- Parked vehicles are forcing pedestrians to walk in the travel lanes.

-  Cities



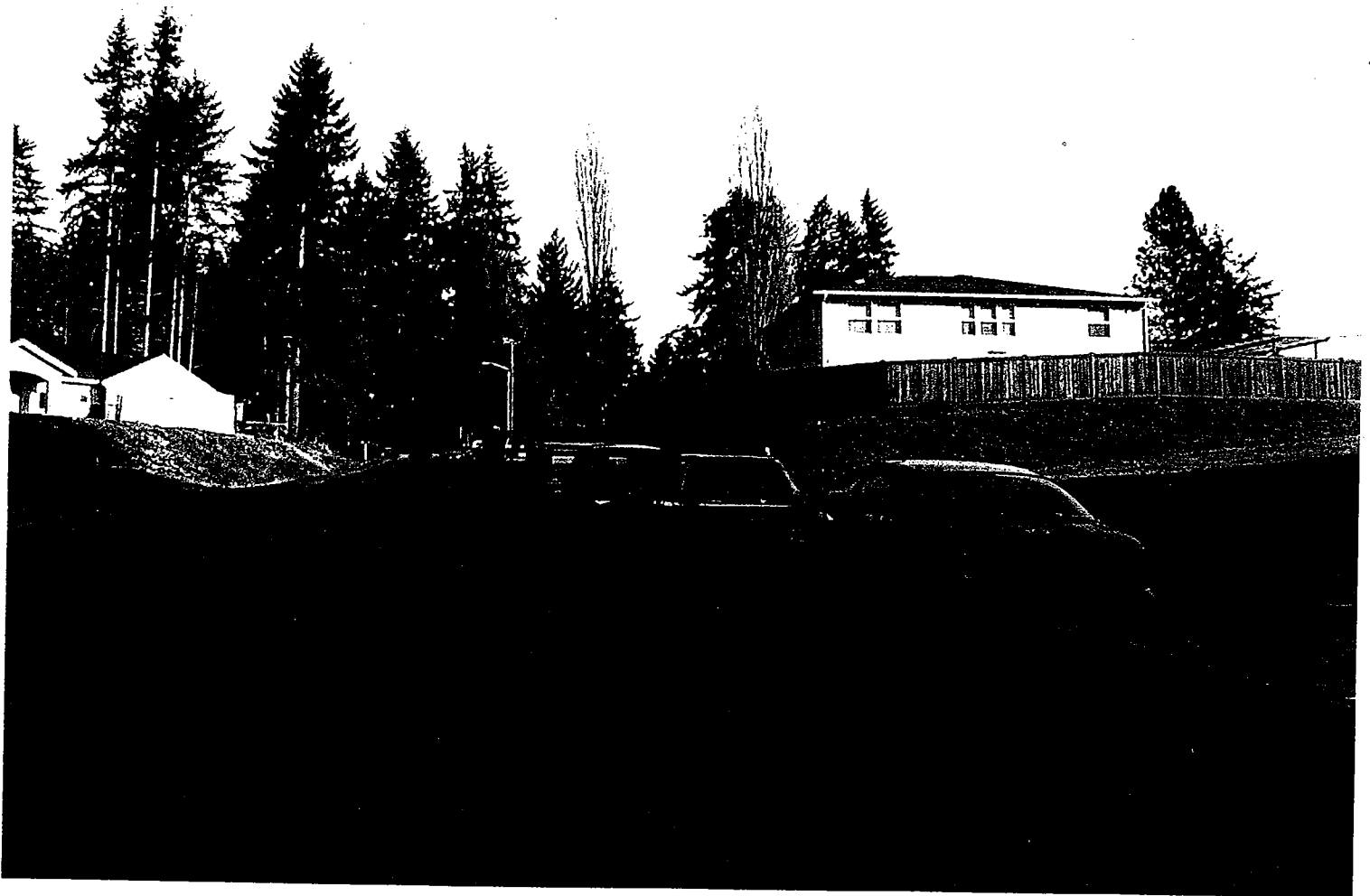
