21 Of this appropriation for CIP project number 395209, King County Office
22 Building Feasibility, \$150,000 may not be expended or encumbered until the executive
23 submits a report and council approves by motion a report that specifies the tenants to
24 occupy the King County Office Building. The report shall include rationale for the
25 tenants and illustrate how the recommendations fit within the project financial proforma
26 and the adopted and proposed annual space plans. The report must be filed in the form of
27 15 copies with the clerk of the council and the chair and lead staff of the budget and fiscal
28 management committee or its successor on or before January 31, 2005.




