1	AN ORDINANCE approving the city of Carnation 2004
2	Comprehensive Sewer Plan.
3	
4	
5	PREAMBLE:
6 .	K.C.C. chapter 13.24 requires approval of comprehensive plans for sewer
7	utilities as a prerequisite for granting right-of-way franchises and approval
8	of right-of-way construction permits.
9	The city of Carnation 2004 Comprehensive Sewer Plan ("plan") discusses
10	sewer service to the city, which is currently served exclusively by on-site
11	septic systems. King County has entered into an agreement with the city
12	and will construct, own, operate and maintain a treatment plant that will
13	receive the city's sewer flows. Sewer service to approximately seven
14	hundred homes and businesses is anticipated to occur in 2007; at buildout,
15	anticipated to occur after 2030, approximately one thousand three hundred
16	homes and businesses will be served.

17	The city is currently working with King County to evaluate ways to reduce
18	sewage flow before construction of the treatment plant. Investing in
19	demand management has been shown in initial evaluations conducted by
20	the city and the county to be cost effective. This potential will be further
21	evaluated before construction of the plant.
22	The plan anticipates a capital cost of approximately \$11.5 million for
23	construction of the local sewer collection system. The county's investment
24	in the treatment plant will amount to at least \$10.6 million dollars more.
25	Funding for the capital improvements will result in monthly sewer charges
26	of approximately \$155 per connection. This amount may vary depending
27	on the amount of grant funding available and future changes to the
28	county's capacity charge.
29	The King County utilities technical review committee ("UTRC") reviewed
30	the plan on May 12, 2004, and recommended several technical changes
31	that have been incorporated into the final plan version attached to this
32	ordinance. The UTRC recommends that the council approve the plan.
33	The city prepared a determination of non-significance for the plan on
34	October 15, 2003, in accordance with the state Environmental Policy Act.
35	The city adopted a draft version of the plan on April 20, 2004, and
36	readopted the draft in October, 2004 and intends to adopt the final version
37	after county approval.
