1 AN ORDINANCE approving the revision of the corporate
2 boundary of the city of Kirkland to include portions of
3 116th Avenue NE and NE 60th Street that are county roads,
4 as provided for in RCW 35A.21.210.

7 **STATEMENT OF FACTS:**

- 8 1. City of Kirkland Ordinance Number 3985, which was adopted on
9 February 1, 2005, revises the city's corporate boundary to include certain
10 segments of 116th Avenue NE and NE 60th Street in the vicinity of the
11 Bridle Trails State Park.
- 12 2. RCW 35A.21.210 authorizes the governing body of any code city to
13 revise any part of the corporate boundary that coincides with the
14 centerline, edge, or any portion of a public street, road or highway right-
15 of-way by substituting therefore a right-of-way line of the same public
16 street, road or highway so as fully to include or fully to exclude that

17 segment of the public street, road or highway from the corporate limits of
18 the city.

19 3. Revision of the corporate boundary of a city is effective upon approval
20 by the city council and the county legislative authority as provided for in
21 RCW 35A.21.210.

22 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

23 **SECTION 1.** The revision of the corporate boundary of the city of Kirkland to

Ordinance 15175

24 include certain segments of 116th Avenue NE and NE 60th Street, legally described as
25 set forth in Attachment A to this ordinance, is hereby approved.







**Legal Description for 116th Avenue NE/NE 60th
Street Annexation to the City of Kirkland**

Located in the NW quarter of Section 16, Township 25 North, Range 5 East, WM, in King County Washington.

That portion of 116th Avenue NE described as the West 30 feet of said Quarter Section;

Together with the portion of NE 60th Street described as the North 30 feet of the NW $\frac{1}{4}$ of said Quarter Section.
