6 1. The Board of Commissioners of the Val Vue Sewer District has
7 determined that it would be in the best interests of the district to change its
8 name to the Valley View Sewer District.

9 2. The district filed Resolution 2007-1 with the metropolitan King County
10 council on February 16, 2007, resolving to change the name of the district
11 from Val Vue Sewer District to Valley View Sewer District.

13 SECTION 1. The metropolitan King County council approves the change in







RESOLUTION NO. 2007-1

A Resolution of the Board of Commissioners of Val Vue Sewer District, King County, Washington, changing the District's name to Valley View Sewer District.

WHEREAS, the Board of Commissioners of Val Vue Sewer District, after due deliberation and consideration of more descriptive names for the District, that will not be confused with the City of "Bellevue" and the services it provides, has determined that the name of the District shall be changed from Val Vue Sewer District to "**Valley View Sewer District**," in accordance with RCW 57.04.065.

NOW, THEREFORE, BE IT RESOLVED by the Board of Sewer Commissioners of Val Vue Sewer District, King County, Washington, as follows:

Section 1. The name of the District shall be changed from "Val Vue Sewer District" to "**Valley View Sewer District**" effective March 1, 2007, subject to the prior approval of the legislative authority of King County, Washington.

Section 2. A certified copy of this Resolution shall be immediately submitted to the King County Council for action in accordance with the provisions of RCW 57.04.065.

Section 3. The Manager of Val Vue Sewer District is authorized and directed to immediately proceed to implement this Resolution so that the formal change of name can be completed by March 1, 2007.


Section 4. Upon approval of the King County Council or the effective date of March 1, 2007, whichever later occurs, all of the existing Resolutions of the Board of Commissioners of the District are by this Resolution amended and shall be interpreted to read "**Valley View Sewer District**" where the words "Valley View Sewer District" or "Val Vue Sewer District" appear in those Resolutions.

Section 5. The Manager of Val Vue Sewer District is authorized to acquire a rubber stamp to be used to imprint the District's new name on copies of previously adopted Resolutions to demonstrate the change of the name of the District as authorized by this Resolution 2007-1.




