6	1. A petition has been filed requesting vacation of a portion of 151st Avenue
7	SE hereinafter described.
8	2. The department of transportation notified the various utility companies serving
9	the area and has been advised that easements are required within the vacation area
10	and have been obtained. Puget Sound Energy, Qwest, and King County Water
11.	District No. 117 have retained Utility Easements under recording numbers
12	20060323000563, and 20060811001099, records of King County, Washington.
13	The City of Bellevue has retained an Agreement Regarding Annexation of Real
14	Estate under recording number 20060210000236, records of King County,
15	Washington.
16	3. The department of transportation is requiring a Drainage Easement for the two
17	road cross culverts conveying and discharging stormwater drainage within the

18	subject vacation area. The petitioners, their heirs or assigns, will be responsible
19	for any future maintenance of any and all drainage systems located within their
20	property outside of the 151st Avenue SE right-of-way and said drainage easement,
21	recorded under Recording No. 20070315001247, records of King County.
22	4. The department of transportation records indicates that King County has been
23	maintaining 151st Avenue SE. The records indicate that public funds have been
24	expended for its acquisition.
25	5. The department of transportation considers the subject portion of the right-of-
26	way useless as part of the county road system and believes the public would
27	benefit by the return of this unused area to the public tax rolls.
28	6. The right-of-way is classified as "B-Class" and, in accordance with King
29	County Code 14.40.020, the compensation due King County is based on seventy-
30	five percent of the assessed value of the subject right-of-way, which was
31	determined from records of the department of assessments. King County is in
32	receipt of \$6,909.75 from the petitioners.
33	Due notice was given in the manner provided by law and a hearing was held by
34	the office of the hearing examiner on the 7th day of March 2007.
35	In consideration of the benefits to be derived from the subject vacation the council
36	has determined that it is in the best interest of the citizens of King County to grant
37	said petition.

51	Avenue SE, as recorded on the Plat of Horizon View Addition Division "A",
52	recoded Volume 48 of Plats, Page 44, records of King County, Washington.

- 5. The subject right-of-way is currently maintained for public use, but is not necessary for the present or future public road system for travel or general utilities purposes (subject to the establishment of utility easements as necessary; see Finding 7).
- 6. Vacation of the right-of-way would have no adverse effect on the provision of access and fire and emergency services to the abutting subject property and surrounding area.
- 7. The easements necessary to be retained for the construction, repair and maintenance of public utilities and services have been duly recorded, with the exception of one, for Comcast cable communications. Comcast has obtained an easement pre-authorization from the Applicants.

## NOTICE OF RIGHT TO APPEAL AND ADDITIONAL ACTION REQUIRED

In order to appeal the recommendation of the Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$250.00 (check payable to King County Office of Finance) on or before **June 8, 2007**. If a notice of appeal is filed, the original and six (6) copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before **June 15, 2007**.

Filing requires actual delivery to the Office of the Clerk of the Council, Room 1025, King County Courthouse, 516 3<sup>rd</sup> Avenue, Seattle, Washington 98104, prior to the close of business (4:30 p.m.) on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. The Examiner does not have authority to extend the time period unless the Office of the Clerk is not open on the specified closing date, in which event delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 days calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance which implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting, the Council may adopt the Examiner's recommendation, may defer action, may refer the matter to a Council committee, or may remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council on a recommendation of the Examiner shall be final and conclusive unless within twenty-one (21) days from the date of the action an aggrieved party or person applies for a writ of certiorari from the Superior Court in and for the County of King, State of Washington, for the purpose of review of the action taken.

## NOTICE OF RIGHT TO APPEAL AND ADDITIONAL ACTION REQUIRED

In order to appeal the recommendation of the Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$250.00 (check payable to King County Office of Finance) on or before **June 8**, **2007**. If a notice of appeal is filed, the original and six (6) copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before **June 15**, **2007**.

Filing requires actual delivery to the Office of the Clerk of the Council, Room 1025, King County Courthouse, 516 3<sup>rd</sup> Avenue, Seattle, Washington 98104, prior to the close of business (4:30 p.m.) on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. The Examiner does not have authority to extend the time period unless the Office of the Clerk is not open on the specified closing date, in which event delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 days calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance which implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting, the Council may adopt the Examiner's recommendation, may defer action, may refer the matter to a Council committee, or may remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council on a recommendation of the Examiner shall be final and conclusive unless within twenty-one (21) days from the date of the action an aggrieved party or person applies for a writ of certiorari from the Superior Court in and for the County of King, State of Washington, for the purpose of review of the action taken.
