1 AN ORDINANCE establishing August 19, 2008, as the
2 date of a special election on the question of annexation to
3 fire district 50 of the town of Skykomish; and declaring an
4 emergency.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 SECTION 1. Findings:

8 A. Fire district 50, by Resolution No. 08-01, has determined that it is in the best
9 interests of the district and the public to include the town of Skykomish, in accordance
10 with chapter 52.04 RCW.

11 B. The town of Skykomish, by Ordinance No. 387, showed its intent to join fire
12 district 50 and found that the public interest would be served thereby.

13 C. The King County boundary review board received a request for review under
14 chapter 36.93 RCW, and on May 10, 2008, the review board, in file 2276, deemed the
15 proposed annexation approved.

16 E. Pursuant to chapters 29A.04 and 52.04 RCW, the metropolitan King County
17 council deems an emergency exists for the purpose of calling a special election to be held
18 on the question of this annexation on August 19, 2008.

19 SECTION 2. A special election shall be held on the 19th day of August 2008 in
20 accordance with chapter 35A.14 RCW within the territory of fire district 50 and the town
21 of Skykomish, for the purpose of submitting the question of annexation of the town of
22 Skykomish into fire district 50.

23 SECTION 3. The number of residents within the town of Skykomish is estimated
24 at two hundred ten as nearly as may be determined from available records. The number
25 of residents in the territory of fire district 50 is estimated at one thousand and two
26 hundred as nearly as may be determined from available records.

27 SECTION 4. Pursuant to RCW 29A.04.321 and 52.04.071, it is hereby deemed
28 that an emergency exists for purposes of calling a special election. The King County
29 director of the elections division is hereby requested to assume jurisdiction to call and
30 conduct a special election and submit to the registered voters within the town of
31 Skykomish and the territory of fire district 50 of the proposition as set forth in section 4
32 of this ordinance. The clerk of the council is hereby authorized and directed to transmit
33 the proposition to the director of the elections division in substantially the following
34 form, with such additions, deletions or modifications in the ballot title as may be required
35 for the propositions listed below by the King County prosecutor:

36 PROPOSITION 1: Fire District 50 passed Resolution No. 08-01 and the town of
37 Skykomish passed Resolution No. 387 both concerning annexation of the town of

38 Skykomish into Fire District 50. Shall the town of Skykomish be annexed to and be a
39 part of fire protection district 50?

42 SECTION 5. The director of the elections division is hereby authorized and
43 requested to prepare and distribute a local voters' pamphlet, pursuant to K.C.C. 1.10.010,
44 for the special election called for in this ordinance, the cost of the pamphlet to be
45 included as part of the cost of the special election.

46 SECTION 6. A. The boundaries of the territory proposed for annexation are
47 hereby described in Attachment A to this ordinance.

48 B. The boundaries of fire district 50 are hereby described in Attachment B to this
49 ordinance.

50 SECTION 7. The council finds as a fact and declares that an emergency exists

51 and that this ordinance is necessary for the immediate preservation of public peace, health
52 or safety or for the support of county government and its existing public institutions.

**LEGAL DESCRIPTION FOR THE BOUNDARIES OF THE
TOWN OF SKYKOMISH, WASHINGTON**

THAT PORTION OF THE SOUTH HALF OF SECTION 26, TOWNSHIP 26 NORTH,
RANGE 11 EAST, W.M., IN KING COUNTY, WASHINGTON, DESCRIBED AS
FOLLOWS:

COMMENCING AT THE EXISTING CONCRETE MONUMENT, ON CENTERLINE
STATION 884+39.9 P.C. SHOWN ON DRAWING SHEET 3 OF 8 SHEETS OF
CONTRACT DRAWINGS FOR STATE ROAD NO. 2, STEVENS PASS AUTO
CAMP TO MONEY CREEK PARK;

THENCE SOUTHWESTERLY ALONG SAID CENTERLINE AND ALONG A
CURVE TO THE RIGHT HAVING A RADIUS 1910.00 FEET, THROUGH A
CENTRAL ANGLE OF $1^{\circ}47'39''$, AN ARC DISTANCE OF 59.81 FEET;

THENCE SOUTH $28^{\circ}35'21''$ EAST ALONG A RADIAL LINE TO SAID CURVE
50.00 FEET TO THE SOUTH RIGHT-OF-WAY MARGIN OF SAID SR 2, ALSO
KNOWN AS STATE ROAD NO. 15 NORTHEAST STEVENS PASS HIGHWAY, AS
CONVEYED TO THE STATE OF WASHINGTON BY DEED RECORDED UNDER
RECORDING NUMBER 2920989, RECORDS OF KING COUNTY, WASHINGTON
AND BEING A POINT ON THE EAST LINE OF A TRACT OF LAND CONVEYED
TO J.G. HENRY AND E.R. DUBUQUE UNDER RECORDING NUMBER 4076078,
RECORDS OF KING COUNTY, WASHINGTON, AND THE TRUE POINT OF
BEGINNING;

THENCE SOUTH $1^{\circ}52'48''$ EAST ALONG THE EAST LINE OF SAID TRACT, A
DISTANCE OF 39.53 FEET TO A POINT ON THE NORTH LINE OF A TRACT OF
LAND CONVEYED TO JOHN G. HENRY AND E.R. DUBUQUE UNDER
RECORDING NUMBER 3661377;

THENCE NORTH $71^{\circ}48'40''$ EAST ALONG THE NORTH LINE OF SAID TRACT A
DISTANCE OF 26.05 FEET TO THE NORTHEAST CORNER THEREOF WHICH
POINT IS 3,451.40 FEET SOUTH AND 1,640.20 FEET WEST OF THE NORTHEAST
CORNER OF SAID SECTION 26 AND WHICH POINT IS ALSO THE NORTHEAST
CORNER OF A TRACT DESCRIBED AS PARCEL "A" IN THE INSTRUMENT
RECORDED UNDER RECORDING NUMBER 7701140274;

THENCE SOUTH $1^{\circ}52'48''$ EAST ALONG THE EAST LINE OF SAID PARCEL "A"
AND THE SOUTH EXTENSION THEREOF TO THE SOUTH BANK OF THE
SOUTH FORK SKYKOMISH RIVER;

THENCE EAST ALONG SAID SOUTH BANK TO THE EAST LINE OF THE
SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 26;

THENCE SOUTHERLY ALONG SAID EAST LINE TO THE SOUTH LINE OF SAID SECTION 26;

THENCE WESTERLY ALONG SAID SOUTH LINE TO THE SOUTHWEST CORNER OF SAID SECTION 26;

THENCE NORTHERLY ALONG THE WEST LINE OF SAID SECTION TO THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION;

THENCE EASTERLY ALONG THE NORTH LINE OF SAID SOUTHWEST QUARTER TO THE NORTHEAST CORNER THEREOF;

THENCE SOUTHERLY ALONG THE EAST LINE OF SAID SOUTHWEST QUARTER TO THE SOUTH MARGIN OF STATE HIGHWAY NO. 2;

THENCE EASTERLY ALONG SAID SOUTH MARGIN TO THE TRUE POINT OF BEGINNING.

NOTE: THIS LEGAL DESCRIPTION ALSO INCLUDES THAT PORTION OF UNINCORPORATED KING COUNTY IN GOVERNMENT LOT 2 LYING SOUTHERLY OF THE SOUTH RIGHT OF WAY MARGIN OF SR2 ALSO KNOWN AS NORTHEAST STEVENS PASS HIGHWAY, AND LYING WEST OF THE EAST LINE OF THE WEST 990.7 FEET. THIS AREA WHICH WAS INTENDED TO BE ANNEXED IN 1980 AS KNOWN AS THE FLASK AREA WHICH IS DESCRIBED AS FOLLOWS:

THAT PORTION OF UNINCORPORATED KING COUNTY LYING WITHIN THE PLAT OF SKY RIVER ESTATES AS RECORDED IN VOLUME 109 OF PLATS, PAGE 94, RECORDS OF KING COUNTY, WASHINGTON.

ALSO, THE EAST BOUNDARY LINE OF THE TOWN OF SKYKOMISH SITUATED IN THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER BISECTS LOTS 8 AND 9, MALONEY'S FIFTH ADDITION, ACCORDING TO VOLUME 33 OF PLATS, PAGE 42, RECORDS OF KING COUNTY, WASHINGTON.

That the name and number of said district shall be King County Fire Protection District No. 50, the boundaries of which shall be as follows:

Beginning at the northwest corner section 3, T. 26 N., R. 10 E., W.M., thence southerly along the west section lines of sections 3, 10, 15, 22, 27, 34 to the southwest corner of section 34, T. 26 N., R. 10 E., W.M., thence east along the township line between Townships 25 N. and 26 N. to the King-Chelan County line, thence north along the King-Chelan County line to the King-Snohomish County line, thence west along the King-Snohomish County line to point of Beginning, EXCEPT that area within the corporate limits of the Town of Skykomish.
