1 AN ORDINANCE relating to the annexation of  
2 approximately 35.6 acres of land into fire district 10,  
3 known as Blakely Woods Area Annexation, for the purpose  
4 of providing fire suppression and emergency medical  
5 services.

7 **STATEMENT OF FACTS:**

- 8 1. A notice of intention proposing the annexation of approximately 35.6  
9 acres of land into fire district 10, known as Blakely Woods Area  
10 Annexation, for the purpose of providing fire suppression and emergency  
11 medical services was filed with the county council on June 19, 2008.
- 12 2. Fire district 10 found the petition for transfer to be sufficient and  
13 concurred with the proposed transfer in Resolution No. 08-01, adopted on  
14 April 9, 2008.
- 15 3. Fire district 10 made a determination of nonsignificance on the  
16 proposed annexation in Resolution 08-01, adopted on April 9, 2008.
- 17 4. The Washington state Boundary Review Board has completed the

18 required evaluation of the proposed annexation and found the proposed  
19 annexation to meet the necessary requirements.

20 5. The county council received a letter, dated September 19, 2008, stating  
21 that fire district 10 has no preexisting financial obligations or indebtedness  
22 for which the property owners of the annexation area would be obligated  
23 to assume.

24 6. The county council held the legally required public hearing and has  
25 considered all the criteria in RCW 52.04.041.

26 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

27 SECTION 1. The annexation of approximately 35.6 acres of land into fire district  
28 10, for the purpose of providing fire suppression and emergency medical services  
29 described in Attachment A to this ordinance is approved. Approval of this proposed  
30 annexation is consistent with chapter 52.04 RCW.

31 SECTION 2. Fire district 10 is the appropriate entity to serve the area proposed  
32 to be annexed.

33 SECTION 3. The property owners of the annexation area are not obligated to  
34 assume responsibility for any preexisting finances or indebtedness of the district.


35 SECTION 4. Completion of this annexation does not constitute county approval


