1 AN ORDINANCE specifying the load limits on county
2 bridges; specifying load limits on 15 Mile Creek Bridge
3 1384-B; specifying load limits on Lake Dorothy Overflow
4 Bridge 359-D; adding new sections to K.C.C. chapter 14.16
5 and repealing Ordinance 11925, Section 2, and K.C.C.
6 14.16.087, Ordinance 11095, Section 17, and K.C.C.
7 14.16.105, Ordinance 5701, Section 16, as amended, and
8 K.C.C. 14.16.150 and Ordinance 15449, Section 2, and
9 K.C.C. 14.16.153.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 14.16 a
12 new section to read as follows:

13 The use of 15 Mile Creek Bridge, Bridge 1384-B, shall be limited to one truck at
14 a time, be prohibited to loads in excess of seventeen tons for three axle vehicles, be
15 prohibited to loads in excess of thirty tons for five axle vehicles, and be prohibited to
16 loads in excess of thirty-two tons for six axle vehicles until further notice.

17 NEW SECTION. SECTION 2. There is hereby added to K.C.C. chapter 14.16 a
18 new section to read as follows:

19 The use of Lake Dorothy Overflow Bridge, Bridge 359-D, shall be limited to one
20 truck at a time, and be prohibited to loads in excess of nineteen tons until further notice.

21 SECTION 3. Ordinance 11925, Section 2, and K.C.C. 14.16.087 are each hereby
22 repealed.

23 SECTION 4. Ordinance 11095, Section 17, and K.C.C. 14.16.105 are each
24 hereby repealed.

25 SECTION 5. Ordinance 5701, Section 16, as amended, and K.C.C. 14.16.150 are
26 each hereby repealed.



29 repealed.




