1 AN ORDINANCE relating to the annexation of
2 approximately 187 acres of land into the Sammamish
3 Plateau water and sewer district, known as the Overdale
4 Annexation, for the purpose of water and sewer service.

5 STATEMENT OF FACTS:

- 6 1. A notice of intention proposing the annexation of approximately 187
7 acres of land into the Sammamish Plateau water and sewer district, known
8 as Overdale Annexation, for the purpose of providing water and sewer
9 service was filed with the county council on January 27, 2011.
- 10 2. Sammamish Plateau water and sewer district has found the petition for
11 transfer to be sufficient and has concurred with the proposed transfer in
12 Resolution No. 3977, passed on December 6, 2010.
- 13 3. The Sammamish Plateau water and sewer district filed a determination
14 of nonsignificance on the proposed annexation dated September 22, 2010.
- 15 4. The utilities technical review committee recommended county council
16 approval of the proposed annexation.
- 17 5. The county council held the legally required public hearing and has
18 considered the criteria in RCW 57.02.040.

19 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

20 SECTION 1. The annexation of approximately 187 acres of land into the
21 Sammamish Plateau water and sewer district for the purpose of providing water and
22 sewer service described in Attachment A to this ordinance is approved. Approval of this
23 proposed annexation is consistent with RCW 57.02.040.

24 SECTION 2. The Sammamish Plateau water and sewer district is the appropriate
25 entity to serve the area proposed to be annexed.

26 SECTION 3. Completion of this annexation does not constitute county approval





OF THE
OVERDALE ANNEXATION AREA
PROPOSED FOR ANNEXATION TO THE
SAMMAMISH PLATEAU WATER AND SEWER DISTRICT

The South half of the Northwest Quarter of Section 22, Township 24 North, Range 6 East, W.M., King County, Washington;

Together with the North half of the Southwest Quarter of Section 22, Township 24 North, Range 6 East, W.M., King County, Washington;

Together with that portion of the Southeast Quarter of Section 22, Township 24 North Range 6 East, W.M., King County, Washington lying west of the westerly margin of Vaughn Hill Road and south of the southerly margin of Southeast 58th Street (extended);

Together with the Southeast Quarter of the Northeast Quarter of Section 21, Township 24 North, Range 6 East, W.M., King County, Washington;

TOGETHER WITH the East 574.5 feet of the North Half of the Northeast Quarter of the Southeast Quarter of Section 21, Township 24 North, Range 6 East, W.M., King County, Washington.
