1	AN ORDINANCE renaming the Maple Ridge Highlands
2	Open Space to reflect two distinct areas with historical
·3	community identity: Danville-Georgetown Open Space and

5	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
6	SECTION 1. Findings:
7	A. King County obtained the Maple Ridge Highlands Open Space as a condition
8	of the Polygon Four-to-One development proposal, which was approved in 1997 as an
9	amendment to the King County Comprehensive Plan. The Four-to-One program required
10	the Polygon project to dedicate to King County four acres of open space land for every
11	one acre of land given urban development potential along the county's urban growth
12	boundary.
13	B. The Polygon Four-to-One Open Space was dedicated to the county in phases
14	from 2000 to 2005 upon recording of the plats of the Maple Ridge Highlands
15	development. The open space area is presently named for that development.
16	C. The Danville-Georgetown Open Space is named for the Danville Mine, one of
17	the first coal mines in the area, and for the area's former town of Georgetown. It also
18	encompasses the Rock Creek Natural Area and Landsburg Reach. Henry's Ridge Open

19	Space is named for an area featuring entertainment establishments such as dance halls
20	and boat rentals, which was an attraction for miners from surrounding towns.
21	D. Public response to an on-line questionnaire on the King County parks and
22	recreation division website about renaming this open space was overwhelmingly in favor

- E. The county council is authorized to designate the name of any park or open space established by the county under RCW 36.32.430.
- F. The sole purpose of this ordinance is to rename this site as authorized under RCW 36.32.430 and in furtherance of agency organization, reorganization, internal operational planning or coordination of plans or functions as contemplated under WAC 197-11-800(14)(h).



# Historical Background for the Danville-Georgetown and Rock Creek Natural Areas, and Henry's Ridge

Maple Valley's early history is tied to coal mining; however, there are relatively few remaining intact historic sites (be it mines, buildings, etc.) associated with this important industry. Therefore, naming open space areas in honor of the people who shaped this place, as well as the places themselves, keeps this history alive.

The proposal to name the area north of Kent-Kangley Road the Danville-Georgetown Open Space is appropriate because it commemorates the Danville Mine, formally located to the east of the open space, and the community of Georgetown, which was located to the southeast. The area previously known as Georgetown was once owned by the Northwest Improvement Company, a subsidiary of the Northern Pacific Railroad and today is part of the community of Ravensdale. The Rock Creek Natural Area could also appropriately be called Danville-Georgetown as it was all part of the same historical landscape.

The railroads which were brought in to move coal were instrumental in shaping initial development of Maple Valley. Early 20<sup>th</sup> century Kroll maps note the location of "Henry's Switch" where the tracks of the Northern Pacific Railroad and the Columbia and Puget Sound Railroad crossed. This switch was just off the southwest corner of the open space area proposed to be named Henry's Ridge Open Space, thus also a site that was important in the early history of Maple Valley.
