1 AN ORDINANCE increasing the monthly rental rates for  
2 aircraft tie-downs at the King County International Airport,  
3 also known as Boeing Field International; and amending  
4 Ordinance 10500, Section 1, as amended, and K.C.C.  
5 15.52.060 and Ordinance 10500, Section 1, as amended,  
6 and K.C.C. 15.52.060.

7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. A. Section 2 of this ordinance increases aircraft parking/storage  
9 fees (tie-down fees) for the monthly rental rates for 0-12,500 weight aircraft in 2013, as  
10 provided in K.C.C 15.52.060. Section 3 of this ordinance increases aircraft  
11 parking/storage fees (tie-down fees) for the monthly rental rates for 0-12,500 weight  
12 aircraft in 2014, as provided in K.C.C. 15.52.060.

13 B. These fees are authorized by K.C.C. chapter 15.52.

14 SECTION 2. Ordinance 10500, Section 1, as amended, and K.C.C. 15.52.060 are  
15 each hereby amended to read as follows:

16 The following tie-down rates will be charged for storage of aircraft on county  
17 property (Note: Aircraft weight in pounds shall be that weight for the aircraft as  
18 published in leading aviation journals.)


