1	AN ORDINANCE approving the sale of a parcel of surplus
2	real property located in council district three.
3	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
4	SECTION 1. Findings:
5	A. The King County road services division is the custodian of certain property
6	located at 17002 148th Avenue N.E. Woodinville area commonly known as the
7	Woodinville Gravel Pit.
8	B. The road services division has determined that the Woodinville Gravel Pit is
9	surplus to its needs and the needs of the public.
10	C. Pursuant to K.C.C.4.56.070, the facilities management division has circulated
11	a surplus notice to King County agencies and none expressed interest.
12	D. The facilities management division has also determined that the property is
13	not suitable for affordable housing purposes and declared the property to be surplus.
14	E. The King County executive has negotiated a purchase and sale agreement for
15	the sale of the property to David J. and Jody A. Hannant for \$510,000.
16	F. The proposed sale is consistent with K.C.C.4.56.100 regarding sale of county
17	property. K.C.C.4.56.080 provides that King County council approval is required for the
18	sale of county-owned real property valued in excess of ten thousand dollars.

SECTION 2. The King County council, having determined that the sale of the subject property is in the best interest of the public, hereby authorizes the executive to execute a purchase and sale agreement in substantially similar form as provided in Attachment A to this ordinance and to execute any other documents necessary to convey and deliver the property to the buyer. All actions up to now taken by county officials, agent and employees consistent with the terms and purposes of the purchase and sale agreement are hereby ratified, confirmed and approved.

SECTION 3. If any provision of this ordinance is declared by any court of competent jurisdiction to be contrary to law, then such provision is null and void and

- 28 shall be deemed separable from the remaining provisions of this ordinance and in no way
- 29 affect the validity of the other provisions of this ordinance or of the sale.

RECITALS

- Seller is the owner of that certain real property located within the Woodinville area of unincorporated King County, Washington, which consists of approximately 555,563 square feet, commonly identified as Assessor's Parcel Number 112605-9051, and located at 17002 - 148th Avenue NE, the legal description of which is attached hereto as EXHIBIT A (the "Property").
- В, Seller is desirous of selling the Property and Buyer is desirous of purchasing the Property.

AGREEMENT

Now, Therefore, in consideration of the promises and mutual covenants contained herein, and other valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties hereto covenant and agree as follows:

ARTICLE 1. PURCHASE AND TRANSFER OF ASSETS

- PROPERTY TO BE SOLD. Subject to and upon the terms and conditions set forth in this Agreement, Seller shall sell, convey, assign, transfer and deliver to Buyer on the Closing Date (as defined in Article 10.2 below) and Buyer shall buy, assume and accept from Seller on the Closing Date the following assets and properties:
- all the Seller's right, title and interest in the Property, as described in EXEMBIT A; subject to Seller's retention of reservations as described in EXHIBIT B (the form of deed), including but not limited to a reservation of easement for a Recreational Trail Easement, which is provided for in Section 4.4.1 of this Agreement;

- all of Seller's right, title and interest in improvements and structures located on the Property, if any;
- all of Seller's tenements, hereditaments, easements and rights appurtenant to the Property including but not limited to, all of the Seller's right, title, and interest in and to streets, alleys or other public ways adjacent to the Property, easements for public utilities, all sewers and service drainage easements, all rights of connection to the sewers, and all rights of ingress and egress, and all leases, licenses, government approvals and permits affecting the Property.
- all of Seller's right, title and interest in and to tangible personal property, if any, owned by the Seller and attached or appurtenant to the Property ("Personal Property").

Hereinafter, the items listed in Section 1.1 are collectively referred to as the "Purchased Assets."

ARTICLE 2. **PURCHASE PRICE**

2.1. PURCHASE PRICE AND PAYMENT. In consideration of the sale, transfer, ALL CASH SALE: This sale is not contingent upon Buyer obtaining financing and vide all each at elesing.

EARNEST MONEY. Not later at is A..... conveyance, assignment and delivery of the Purchased Assets, Buyer shall, in full payment therefor, pay to Seller on the Closing Date a total purchase price of Five HUNDRY TOU THUS AND

Buyer will provide all each at clesing.

execution of this Agreement, Buyer shall deposit with Escrow Agent (defined in Section 10.1 of this Agreement) a promissory note in the form attached hereto as Exhibit C the amount of AND NO/100 DOLLARS (\$10.000), or five percent (5%) of the Purchase Price, as the initial earnest money deposit (the "Earnest Money Note"). Within two (2) business days after satisfaction of the Due Diligence Inspection and Feasibility Contingency set forth in Section 5.1 of this Agreement, the Earnest Money Note shall be replaced with cash in the same amount as the Earnest Money Note and such cash shall be deposited into escrow as the earnest money (the "Earnest Money"). Upon closing of this transaction, the Earnest Money will be applied toward the Purchase Price that is due Seller. Should Buyer default on its obligations under this Agreement, the Seller shall be entitled to retain the Earnest Money as liquidated damages.

ALLOCATION OF PURCHASE PRICE. Seller and Buyer agree that the entire Purchase Price is allocable to real property and that the value of the Personal Property, if any, is de minimus.

ARTICLE 3. REPRESENTATIONS AND WARRANTIES OF THE PARTIES

- 3.1. WARRANTIES AND REPRESENTATIONS OF SELLER. Seller represents and warrants as follows:
- 3.1.1. Definition of Seller. The Seller is a home rule charter county and political subdivision of the State of Washington duly organized, validly existing and in good standing under the laws of the State of Washington. Seller has all requisite corporate power and authority to carry on its business as it is now being conducted in the place where such businesses are now conducted.
- 3.1.2. Execution, Delivery and Performance of Agreement, Authority. The execution, delivery and performance of this Agreement by Seller (i) is within the powers of Seller as a home rule charter county and political subdivision of the State of Washington, (ii) has been or will be on or before the Closing Date, duly authorized by all necessary action of the Seller's legislative authority, and (iii) does not and will not violate any provision of any law, rule, regulation, order, writ, judgment, decree or award to which the Seller is a party or which is presently in effect and applicable to Seller. This Agreement constitutes the legal, valid and binding obligation of Seller enforceable against Seller in accordance with the terms thereof.
- 3.1.3. Litigation. To the best of Seller's knowledge, there is no pending or threatened lawsuit or material claim against or relating to Seller with respect to the Property, which shall impede or materially affect Seller's ability to perform the terms of this Agreement. To the best of Seller's knowledge, there is no pending or contemplated condemnation or similar proceeding with respect to the Property or any part thereof.
- 3.1.4. Assessments. To the best of Seller's knowledge, there is no contemplated local improvement district or other special assessment or charge with respect to the Property, except as may be disclosed in the Title Commitment described below.
- 3.1.5. Full Disclosure. To the best of Seller's knowledge, no representation or warranty by Seller in this Agreement or in any instrument, certificate or statement furnished to Buyer pursuant hereto, or in connection with the transactions contemplated hereby, contains or will contain any untrue statement of a material fact or fails to state a material fact which is necessary to make the statements set forth therein not false or misleading.
- 3.1.6. Broker. Seller agrees to pay <u>CYONY WEUS</u>, the selling broker in this Agreement, three percent (3%) of the Purchase Price as a selling firm commission, upon Closing (as defined in Article 10 below).
- 3.1.7. Contracts. There are no contracts or other obligations outstanding for the sale, exchange, transfer, lease, rental or use of the Property or any portion thereof.

- Future Agreements. From and after the date hereof unless this Agreement is terminated in accordance with its terms, Seller shall not without the prior written consent of Buyer:
- enter into any agreement, contract, commitment, lease or other transaction that affects the Property in any way; or
 - sell, dispose of or encumber any portion of the Property; (ii)
- 3.1.9. Maintenance of the Property. Seller shall continue to maintain the Property in compliance with all applicable laws and pay all costs of the Property with respect to the period prior to Closing.

3.1.10 Condition of the Property.

- Seller has not made, does not make, and specifically negates and disclaims any representations, warranties, promises, covenants, contracts or guarantees of any kind or character whatsoever, whether express or implied, oral or written, past, present or future, of, as to, concerning, or with respect to the value, nature, quality, or condition of the Property, including, without limitation:
 - The water, soil and geology; (i)
 - The income to be derived from the Property; (ii)
- The suitability of the Property for any and all activities and uses that Buyer (iii) or anyone else may conduct thereon;
- The compliance of or by the Property or its operation with any laws, rules, (iv) . ordinances or regulations of any applicable governmental authority or body;
- The habitability, merchantability, marketability, profitability or fitness for (v) a particular purpose of the Property;
- The manner or quality of the construction or materials, if any, incorporated (vi) into the Property; or
 - (vii) Any other matter with respect to the Property.
- Seller has not made, does not make, and specifically disclaims any representations regarding compliance with any environmental protection, pollution, zoning or land use laws, rules, regulations, orders, or requirements, including the existence in or on the Property of hazardous materials or substances.
- Without limitation, Seller does not make and specifically disclaims any warranties, express or implied, any warranties or representations with respect to the structural condition of the Purchased Assets, the area of land being purchased, the existence or nonexistence of any Hazardous Substances or underground storage tanks, or the actual or threatened release, deposit, seepage, migration or escape of Hazardous Substances, from or into the Purchased Assets, and the compliance or noncompliance of the Purchased Assets with applicable federal, state, county and local laws and regulations, including, without limitation, environmental laws and regulations and seismic/building codes, laws and regulations. For purposes of this Agreement, the term "Hazardous Substances" shall mean: "hazardous substance" as defined in the Comprehensive Environmental Response, Compensation and

Liability Act of 1980, as amended ("CERCLA"); "hazardous waste" as defined by the Resource Conservation and Recovery Act of 1976 ("RCRA") as amended; hazardous wastes, hazardous materials, hazardous substances, toxic waste, toxic materials, or toxic substances as defined in state or federal statutes or regulations; asbestos-containing materials, polychlorinated biphenyls; radioactive materials, chemicals known to cause cancer or reproductive toxicity; petroleum products, distillates or fractions; any substance the presence of which is prohibited by statute or regulation; and any substance for which any statute or regulation requires a permit or special handling in its use, collection, storage, treatment or disposal.

- All provisions of this Section 3.1.10 shall survive Closing and the expiration or earlier termination of this Agreement.
- 3.1.11. Risk of Loss. Until the Closing Date, the risk of loss relating to the Property shall rest with the Seller, Risk of Loss shall be deemed to include any property damage occurring as a result of an "Act of God," including, but not limited to, earthquakes, tremors, wind, rain or other natural occurrence.
- 3.1.12. Foreign Person. Seller is not a foreign person and is a "United States Person" as such term is defined in Section 7701 (a) (30) of the Internal Revenue Code of 1986, as amended and shall deliver to Purchaser prior to the Closing Date an affidavit, as set forth in EXHIBIT D, evidencing such fact, and such other documents as may be required under the Code.
- 3.1.13. Seller's Knowledge. Any and all representations or warranties based on Seller's knowledge are made to and limited by the present, actual knowledge of Robert Thompson, who is an employee of King County, within the Real Estate Services Section, and who has made no inquiries or investigations with respect to Seller's representations and warranties prior to the making thereof and has no duty to undertake the same.
- Representations and Warranties of Buyer. BUYER REPRESENTS AND **WARRANTS AS FOLLOWS:**

3.2.1. Organization. Buyer is a limited liability corporation, duly organized, validly existing and in good standing under the laws of the State of Washington. Buyer has all requisite corporate power and authority to carry on its business as it is now being conducted in the place where such businesses are now conducted. Buyer aeknowledges that the person signing this Agreement has authority to execute real estate purchase and sale contrasts on behalf of the Buyer and will submit to Seller its articles of incorporation, certificate of formation, or other. appropriate documentation demonstrating such authority.

3.2.2. Execution, Delivery and Performance of Agreement, Authority. The secution, delivery and performance of this Agreement by Buyer (i) is within the powers of Buyer as a corporation, (ii) has been duly authorized by all necessary corporate action of the Buyer, and (iii) does not and will not violate any provision of any law, rule, regulation, order, writ, judgment, decree, award or contract to which the Buyer is a party or which is presently in effect and applicable to Buyer. This Agreement constitutes the legal, valid and binding obligation of Buyer enforceable against Buyer in accordance with the terms hereof.

- 3.2.3. Litigation. There is no pending or, to the best of Buyer's knowledge, threatened lawsuit or material claim against or relating to Buyer that shall impede or materially affect Buyer's ability to perform the terms of this Agreement.
- 3.2.4. Full Disclosure. No representation or warranty by Buyer in this Agreement or in any instrument, document, certificate or statement furnished to Seller pursuant hereto, or in connection with the transactions contemplated hereby, contains or will contain any untrue statement of a material fact.
- 3.2.5. Condition of Property. Buyer acknowledges that, within the Due Diligence Period (as defined in Article 5.1 below), it will have conducted a physical inspection and made all investigations Buyer deems necessary in connection with its purchase of the Purchased Assets. Upon waiver or satisfaction by Buyer of its contingencies pursuant to Article 5, Buyer will be deemed to have approved the physical condition of the Property and agrees to accept and purchase the same "AS IS, WHERE IS", including, without limitation, the existence or non-existence of any pollutants, contaminants, hazardous waste, dangerous waste, toxic waste, underground storage tanks or contaminated soil, or the actual or threatened release, deposit seepage, migration or escape of such substances at, from or into the Property and the compliance or noncompliance of the Property with applicable federal, state, county and local laws and regulations including, without limitation, environmental laws and regulations.

Buyer acknowledges and agrees that, except to the extent of Seller's representations and warranties in Section 3.1 of this Agreement, and to the extent of any fraud or deliberate misrepresentation by Seller. Seller shall have no liability for, and that Buyer shall have no recourse against the Seller for, any defect or deficiency of any kind whatsoever in the Property including without limitation those relating to Hazardous Substances, without regard to whether such defect or deficiency was discovered or discoverable by the Buyer or Seller.

- 3.2.6. Waiver of Disclosure Statement. Buyer hereby expressly waives receipt of a Seller Disclosure Statement.
- 3.2.7. Indemnification. Buyer shall indemnify, defend and hold Seller, its officers, agents and employees harmless from and against any and all claims and agency orders or requirements relating to or arising out of, directly or indirectly, the Property after Closing.
- 3.2.8. Broker. Buyer agrees to pay a commission in accordance with any listing or commission agreement to which Buyer is a party.

ARTICLE 4. TITLE MATTERS

- 4.1. TITLE. Seller shall deliver to Buyer good and marketable title, free and clear of all liens, defects and encumbrances except the Permitted Exceptions.
- 4.2. Title Commitment. Buyer shall obtain a current owner's standard policy of title insurance (the "Title Commitment") Issued by First American Title Insurance Company, located at 818 Stewart Street, Suite 800, Seattle, WA 98101, (206) 728-0400 (the "Title Company"), describing the Property, listing Buyer as the prospective named insured and showing as the policy amount the total Purchase Price for the Property. At such time as the Title Company causes the Title Commitment to be furnished to Buyer, the Title Company shall further cause to be furnished to Buyer legible copies of all instruments referred to in the Title Commitment as restrictions or exceptions to title to the Property.
- 4.2.1. Survey. Buyer shall have the option, at its expense, to have prepared and furnished to the Title Company and Buyer a survey (the "Survey") of the Property prepared by a licensed public surveyor. The Survey shall be certified to Buyer and the Title Company, shall be satisfactory to the Title Company so as to permit it to issue an owner's extended coverage title policy, identify the Property by legal description and shall set forth the number of square feet contained within the Property, show all natural monuments, existing fences, drainage ditches and/or courses, flood plain limits, any building or other site improvements and/or objects, any rights-of-way for streets, existing driveways, alleys or highways, easements and other restriction lines existing and/or proposed which shall affect any portion of the Property, and such other items as required by Buyer.
- - 4.3. OWNER'S TITLE INSURANCE POLICY. At the Closing, Buyer shall cause a standard owner's policy of title insurance to be issued by the Title Company in the full amount of the Purchase Price, effective as of the Closing Date, insuring Buyer that the fee simple title to the Property is vested in Buyer, subject only to the usual printed exceptions contained in such title insurance policy, to the matters approved by Buyer as provided herein, and to any other matters.

approved in writing by Buyer. The obligation of Buyer to provide the title policy called for herein shall be satisfied if, at the Closing, the Title Company has given a binding commitment, in a form reasonably satisfactory to Buyer, to issue the policies in the form required by this section. Buyer shall pay any sum owing to the Title Company for the preparation of the preliminary and binding commitments generated by the Title Company.

- 4.4. CONVEYANCE. Seller shall convey to Buyer the title to the Property by deed, in substantially the form attached hereto as EXHIBIT B, subject only to the Permitted Exceptions and reservations of Seller that may be defined in EXHIBIT B. Rights reserved in federal patents or state deeds, building or use restrictions general to the district, and building or zoning regulations or provisions shall be deemed Permitted Exceptions.
- 4.4.1. Reservation of Easements. The conveyance deed described in Section 4.4 above shall include the reservation by Seller of a <u>permanent and exclusive</u> Recreational Trail Easement, which is described as follows:

RESERVING UNTO GRANTOR KING COUNTY, its heirs, successors and assigns, a permanent and exclusive *Recreational Trail Easement*, together with unobstructed access to and egress from, over, across, along, in under, upon and through the above-described Property, for a portion of the Property hereinafter referred to as the *Trail Easement*, or *Easement Area*, legally-described as follows:

Legal Description Provided in Exhibit B, Statutory Warranty Deed

King County reserves unto itself in perpetuity the right to enter upon at all times and use, and allow the general public to enter upon and use, the Easement Area as a recreational equestrian and pedestrian trail. King County further reserves unto itself in perpetuity the right to, including but not limited to, construct, reconstruct, own, install, inspect, repair, replace, renovate, enhance and manage the trail and trail improvements, including but not limited to grading, surfacing, fencing, lighting, landscaping, posting signage, and preserving and maintaining the recreational trail through the Easement Area, and also the right to plant, cut, prune, remove and dispose of any and all trees, plants, brush or vegetation in the Easement Area, and to control, on a continuing basis and by any prudent and reasonable means, the establishment and growth of trees, plants, brush or other vegetation in the Easement Area. This exclusive Trail Easement includes the right to use motorized vehicles and equipment as may be deemed necessary and appropriate by the Grantor in connection with any of the foregoing activities. This exclusive Trail Easement further includes the right to keep the Easement Area free of obstructions, encroachments and any interference with Grantor's use.

King County further reserves unto itself in perpetuity the right to install, construct, own, use, operate, maintain, inspect, repair, replace, renovate, improve, remove, manage, and enhance underground utilities, including, but not limited to, the rights of ingress and egress across the surface of the Property to access the Easement Area from the surface; the right to install, construct, operate, maintain, modify, repair, replace, improve, remove and use utilities, including utility pipelines, conduits, wires or other facilities and equipment within said Easement Area, including the addition, removal, or replacement of same, either in whole or in part with either

like or different size utilities; and the right to do the same with such additional pipelines, conduits, wires, or other facilities and equipment as may now or hereafter be installed in the Easement Area.

Further, King County may grant sub-easements, issue licenses and/or permits, and assign, apportion, or otherwise transfer its easement rights in whole or in part to third parties without notice to or the written consent of Grantee, its heirs, successors, or assigns.

No minimum frequency, volume or duration of use will be necessary to retain the viability and existence of the Trail Easement. The Trail Easement is intended to be permanent and to remain on the Property in perpetuity and shall not be deemed to have been relinquished, canceled, rescinded, abandoned, or otherwise terminated except through duly authorized written notice to the Grantee from Grantor King County.

Nothing in this Trail Easement will be considered to diminish King County's governmental or police powers.

The benefits, burdens, covenants, terms, conditions, and restrictions of the Trail Easement shall be binding upon, and inure to the benefit of, Grantor King County and its heirs, successors, and assigns, shall continue as a servitude and easement running in perpetuity with the Property, and shall be included in any future deed conveying the Property.

ARTICLE 4. CONTINGENCIES

- 5.1.1. Inspections. During the Due Diligence Period, Buyer, its designated representatives or agents shall have the right at Buyer's expense to (i) perform any and all tests, inspections, studies, surveys or appraisals of the Property deemed necessary, on any subject, by the Purchaser (subject to the limitations set forth below and Paragraph 5.1.2 Right of Entry); (ii) obtain a Phase I or Phase II Environmental Assessment on the Property and perform any and all tests, inspections and studies deemed necessary therewith; and (iii) examine all Due Diligence materials available to Seller that Buyer may reasonably request from Seller that are not subject to

as Buyer

attorney-client privilege or that the County is not otherwise prohibited from disclosing by law; (IV) determine to its satisfaction whether approvals, permits and variances can be obtained under applicable land use and zoning codes for Buyers proposed development of the property. (V) determine whether Purchaser's proposed development of the property is economically feasible.

5.1.2. Right of Entry. Buyer and Buyer's designated representatives or agents shall have the right and Seller hereby grants to Buyer and Buyer's designated representatives the right to enter the Property pursuant to a County permit and conduct the tests, investigations and studies set forth in this Article 5 upon three (3) days advance written notice; provided that such right of entry will be limited to those times and dates that will not disrupt Seller's use of, or Seller's operations and activities on the Property. The Buyer will not be permitted to undertake activities that damage County property. Invasive tests of the Property, such as drilling or excavation shall be subject to Seller's prior written approval.
