1 AN ORDINANCE approving the Shoreline Water District
2 Water System Plan Update 2011, Revised May 2013.

3 STATEMENT OF FACTS:

4 1. King County has adopted K.C.C. chapter 13.24, which requires
5 approval of comprehensive plans for water utilities that distribute or obtain
6 water in unincorporated King County as a prerequisite for operating in
7 unincorporated King County, receiving approval for annexation proposals,
8 being granted right-of-way franchises, and being given approval for right-
9 of-way construction permits. K.C.C. 13.24.060 prescribes the
10 requirements for approval of such plans, including consistency with state
11 and local planning requirements.

12 2. RCW 70.116.050 requires that general comprehensive plans for water
13 within critical water supply service areas be submitted to, and approved
14 by, the legislative authority within whose boundaries all or a portion of a
15 utility lies. RCW 57.16.010 requires that general comprehensive plans for
16 water districts be submitted to, and approved by, the legislative authority
17 within whose boundaries all or a portion of the district lies.

18 3. The Shoreline water district ("the district") is in King County and has
19 adopted the Shoreline Water District Water System Plan Update 2011,
20 Revised May 2013 ("the plan").

21 4. King County has adopted a comprehensive plan that includes water
22 supply policies in its provisions for facilities and services (policies F-101
23 through F-254) that call for consistency with other adopted plans, support
24 for regional water supply planning, pursuit of reclaimed water, water
25 conservation and protection of water resources.

26 5. K.C.C. chapter 13.24 requires the utilities technical review committee
27 ("UTRC") to review and make a recommendation to the King County
28 executive and council on the plan and the requirements under K.C.C.
29 chapter 13.24 and the plan's consistency with the King County
30 Comprehensive Plan. The UTRC has reviewed the planning data and city
31 operations and has found:

32 a. The plan uses population and employment forecasts developed by the
33 Puget Sound Regional Council for the district's service area;

34 b. The district's service area is within the cities of Shoreline and Lake
35 Forest Park with no service in unincorporated King County;

36 c. The capital facility plan is adequate to meet anticipated facility and
37 service needs;

38 d. The plan is consistent with applicable Washington state water quality
39 laws, including the evaluation of reclaimed water use; and

40 e. The plan is consistent with other pertinent county adopted plans and
41 policies.

42 7. The Washington state Department of Health approval of the district's
43 plan is pending King County council action.

44 8. Under the state Environmental Policy Act the district issued a
45 determination of nonsignificance for the issuance of the plan on December
46 13, 2011, and there were no appeals.

47 9. The district's operations and facilities meet multiple existing statutory,
48 administrative and planning standards. As the district's operations,
49 facilities and planning meet the requirements of the King County Code,
50 and are consistent with the King County Comprehensive Plan, the UTRC
51 recommends approval of the plan.

52 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

53 SECTION 1. The Shoreline Water District Water System Plan Update 2011,

54 Revised May 2013, Attachment A to this ordinance, is hereby approved as a
55 comprehensive water system plan.
