1 AN ORDINANCE approving a water franchise for the
2 Edgehill Water Association, located in council district
3 three.

4 **STATEMENT OF FACTS:**

5 1. The Edgehill Water Association filed an application for a water
6 franchise to operate and maintain water pipelines and appurtenant
7 facilities in unincorporated King County for the purpose of providing
8 water service in King County.

9 2. The Edgehill Comprehensive Water System Plan was approved by the
10 King County council in accordance with a recommendation of the King
11 County utilities technical review committee.

12 3. The utilities technical review committee has approved the Edgehill's
13 franchise application as meeting the requirements of K.C.C. 6.27.060 and
14 13.24.010.

15 4. The council has scheduled, noticed and conducted a public hearing
16 regarding the Edgehill's application for a right-of-way franchise on the
17 28th day of July, 2014, as required by RCW 36.55.040 and K.C.C.
18 6.27.050.

19 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

20 SECTION 1. The metropolitan King County council, having determined that the
21 Edgehill Water Association application meets the criteria for the granting of a water
22 franchise and that the grant is in the best interests of the public, does hereby approve the
23 attached franchise agreement, which is Attachment A to this ordinance, and authorizes
24 the King County executive to execute the agreement.

25 If within forty-five days after the granting of the franchise, the applicant fails to
26 sign the written acceptance incorporated in this ordinance, then the rights and privileges
27 granted in this ordinance shall be forfeited and the franchise shall be null and void.


28 If the franchise is accepted by the applicant as provided herein and comes into
29 force and effect, then this franchise shall replace the association's previous water

30 franchise, specifically No. 6145, and such earlier franchise shall be thereafter null and
31 void.
