1 AN ORDINANCE providing a supplemental appropriation
2 of \$604,000 to the building repair and replacement fund
3 and amending the 2014 Annual Budget Ordinance,
4 Ordinance 17695, Section 63, as amended, and Attachment
5 B as amended.

6 PREAMBLE:

7 Built in 1908 as the new City Hall, the Yesler Building is an historic
8 landmark owned by King County government. Over the years the county
9 has used the building to house various programs and agencies. The recent
10 consolidation of the public defense agencies into the King County
11 department of public defense has created a need for contiguous space to
12 accommodate the new county employees. Predevelopment work will
13 determine the feasibility of the adaptive reuse of the Yesler Building as a
14 cost-efficient, long-term solution for collocating this vital public service.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Ordinance 17695, Section 63, as amended, is hereby amended by
17 adding thereto and inserting the following:

18 From the building repair and replacement fund there is hereby appropriated and
19 authorized to be disbursed the following amounts for the specific project identified in this
20 Attachment A to this ordinance.
