### Ordinance 17924

Proposed No. 2014-0403.2

1 AN ORDINANCE relating to the county property tax  
2 levies for collection in 2015, and implementing RCW  
3 84.55.120.

4 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

5 SECTION 1. The council is under an obligation by charter to enact revenue  
6 measures that support the budget appropriation ordinance by December 1, 2014, for the  
7 2015 budget. This ordinance sets the amount of property tax to be collected for the  
8 regular property tax levy, the road district levy, the conservation futures levy and the  
9 emergency medical services levy. In accordance with RCW 84.55.120, the council has  
10 given proper notice of this ordinance to the public.

11 SECTION 2. For collection of the property tax levies in 2015, the council hereby  
12 authorizes property tax changes compared to the amounts authorized for collection in  
13 2014 as follows:

14 Levy	Estimated	% Increase	Estimated Total Levy
15 Regular	\$2,673,548	0.59%	\$462,453,243
16 Regular - Transit	\$353,470	1.39%	\$26,217,172
17 Road District	\$9,342,288	13.03%	\$81,063,326
18 Conservation Futures	\$97,103	0.54%	\$18,364,254
19 Emergency Medical Services	\$1,135,410	1.00%	\$116,608,875

20 The changes shown above are exclusive of any amounts resulting from new construction  
21 valued in 2014, any increases in value of state-assessed property for 2015 and any  
22 amounts necessary to fund tax refunds paid in 2014.


23 SECTION 3. Upon enactment, the clerk is directed to forward this ordinance to  
24 the assessor in accordance with RCW 84.52.070.
