1           AN ORDINANCE authorizing the King County executive  
2           to execute an amendment to the interlocal agreement with  
3           the King County flood control zone district extending the  
4           duration of the interlocal agreement through March 31,  
5           2015.

6           STATEMENT OF FACTS:

7           1. King County and the King County Flood Control Zone District have  
8           entered into the Interlocal Agreement Between King County and the King  
9           County Flood Control Zone District Regarding Flood Protection Services,  
10          dated February 19, 2009.

11          2. The county and the district have amended the interlocal agreement four  
12          times, with the last amendment extending the duration of the interlocal  
13          agreement through December 31, 2014.

14          3. The county and the district desire to amend the interlocal agreement to  
15          extend its term to March 31, 2015.

16          4. The fifth amendment to the interlocal agreement, Attachment A to this  
17          ordinance, amends the interlocal agreement to extend its term through  
18          March 31, 2015.

19          BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

20            SECTION 1. The county executive is hereby authorized to execute an  
 21 amendment to the Interlocal Agreement Between King County and the King County  
 22 Flood Control Zone District Regarding Flood Protection Services, dated February 19,  
 23 2009, substantially in the form of Attachment A to this ordinance. All other provisions of  
 24 the interlocal agreement as previously amended shall remain in full force and effect.
