1 AN ORDINANCE relating to extending the expiration date
2 of the Vashon-Maury Island groundwater protection
3 committee; and amending Ordinance 14214, Section 8, as
4 amended, and K.C.C. 9.14.070.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 14214, Section 8, as amended and K.C.C. 9.14.070 are
7 each hereby amended to read as follows:

8 A. The Vashon-Maury Island groundwater protection committee is hereby
9 created and shall continue in existence until December 31, ((2017)) 2022.

10 B. The committee members shall be selected from within the Vashon-Maury
11 island groundwater management plan area and shall consist of the following:

- 12 1. Three representatives who are Vashon-Maury island residents;
- 13 2. One representative from water purveyors;
- 14 3. One representative from interests representing water supply or wastewater
15 management;
- 16 4. One representative from residential exempt well owners;
- 17 5. One representative from island commercial and industrial interests;
- 18 6. One representative from commercial agriculturists;
- 19 7. One livestock owner; and

20 8. One representative from local environmental organizations.

21 C. The county shall invite each of the tribal nations with federally recognized
22 rights within the Vashon-Maury island groundwater management area to recommend
23 candidates for the committee. The committee shall include a representative from each
24 tribal nation with federally recognized rights within the Vashon-Maury island
25 groundwater management area, if the tribal nation provides to the county a candidate for
26 appointment to the committee.

27 D. Each county abutting the Vashon-Maury island groundwater management
28 plan area boundary shall be requested to provide to the county a candidate for
29 appointment to the committee on an advisory, nonvoting basis.


30 E. The Seattle-King County department of public health and the Washington
31 state departments of Ecology and Health shall be requested to provide to the county a
32 candidate for appointment to the committee on an advisory, nonvoting basis.

33 F. Each member of the committee shall coordinate internally with the entity the
34 member represents.
