SETTLEMENT AGREEMENT
BY AND BETWEEN THE
KING COUNTY DEPARTMENT OF TRANSPORTATION (Metro)
AND THE
AMALGAMATED TRANSIT UNION, LOCAL 587 (Union)

SETTLEMENT AGREEMENT

This Settlement Agreement (“Agreement”) is entered into between Amalgamated Transit Union Local 587 (“Local 587”), and King County Department of Transportation, King County, and Metro (collectively “King County”) (all collectively referred to as the “Parties”).

Recitals

A. Transit operators (“Operators”) perform transit services driving buses for King County, and are represented by Local 587. Following an investigation by the U.S. Department of Labor that resulted in wage payments under federal law to some Operators for uncompensated time during their work day, Local 587 raised similar concerns in relation to all Operators under Washington State law.

B. In the hopes of addressing these issues without engaging in litigation, the Parties entered into discussions regarding a global resolution of these issues. The Parties have conducted their own investigations of the facts and law applicable to the case.

C. The Parties have engaged in settlement negotiations in good faith and at arms-length. As a result of those discussions, the Parties reached a settlement that they believe is fair, adequate, and reasonable in light of the relevant law and facts, and that they believe is in the best interests of all Parties. This Agreement memorializes the terms of the settlement reached by the Parties at the conclusion of the negotiations. The Parties enter into this Agreement with the shared intent to resolve any and all outstanding and potential claims concerning recorded, unrecorded, off-the-clock, additional, undercompensated, or uncompensated work time and any related overtime (or the calculation thereof) arising under local, state and federal laws and the Parties’ collective bargaining agreement.

D. The Parties acknowledge that this Agreement is beneficial for all involved. In reaching this conclusion, the Parties and their counsel considered the uncertainty, risks, difficulties, and delays inherent in any litigation; the burden of proof necessary to prevail on any possible claims; and the defenses thereto.

Terms and Conditions

In light of the foregoing Recitals, the Parties hereby agree to the following terms and conditions:

1. **No Admission of Liability.** This Agreement is entered into solely for the purposes of resolving disputed claims based on contested facts and allegations, and to avoid the costs and risks of litigation to all Parties. No part of this Agreement or the decision to settle the disputed claims and to enter into this Agreement will be construed as an admission of liability or wrongdoing by King County of any kind or nature or as an admission by King County that any part of the contested facts or allegations are true, valid, or have any merit. Similarly, no part of this Agreement will be construed as an admission by Local 587 or the Operators that any of their claims are without merit.

2. **Settlement Amount.** King County agrees to pay in full and final settlement of all wage claims for Operators a gross amount equal to the total of all individual settlement payments to Operators that will be set forth in Exhibit A. This amount will be reduced for any amounts attributable to Operators who do not complete and return an individual participation and release form. King County will not be responsible for making any other payment of any kind to Local 587, the Operators, or their counsel in connection with this matter. Individual settlement payments will be distributed as follows:

a. **Individual Settlement Payments.** Subject to the terms and contingencies set forth in this Agreement, King County will provide each Operator an individual settlement payment for the gross amount listed in Exhibit A to be attached hereto. These payments will be derived using a defined amount of \$103.00 per month multiplied by the number of months employed as an Operator during the three-year period from April 1, 2015, through March 31, 2018, and decreased for net wage amounts previously received by the Operator in relation to the U.S. Department of Labor investigation. For these purposes, eligibility for each month's payment is based on an Operator's employment for fifteen or more calendar days in that month. A minimum gross payment of \$500.00 is assured if an Operator was employed for fifteen calendar days or more in any month between April 1, 2015, and March 31, 2018. The amount listed in Exhibit A, and not the formula, defines the gross amount due to each Operator. The gross amount will be subject to all legally required deductions. King County will issue a W-2 in connection with each payment.

b. **Individual Participation and Release Forms.** The Parties will agree upon and distribute individual participation and release forms (substantially in the form attached at Exhibit B) to all Operators and will notify the Operators of a deadline (no less than three weeks after the initial distribution of the forms) for the Operators to complete, sign, and submit the forms. Each Operator who completes, signs, and submits an individual participation and release form will be provided with an individual gross settlement payment as listed in Exhibit A (less required deductions). Operators who do not complete, sign, and submit individual participation and release forms by the deadline will not receive a payment unless the Parties agree otherwise. King County will provide Local 587 with a list of all Operators who submit

individual participation and release forms. King County will provide Local 587 with copies of signed individual participation and release forms upon request.

c. **Settlement Payment Process.** The individual settlement payments will be made within a reasonable period after the deadline for submission of the individual participation and release forms and after final approval of this Agreement by the King County Council. King County may, in its sole discretion, direct deposit, hand deliver, or mail individual settlement payments. For current employees, individual settlement payments may be included with the regular payroll distribution. If, for any reason, the settlement is not finally approved, then no payments will occur under this Agreement.

d. **Withholding and Taxes.** Settlement payments will be subject to all taxes, contributions, and withholdings required by law. For purposes of withholding, King County may use the most recent tax reporting information or documentation in its records and withhold at the supplemental tax rate. Local 587, the Operators, and their counsel agree to cooperate fully with King County as reasonably necessary to allow King County to distribute the settlement payments, pay required taxes and withholdings, and issue any required documentation.

3. **Release of Claims.** This Agreement constitutes a full and final settlement and release of any and all wage claims for or relating to recorded, unrecorded, off-the-clock, additional, undercompensated, or uncompensated work time and any related overtime (or the calculation thereof) that were or could have been asserted by Local 587 or the Operators against King County and its current or former officers, directors, employees, affiliates, related entities, representatives, agents, and attorneys (the "Released Parties"). This release covers any and all wage claims, rights, demands, charges, complaints, grievances, causes of action, damages, obligations, disputes, or liabilities of any kind or nature for or relating to recorded, unrecorded, off-the-clock, additional, undercompensated, or uncompensated work time and any related overtime (or the calculation thereof) that have been or could have been asserted in litigation, whether known or unknown, arising out of the work performed by the Operators. This expressly includes, but is not limited to, any statutory (*e.g.*, RCW Chapters 41.56, 49.12, 49.46, 49.48, and 49.52), contractual, or common law claim for compensation, wages, unpaid amounts, double damages, interest, penalties, costs, expenses, and/or attorneys' fees for or relating to recorded, unrecorded, off-the-clock, additional, undercompensated, or uncompensated work time and any related overtime (or the calculation thereof) that arose prior to April 1, 2018. This expressly excludes any claims that cannot be released as a matter of law. A parallel release will be included in every individual participation and release form as provided in Section 2(b).

4. **Grievances.** In light of the foregoing release of claims and after receipt of the list and any requested copies of individual participation release forms of Operators who submit such forms, Local 587 will withdraw with prejudice grievances, if any, for wage matters released in Section 3 (including but not limited to pre-trip time, see-me time, and unpaid time during the picks) for any Operator who submits an individual release. Nothing in this Agreement shall be construed to preclude Local 587 from pursuing the grievance of any Operator who does not release the claims covered by this Agreement.

5. **No Effect on Employee Benefits.** This Agreement, and any individual settlement awards paid hereunder, will have no effect on the eligibility and/or calculation of employee entitlements or benefits of Operators.

6. **Miscellaneous Provisions.**

a. **Internal Approvals.** The Parties understand and agree that this Agreement is subject to final approval by the King County Council. The effective date will be the date that the Agreement receives final approval.

b. **Headings.** The descriptive headings of any paragraphs or sections of this Agreement are provided for convenience of reference only and do not constitute a part of this Agreement.

c. **Modification of Settlement.** This Agreement may be amended or modified only by a written instrument signed by all Parties or the counsel for all Parties, or their successors-in-interest.

d. **Authorization to Enter Into Settlement.** The Parties and their Counsel warrant and represent that they are expressly authorized to enter into this Agreement and to take all appropriate actions required or permitted to be taken by such Parties pursuant to this Agreement to effectuate its terms, and to execute any other documents required to effectuate the terms of this Agreement and a full and final resolution of the issues addressed herein. The Parties and their counsel will cooperate with each other and use their best efforts to effect the implementation of the Agreement. In the event the Parties are unable to reach agreement on the form or content of any document needed to implement the Agreement, or on any supplemental provisions that may become necessary to effectuate the terms of this Agreement, the Parties may seek the assistance of a mutually designated third party to resolve such disagreement.

e. **Agreement Binding on Successors and Assigns.** This Agreement will be binding upon, and inure to the benefit of, any successors or assigns of the Parties hereto.

f. **Washington Law Governs.** Interpretation and enforcement of this Agreement and any exhibits hereto will be governed by and interpreted according to the substantive and procedural laws that exist in the State of Washington on the effective date of this Agreement. This Agreement has been freely negotiated and will not be construed in favor of or against any party.

g. **Enforcement.** Venue for any action under or to or interpret or enforce this Agreement shall lie in Seattle, King County, Washington. The parties agree that any such dispute will be submitted to arbitration with a mutually agreeable arbitrator. The arbitrator will have no authority to add to, subtract from, or modify in any manner the terms of this Agreement. The arbitrator may only interpret this Agreement. Except to the extent fees are authorized and awarded pursuant to statute, each side will bear its own attorneys' fees, and the non-prevailing party will bear the fees of the arbitrator and court reporter unless prohibited by law. Judgment

on any award may be entered in a court of competent jurisdiction. This provision will be specifically enforceable under the laws of the State of Washington. The decision of the arbitrator will be final and binding to the extent permitted by law. This Agreement, and any dispute in relation to the interpretation or enforcement of the Agreement, will not be subject to the dispute resolution process in the collective bargaining agreements between the parties.

h. Execution of Agreement. This Agreement may be executed in one or more counterparts, all of which together will constitute one agreement, and each of which separately will constitute an original document.

i. No Precedent. This Agreement is not precedent setting, does not establish past practice, and may not be used to otherwise establish or alter the collectively bargained terms between the Parties.


j. Entire Agreement. This Agreement, including Exhibits A and B, constitutes the ENTIRE AGREEMENT between the parties and should be interpreted as an integrated whole. The Agreement supersedes all other representations, statements, understandings, and agreements pertaining to and is intended to fully and finally address the issues released in Section 3. If any substantive section of this Agreement is held invalid or unenforceable, the Agreement is void and the Parties will take all actions necessary to return the parties to their status at the time of its execution. There are no other or further agreements that modify or amplify the terms of this Agreement. The terms of this Agreement are contractual and not a mere recital.

7. Acknowledgement. The Parties warrant and represent that they have carefully read this Agreement, know the contents thereof, have had the assistance of counsel, understand the Agreement is waiving potential wage claims, did not rely upon any representation or statement not expressly included in the Agreement, understand the Agreement's final and binding effect, and are signing the Agreement freely and voluntarily.




