1 AN ORDINANCE revising the legal description of the
2 annexation of approximately 99.98 acres of land into the
3 King County water district No. 119, known as the Felling
4 Annexation, for the purpose of water service; and
5 amending Ordinance 18742, Section 1.

6 **STATEMENT OF FACTS:**

- 7 1. On May 7, 2018, the council adopted Ordinance 18742, which
8 approved the annexation of approximately 99.98 acres of land into King
9 County water district No. 119. The executive approved the ordinance on
10 June 19, 2018. Ordinance 18742 became effective on June 29, 2018.
- 11 2. Ordinance 18742 contained an incorrect legal description of the
12 annexation area.
- 13 3. On August 7, 2018, the clerk of the council received a corrected legal
14 description from the Washington state Boundary Review Board for King
15 County.

16 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

17 SECTION 1. Ordinance 18742, Section 1, is hereby amended to read as follows:

18 The annexation of approximately 99.98 acres of land into the King County water
19 district No. 119 for the purpose of providing water service described in Attachment A to

20 ((~~Ordinance 18742~~)) this ordinance is approved. Approval of this proposed annexation is
21 consistent with RCW 57.02.040.
