1 AN ORDINANCE making a net supplemental  
2 appropriation of \$18,264,000 to various general fund  
3 agencies, a net supplemental appropriation of \$229,666,000  
4 to various non-general fund agencies and a net  
5 supplemental appropriation of \$45,003,000 to various  
6 capital fund budgets; and amending the 2019-2020 Biennial  
7 Budget Ordinance, Ordinance 18835, Sections 7, 9, 11, 13,  
8 16, 19, 19, 21, 21, 24, 26, 26, 28, 29, 31, 32, 33, 34, 35, 39,

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. From the general fund there is hereby appropriated a net total of  
17 \$18,264,000 to various general fund agencies.

18 From non-general funds there are hereby appropriated a net total of \$229,666,000  
19 to various non-general fund agencies.

20 There is hereby appropriated a net total of \$45,003,000 to various capital fund  
21 budgets, amending the 2019-2020 Biennial Budget Ordinance, Ordinance 18835.

22 SECTION 2. Ordinance 18835, Section 7, as amended, is hereby amended as  
23 follows:

24 COUNCIL ADMINISTRATION - From the general fund there is hereby  
25 appropriated to:

26 Council administration \$1,380,000

27 The maximum number of additional FTEs for council administration shall be: 2.0

28 SECTION 3. Ordinance 18835, Section 9, as amended, is hereby amended as  
29 follows:

30 COUNTY AUDITOR - From the general fund there is hereby appropriated to:

31 County auditor \$45,000

32 SECTION 4. Ordinance 18835, Section 11, as amended, is hereby amended as

34 KING COUNTY CIVIC TELEVISION - From the general fund there is hereby  
35 appropriated to:

45 fund there is hereby appropriated to:

47 SECTION 7. Ordinance 18835, Section 19, as amended, is hereby amended as  
48 follows:

49 OFFICE OF PERFORMANCE, STRATEGY AND BUDGET - From the general  
50 fund there is hereby disappropriated from:

51 Office of performance, strategy and budget (\$100,000)

52 SECTION 8. The council directs that section 7 of this ordinance takes effect  
53 before section 9 of this ordinance.

54 SECTION 9. Ordinance 18835, Section 19, as amended, is hereby amended as  
55 follows:

56 OFFICE OF PERFORMANCE, STRATEGY AND BUDGET - From the general  
57 fund there is hereby appropriated to:

58 Office of performance, strategy and budget \$130,000

59 ER1 EXPENDITURE RESTRICTION:

60 Of this appropriation, \$35,000 shall be expended or encumbered solely to  
61 reimburse the department of human resources for the cost of assigning two Ruth Woo  
62 fellows, as described in K.C.C. 3.12.184, for three to four months to the office of  
63 performance, strategy and budget.

64 ER2 EXPENDITURE RESTRICTION:

65 Of this appropriation, \$500,000 shall be expended or encumbered solely to issue a

66 request for proposals, and to manage and pay a contractor to conduct the feasibility study  
67 for a waste to energy facility to manage the region's solid waste that provides a  
68 comparison to waste export by rail as described in Proviso P4 of this section.

69 P1 PROVIDED THAT:

70 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
71 office of performance, strategy and budget transmits a report providing a model for  
72 downwardly adjusting the value of rights-of-way in road vacation petitions and for  
73 estimating the processing costs for such petitions, and until the director of the office of  
74 performance, strategy and budget or designee participates in one examiner hearing and  
75 answers questions during the hearing related to that modeling. The report under this  
76 proviso will provide the hearing examiner information necessary to make a determination  
77 of how to "adjust" the "appraised value" of rights-of-way, in accordance with RCW  
78 36.87.120.

79 The report shall include, but not be limited to, a model for estimating:

80 A. The net present value of a future tax stream from transferring a right-of-way  
81 area to private ownership;

82 B. The avoided liability risk associated with vacating: actual opened roads;  
83 frequently-traversed public areas; and undeveloped, unopened rights-of-way;

84 C. The avoided costs for management or maintenance associated with vacating:  
85 actual opened roads; frequently traversed public areas; and undeveloped, unopened  
86 rights-of-way; and

87 D. The department of local services average processing costs for a typical road  
88 vacation petition.

89           The executive must file the report by February 1, 2019, in the form of a paper  
90 original and an electronic copy with the clerk of the council, who shall retain the original  
91 and provide an electronic copy to the hearing examiner, and the director of the office of  
92 performance, strategy and budget or designee must participate in one examiner hearing  
93 by May 1, 2019. After the examiner holds the public hearing on behalf of the council, the  
94 examiner will file that report, along with the examiner's recommendation, in the form of a  
95 paper copy and an electronic copy with the clerk of the council, who shall retain the  
96 original copy and provide an electronic copy to all councilmembers and the council chief  
97 of staff.

98           P2 PROVIDED FURTHER THAT:

99           Of this appropriation, \$100,000 shall not be expended or encumbered until the  
100 executive transmits a report on countywide performance measures and a motion that  
101 should acknowledge receipt of the report and reference the subject matter, the proviso's  
102 ordinance, ordinance section and proviso number in both the title and body of the motion,  
103 and a motion acknowledging receipt of a countywide performance measures report is  
104 passed by the council.

105           The countywide performance measures report shall include, but not be limited to:

106           A. A description of the county's performance measure processes, including data  
107 collection and evaluation methods;

108           B. A description of performance measures currently reported by each county  
109 agency;

110           C. Performance measures results for 2017 and 2018 for all agencies reporting to  
111 the county executive. For all other county agencies, the report should include either any

112 performance measures or analysis of performance data accessible to the office of  
113 performance, strategy and budget, or both, for 2017 and 2018;

114 D. Information on how the county's performance measures and performance  
115 measure process compare to other jurisdictions; and

116 E. A description of any recommended improvements to the county's performance  
117 measurement process.

118 The executive should file the countywide performance measures report and a  
119 motion required by this proviso by December 1, 2019, in the form of a paper original and  
120 an electronic copy with the clerk of the council, who shall retain the original and provide  
121 an electronic copy to all councilmembers, the council chief of staff and the lead staff for  
122 the committee of the whole, or its successor.

123 P3 PROVIDED FURTHER THAT:

124 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
125 executive transmits a King County pretrial reform report from a workgroup to be  
126 established by the executive in accordance with this proviso and a motion that  
127 acknowledges receipt of report, and a motion is passed by the council. The motion  
128 should reference the subject matter, the proviso's ordinance, ordinance section and  
129 proviso number in both the title and body of the motion.

130 The workgroup shall be convened by the office of performance, strategy and  
131 budget and shall include representatives from the department of public defense,  
132 prosecuting attorney's office, the superior and districts courts, the department of adult and  
133 juvenile detention, the council, the department of judicial administration and community  
134 and nonprofit organizations working to reduce pretrial incarceration. The workgroup

135 shall consult with community stakeholders, including those representing victims of crime.

136 The activities of the workgroup shall include, but not be limited to:

137       A. Reviewing quantitative and qualitative data to evaluate the number of adults  
138 held in King County correction facilities who have not been adjudicated or sentenced  
139 ("pretrial") and why;

140       B. Developing recommendations based on the review conducted in Section A of  
141 this proviso to reduce the number of nonviolent pretrial adults held in King County  
142 correction facilities; and

143       C. Developing recommendations to improve collection and integration of King  
144 County data related to pretrial detention to allow for meaningful analysis.

145       The King County pretrial reform report shall include, but not be limited to: (1) a  
146 quantitative analysis of the current pretrial jail population and a qualitative review of the  
147 current pretrial process to inform an analysis of the factors that are contributing to pretrial  
148 detention; (2) documentation of the activities conducted by the workgroup as required by  
149 this proviso; (3) the recommendations identified by the workgroup as required by this  
150 proviso; and (4) from a noncounty subject matter expert on pretrial detention,  
151 recommendations of specific actions King County can take to reduce pretrial detention  
152 and issues related thereto.

153       The executive should file the report and a motion required by this proviso by July  
154 31, 2019, in the form of a paper original and an electronic copy with the clerk of the  
155 council, who shall retain the original and provide an electronic copy to all  
156 councilmembers, the council chief of staff and the lead staff for the law and justice  
157 committee, or its successor.

158 P4 PROVIDED FURTHER THAT:

159 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
160 executive transmits the feasibility study for a waste to energy facility to manage the  
161 region's solid waste that provides a comparison to waste export by rail and a motion that  
162 should acknowledge receipt of the feasibility study and reference the subject matter, the  
163 proviso's ordinance, ordinance section and proviso number in both the title and body of  
164 the motion and a motion acknowledging receipt of the feasibility study is passed by the  
165 council. The study should be performed by a contractor with significant experience in  
166 the field of waste management and recycling, demonstrated expertise with waste to  
167 energy technology and familiarity with the capital and operating needs of waste to energy  
168 facilities located around the world, and shall primarily consider a waste to energy facility  
169 that uses mass burn technology. The contractor may also identify other technologies that  
170 may be feasible to accommodate the current and future projections for the amount and  
171 composition of the county's waste stream. The solid waste division must provide the  
172 county's waste tonnage forecast model to the contractor upon request and explain any  
173 assumptions.

174 The feasibility study shall include, but not be limited to:

175 A. A review of factors that may affect the county's future waste tonnage forecast  
176 completed in 2018, and an analysis, with a range of estimates, of how different  
177 assumptions could affect the forecast;

178 B. A discussion of the potential for exporting the county's waste by rail that  
179 includes an analysis of the future rail capacity forecast, the estimated capital and  
180 operating costs and the environmental impacts;



181 C. An evaluation of the size of a waste to energy facility that would be needed to  
182 accommodate the county's solid waste over a twenty to fifty year time horizon, beginning  
183 in 2025, with any assumptions clearly articulated, and a description of any siting needs  
184 including the necessary parcel size;

185 D. A discussion of the costs of a waste to energy facility and potential financing  
186 options that includes estimates for the capital costs, the annual operating and maintenance  
187 costs and the estimated impact on the county's tipping fee, with any assumptions clearly  
188 articulated;

189 E. A discussion of any environmental impacts of a waste to energy facility;

190 F. An assessment of regional electricity markets and the regulatory structure to  
191 produce an estimate of potential revenues from the sale of electricity by a waste to energy  
192 facility;

193 G. An analysis of other potential revenue sources from the potential byproducts  
194 of a waste to energy facility that includes, but is not limited to, the sale of recovered  
195 metals and possible uses of bottom ash;

196 H. A discussion of the state and federal regulatory environment related to waste  
197 to energy facilities; and

198 I. A reasonable timeline for implementation of a waste to energy facility, and an  
199 analysis of the potential impact on the lifespan and capacity of the Cedar Hills regional  
200 landfill if a waste to energy facility was developed according to this timeline.

201 The executive should file the feasibility study and a motion required by this  
202 proviso by October 4, 2019, in the form of a paper original and an electronic copy with  
203 the clerk of the council, who shall retain the original and provide an electronic copy to all

204 councilmembers, the council chief of staff and the lead staff for the committee of the  
205 whole, or its successor.

206 P5 PROVIDED FURTHER THAT:

207 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
208 executive transmits a report on parity between the prosecuting attorney's office and the  
209 department of public defense and a motion that should acknowledge receipt of the report  
210 and reference the subject matter, the proviso's ordinance, ordinance section and proviso  
211 number in both the title and body of the motion and a motion acknowledging receipt of  
212 the report is passed by the council.

213 The report shall include, but not be limited to a definition of parity, which  
214 includes caseloads. The report shall review the extent to which there is parity in the  
215 staffing and budgets between the prosecuting attorney's office and the department of  
216 public defense, examine the staffing levels for each court and provide budget options for  
217 achieving parity between the two agencies.

218 The executive should file the report and a motion required by this proviso by July  
219 8, 2019, in the form of a paper original and an electronic copy with the clerk of the  
220 council, who shall retain the original and provide an electronic copy to all  
221 councilmembers, the council chief of staff and the lead staff for the law and justice  
222 committee, or its successor.

223 P6 PROVIDED FURTHER THAT:

224 Of this appropriation, \$150,000 shall not be expended or encumbered until the  
225 executive transmits a plan to implement the winery, brewery and distillery code updates  
226 and, if recommended by the plan, a proposed ordinance that adds appropriation or FTE

227 authority, or both, to effectuate the plan.

228         The plan to implement the winery, brewery and distillery code updates shall  
229 include, but not be limited to: (1) a description of the departments and divisions  
230 necessary to implement the code updates in Ordinance XXXXX (Proposed Ordinance  
231 2018-0241); a description of the necessary steps those department and divisions will take  
232 to implement the code updates, including but not limited to public outreach and  
233 education, technical compliance and permit assistance for businesses; permitting and  
234 enforcement activities; and any other necessary implementation activities; (2) a  
235 description of the necessary resources to implement the code updates, including  
236 additional FTE, temporary term limited positions and consultant resources; appropriation  
237 authority for those resources; (3) a description of the activities that a consultant would  
238 perform that justifies the requested appropriation, if one is needed; and (4) an estimated  
239 timeframe necessary to bring existing winery, brewery or distillery businesses into  
240 compliance with the updated code, or come to resolution through the code enforcement  
241 process for those businesses that cannot be brought into compliance.

242         The executive should file the plan to implement the winery, brewery and distillery  
243 code updates and a proposed ordinance required by this proviso by February 15, 2019, or  
244 within thirty days of Ordinance XXXXX (Proposed Ordinance 2018-0241) being moved  
245 out of committee, whichever comes first, in the form of a paper original and an electronic  
246 copy with the clerk of the council, who shall retain the original and provide an electronic  
247 copy to all councilmembers, the council chief of staff and the lead staff for the planning,  
248 rural service and environment committee, or its successor.

249         P7 PROVIDED FURTHER THAT:

250 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
251 executive transmits a plan, developed in consultation with the sheriff, to provide bulk rate  
252 gasoline and vehicle license plates to King County search and rescue volunteers and a  
253 motion that should acknowledge receipt of the plan and reference the subject matter, the  
254 proviso's ordinance, ordinance section and proviso number in both the title and body of  
255 the motion, and a motion acknowledging receipt of a plan is passed by the council.

256 The executive should file the plan and a motion required by this proviso by  
257 December 31, 2019, in the form of a paper original and an electronic copy with the clerk  
258 of the council, who shall retain the original and provide an electronic copy to all  
259 councilmembers, the council chief of staff and the lead staff for the law and justice  
260 committee, or its successor.

261 SECTION 10. Ordinance 18835, Section 21, as amended, is hereby amended as  
262 follows:

265 SECTION 11. The council directs that section 10 of this ordinance takes effect  
266 before section 12 of this ordinance.

268 follows:

269 SHERIFF - From the general fund there is hereby appropriated to:  
270 Sheriff \$401,976,000

271 The maximum number of additional FTEs for sheriff shall be: 5.5

272 ER1 EXPENDITURE RESTRICTION:

273 Of this appropriation, \$10,000 shall be expended or encumbered solely to provide  
274 traffic safety reflective gloves and flashlight extender wands to all sheriff patrol deputies.

275 ER2 EXPENDITURE RESTRICTION:

276 Of this appropriation, \$241,000 shall be expended or encumbered solely to  
277 comply with the processing and certification requirements under RCW 7.98.020 related  
278 to petitions for U and T nonimmigrant visas.

279 ER3 EXPENDITURE RESTRICTION:

280 Of this appropriation, no more than ~~(((\$200,000))~~\$500,000 shall be expended or  
281 encumbered to support in-service training in the areas of procedural justice, listen and  
282 explain with equity and dignity communication, violence de-escalation~~((;))~~ and antibias  
283 ~~((and crisis intervention))~~ training for any employees managed by the King County  
284 sheriff until a motion accepting a report as referenced in Proviso P3 of this section is  
285 passed by the council.

286 ER4 EXPENDITURE RESTRICTION:

288 solely for a background check detective position.

312 requirements under RCW 7.98.020 related to petitions for U and T nonimmigrant visas.

313           The letter shall include:

314           A. A list of all U and T nonimmigrant-visa certification forms filed with the  
315 sheriff's office in the previous quarter including the date each certification form was filed  
316 with the sheriff's office, and the date each certification form was executed by the sheriff's  
317 office; and

318           B. A confirmation from the sheriff stating that the office is compliant with the

319 processing and certification requirements under RCW 7.98.020.

320 Moneys shall be unencumbered in \$100,000 increments upon receipt of each  
321 quarterly letter, transmitted by the sheriff to the clerk of the council.

322 The sheriff must file the first quarterly letter required by this proviso by April

342 number in both the title and body of the motion and a motion acknowledging receipt of  
343 the plan is passed by the council.

344 The plan shall include, but not be limited to:

345 A. Descriptions of the specific in-service training curriculum modules, which  
346 shall include the areas of procedural justice, listen and explain with equity and dignity  
347 communication, violence de-escalation((;)) and antibias ((~~and crisis intervention~~))  
348 training;

349 B. Description of the method of delivering such trainings to both deputies and  
350 other employees managed by the sheriff;

351 C. The timeline for implementation of in-service trainings in the areas of  
352 procedural justice, listen and explain with equity and dignity (LEED) communication,  
353 violence de-escalation((;)) and antibias ((~~and crisis intervention~~)) training to both  
354 deputies and other employees managed by the sheriff;

355 D. An analysis describing how the in-service training curriculum in the areas of  
356 procedural justice, listen and explain with equity and dignity (LEED) communication,  
357 violence de-escalation((;)) and antibias ((~~and crisis intervention~~)) training will meet the  
358 anticipated state-mandated law enforcement training requirements; and

359 E. An assessment of the efficacy of the planned in-service training curriculum  
360 modules in the areas of procedural justice, listen and explain with equity and dignity  
361 (LEED) communication, violence de-escalation((;)) and antibias ((~~and crisis~~  
362 ~~intervention~~)) training, methods of delivery and implementation timeline by the office of  
363 law enforcement oversight.

364 The sheriff's office should file the plan and a motion required by this proviso by



365 June 1, 2019, in the form of a paper original and an electronic copy with the clerk of the  
366 council, who shall retain the original and provide an electronic copy to all  
367 councilmembers, the council chief of staff and the lead staff for the law and justice  
368 committee, or its successor.

369 P4 PROVIDED FURTHER THAT:

370 Of this appropriation, \$100,000 shall not be expended or encumbered until the  
371 sheriff transmits a report describing the actions and resources necessary for a community  
372 policing model to be implemented in the unincorporated areas of each of the sheriff  
373 precincts.

374 The report shall include, but not be limited to:

375 A. A description of a community policing model that would best serve the  
376 unincorporated area residents of each of the sheriff precincts, including the organizational  
377 structure and guiding policies that would be employed in the development and  
378 implementation of a community policing model for the unincorporated area of each  
379 sheriff precinct;

380 B. A list of organizations, including, but not limited to, nonprofits, neighborhood  
381 groups, homeowner associations, schools and businesses in the unincorporated area of  
382 each sheriff precinct, identified as potential partners necessary to advance the objectives  
383 of community policing in their respective sheriff precinct;

384 C. A description of the staffing levels necessary to increase the sheriff's office  
385 visibility through neighborhood specific patrols in the unincorporated area of each sheriff  
386 precinct as compared to current reactive policing methods;

387 D. An assessment of the feasibility of establishing a taskforce or roundtable

388 bringing together representatives from each individual sheriff precinct and those  
389 community leaders within the unincorporated area of the respective sheriff precinct to  
390 foster collaboration and trust in furtherance of the objectives of community policing;

391 E. A description of the resources and estimated time necessary to implement a  
392 community policing model in the unincorporated area of each sheriff precinct; and

393 F. An analysis of obstacles to implementing a community policing model in the  
394 unincorporated area of each of the sheriff precincts and methods of overcoming those  
395 obstacles.

396 The sheriff should file the report by June 29, 2019, in the form of a paper original  
397 and an electronic copy with the clerk of the council, who shall retain the original and  
398 provide an electronic copy to all councilmembers, the council chief of staff and the lead  
399 staff for the law and justice committee, or its successor.

854           7. Any other significant driver of mandatory overtime; and

855           B. Recommendations for how to address the causes of mandatory overtime  
856 identified in the report and reduce its usage.

857           The executive should file the report and a motion required by this proviso by June  
858 1, 2019, in the form of a paper original and an electronic copy with the clerk of the  
859 council, who shall retain the original and provide an electronic copy to all  
860 councilmembers, the council chief of staff and the lead staff for the budget and fiscal

2094 B. The proposed configuration for the modular dorms at each location, including:  
2095 the proposed layout for the modular dorms and the amount and types of other spaces to  
2096 be provided, such as space for cooking and eating, hygiene, recreation or supportive  
2097 services;

2098 C. An update on the project budget for site preparation at each site and for  
2099 operating costs for the remainder of the 2019-2020 biennium;

2100 D. A timeline to begin operation of the modular dorms at each site; and

2101 E. A description of the efforts that have been made or are planned to seek and  
2102 consider public input from surrounding communities.

2103 The executive should file the modular dorm plan and a motion required by this  
2104 proviso by March 1, 2019, in the form of a paper original and an electronic copy with the  
2105 clerk of the council, who shall retain the original and provide an electronic copy to all  
2106 councilmembers, the council chief of staff(~~(, the regional housing coordinator))~~) and the  
2107 lead staff for the health, housing and human services committee, or its successor.

2108 SECTION 69. Ordinance 18835, Section 107, as amended, is hereby amended as  
2109 follows:

2113 ER1 EXPENDITURE RESTRICTION:

2114 Of this appropriation, \$200,000, shall be expended or encumbered solely to  
2115 support a report on implementation of a Kenmore water taxi route.

2116 ER2 EXPENDITURE RESTRICTION:

2117 Of this appropriation, \$100,000 shall be expended or encumbered solely to  
2118 support a Renton citywide transit access study required by section 109, Proviso P2, of  
2119 this ordinance.

2120 ER3 EXPENDITURE RESTRICTION:

2121 Of this appropriation, \$200,000 shall be expended or encumbered solely to  
2122 support a report on implementation of a Ballard-to-downtown-Seattle water taxi route.

2123 P1 PROVIDED THAT:

2124 Of this appropriation, \$200,000 shall not be expended or encumbered until the  
2125 executive transmits a report on implementation of a Kenmore water taxi route and a  
2126 motion that should acknowledge receipt of the report and reference the subject matter, the  
2127 proviso's ordinance, ordinance section and proviso number in both the title and body of  
2128 the motion and a motion acknowledging receipt of the report on implementation of a  
2129 Kenmore water taxi route is passed by the council.

2130 The report on implementation of a Kenmore water taxi route shall include, but not  
2131 be limited to:

2132 A. An update on the assessment of facilities, ridership projections, and capital  
2133 and operating cost estimates provided in the 2015 ferry expansion options report;

2134 B. A discussion of planning efforts underway or needed to implement the route;

2135 C. An environmental impact analysis;

2136 D. A summary of coordination with local agencies, including potential lease  
2137 arrangements for facilities;

2138 E. A discussion of options for funding implementation of the route including  
2139 identifying grant opportunities;

2140 F. A summary of public outreach undertaken; and

2141 G. A description of next steps for moving forward.

2142 The executive should file the report on implementation of a Kenmore water taxi  
2143 route and a motion required by this proviso by July 31, 2020, in the form of a paper  
2144 original and an electronic copy with the clerk of the council, who shall retain the original  
2145 and provide an electronic copy to all councilmembers, the council chief of staff and the  
2146 lead staff for the mobility committee, or its successor.

2147 SECTION 70. Ordinance 18835, Section 108, as amended, is hereby amended as

2160 Of this appropriation, \$55,000 shall be expended or encumbered solely to  
2161 reimburse the department of human resources for the cost of assigning two Ruth Woo  
2162 fellows, as described in K.C.C. 3.12.184, for three to four months to the wastewater  
2163 treatment division.

2164 ER2 EXPENDITURE RESTRICTION:

2165 Of this appropriation, \$400,000 shall be expended or encumbered solely to  
2166 evaluate the presence of toxic elements in the effluent of treatment plants, as provided in  
2167 Proviso P1 of this section.

2168 ER3 EXPENDITURE RESTRICTION:

2169 Of this appropriation, \$2,435,849, shall be expended or encumbered solely for  
2170 water quality improvement activities, programs or projects and only in the amounts and  
2171 for the specific water quality improvement activities, programs or projects located within  
2172 the King County wastewater treatment service area set forth by ordinance. Of this  
2173 amount, \$133,500 shall be reserved for administrative costs associated with the program.

2174 The ordinance or ordinances required by this expenditure restriction must be

2178 the Thornton Creek Alliance noxious weed project, as a water quality improvement  
2179 project provided for in Expenditure Restriction ER3 of this section.

2180 P1 PROVIDED THAT:

2181 Of this appropriation, \$300,000 shall not be expended or encumbered until the

2182 executive transmits a status report on the progress of finalizing and transmitting an  
2183 evaluation report on toxics in King County wastewater effluent, ((evaluating)) which  
2184 shall include an evaluation of the presence of toxic elements in the effluent of treatment  
2185 plants, and a motion that acknowledges receipt of the status report and ~~((the))~~ a motion  
2186 acknowledging receipt of the status report is passed by the council. The motion should  
2187 reference the subject matter, the proviso's ordinance, ordinance section and proviso  
2188 number in both the title and body of the motion.

2189       The status report should inform the council on the timeline line of when the  
2190 required elements of the evaluation report, as set forth in this proviso, are expected to be

2199 emerging concern and other toxics in the undiluted effluent of treatment plants. While  
2200 the evaluation shall be as broad as possible within costs, to the extent necessary to narrow  
2201 the scope of the evaluation in light of the extensive range of potentially toxic elements,  
2202 the focus shall be on: (1) those elements considered most toxic to the marine  
2203 environment generally; and (2) those elements considered potentially toxic to Southern  
2204 Resident Killer Whales and the hierarchy of marine species upon which the Southern



2205 Resident Killer Whales depend. The evaluation shall additionally assess whole effluent  
2206 toxicity of the discharges, to assess the impact of the complex mix of toxic elements on  
2207 marine species. The assessment shall be designed to indicate whether undiluted  
2208 wastewater effluent represents a potential source of deleterious toxic influence to Puget  
2209 Sound marine organisms, and to Southern Resident Killer Whales and the hierarchy of  
2210 marine species upon which they depend particularly. The evaluation shall include an  
2211 assessment of the accumulation of those toxic elements in marine organisms, either  
2212 directly or through bioaccumulation, and shall discuss potential impacts on metabolic  
2213 processes, behavior and mortality. The assessment may be accomplished either through  
2214 analysis of the tissue of selected species, or through bioaccumulation modeling. The  
2215 evaluation shall describe potential wastewater treatment technologies that have the  
2216 capacity, in part or in whole, to limit or control the discharge of toxics in wastewater  
2217 effluents to a significantly greater extent than is currently being accomplished at King  
2218 County treatment plants.

2219       The work to perform the evaluations required by this proviso and to prepare the  
2220 evaluation report shall be contracted to an entity or entities with the ~~((capacity))~~ expertise  
2221 to address the required elements of ~~((this))~~ the evaluation~~((;))~~. ~~((p))~~Preference shall be  
2222 given to entities with a demonstrated history of evaluating and reporting on the impacts  
2223 of wastewater effluents on the marine environment, including impacts on Southern  
2224 Resident Killer Whales or their prey species, and that have the capacity for modeling the  
2225 bioaccumulation of toxics.

2226       The results of the evaluation shall be described in an evaluation report on toxics in  
2227 King County wastewater effluent. Within the limits of funding, the report shall describe

2228 the presence, origin, volume, toxicity, environmental fate and impacts to the marine  
2229 environment of toxics evaluated, and shall discuss the identified or potential impacts of  
2230 those toxics on marine species, particularly including the Southern Resident Killer  
2231 Whales and the hierarchy of marine species upon which those killer whales depend.

2232 The executive (~~(must)~~) should file the status report and a motion required by this  
2233 proviso by (~~(March)~~) December 31, 2020, in the form of a paper original and an  
2234 electronic copy with the clerk of the council, who shall retain the original and provide an  
2235 electronic copy to all councilmembers, the council chief of staff and the lead staff for the  
2236 regional water quality committee and the committee of the whole, or their successors.

2237 P2 PROVIDED FURTHER THAT:

2238 Of this appropriation, \$250,000 shall not be expended or encumbered until the  
2239 executive transmits a report on the Kenmore interceptor impacts to fish populations and a  
2240 motion that acknowledges receipt of the report and the motion is passed by the council.

2241 The motion should reference the subject matter, the proviso's ordinance, ordinance  
2242 section and proviso number in both the title and body of the motion.

2243 The report shall include, but not be limited to: (1) a discussion of the design and  
2244 placement of Section 2 of the Kenmore interceptor, with particular attention to the  
2245 placement of the interceptor section and efforts to avoid the accumulation of silt and  
2246 accommodate the movement of water fauna; (2) a characterization of the silt  
2247 accumulation beneath and around the Interceptor in the intervening years since its  
2248 construction; (3) an analysis of the impacts of the silt accumulation on water fauna, with  
2249 particular attention to the ability of the fauna to freely access the lake environment on  
2250 both sides of the interceptor, including any potential impacts on the migration of

2251 anadromous species; (4) an analysis of the interruption of natural upland soil distribution  
2252 processes from area streams discharging into the lake in the area of the interceptor  
2253 Section 2. The report shall additionally address the impacts on the nearshore  
2254 environment of effectively creating a barrier resulting in functionally separated lake  
2255 areas. The report shall discuss options to remedy identified impacts as well as associated  
2256 costs, and recommend appropriate subsequent steps.

2257         The executive must file the report and motion required by this proviso by March  
2258 31, 2020, in the form of a paper original and an electronic copy with the clerk of the  
2259 council, who shall retain the original and provide an electronic copy to all  
2260 councilmembers, the council chief of staff and the lead staff for the regional water quality  
2261 committee and the committee of the whole, or their successors.

2262         P3 PROVIDED FURTHER THAT:

2263         Of this appropriation, \$100,000 shall not be expended or encumbered until the  
2264 executive transmits a report on the management of biosolids generated in the processing  
2265 of wastewater at county facilities and a motion that acknowledges receipt of the report,  
2266 and a motion acknowledging receipt is passed by the council. The motion should  
2267 reference the subject matter, the proviso's ordinance, ordinance section and proviso  
2268 number in both the title and body of the motion.

2269         The primary existing biosolids processing strategy utilized by the county  
2270 emphasizes the land application of biosolids generated by the wastewater treatment  
2271 process at county facilities ("biosolids") in forest and farm environments. The report  
2272 shall describe and evaluate alternative options for the use of those biosolids. The report  
2273 should also address alternative biosolids management approaches that may lead to an

2274 expansion or diversification of the markets for those biosolids.

2275 The report shall include, but not be limited to:

2276 A. As an alternative option to be evaluated, the construction of a local biosolids  
2277 facility that could generate by-products to include gas, electricity, Class A soil  
2278 enhancer/amendment or for other productive uses;

2279 B. To compare the costs and benefits of the alternative options to the existing  
2280 strategy a financial analysis comparing the alternative options to the existing strategy,  
2281 including the transportation costs of the existing strategy;

2282 C. The size of the physical footprint needed for a biosolids facility sited locally,  
2283 at which those biosolids could be further refined into marketable by-products, including

2295 1, 2020, in the form of a paper original and an electronic copy with the clerk of the  
2296 council, who shall retain the original and provide an electronic copy to all

2297 councilmembers, the council chief of staff and the lead staff for the regional water quality  
2298 committee and the committee of the whole, or their successors.

2310 ER1 EXPENDITURE RESTRICTION:

2311 Of this appropriation, \$55,000 shall be expended or encumbered solely to  
2312 reimburse the department of human resources for the cost of assigning two Ruth Woo  
2313 fellows, as described in K.C.C. 3.12.184, for three to four months to the Metro transit  
2314 department.

2315 ER2 EXPENDITURE RESTRICTION:

2316 Of this appropriation, \$200,000 shall be expended or encumbered solely to  
2317 complete the Renton citywide transit access study required by ~~((p))~~Proviso P2 of this  
2318 section.

2319 ER3 EXPENDITURE RESTRICTION:

2320           Of this appropriation, \$10,000,000 shall be expended or encumbered solely to  
2321 implement the council-approved income-based fare program required by Proviso P3 of  
2322 this section. The program shall begin no later than March 31, 2020.

2323           ER4 EXPENDITURE RESTRICTION:

2324           Of this appropriation, \$900,000 shall be expended or encumbered solely for staff,

2335           Of this appropriation, revenues from parking fees may not be collected, expended  
2336 or encumbered until the motion required by Proviso P5 of this section has been passed by  
2337 the council.

2338           ER8 EXPENDITURE RESTRICTION:

2339           Of this appropriation, \$200,000 shall be expended or encumbered solely to  
2340 support a report on implementation of a Kenmore water taxi route required by section  
2341 107, Proviso P1, of this ordinance.

2342           ER9 EXPENDITURE RESTRICTION:

2343           Of this appropriation, \$2,189,000 shall only be expended or encumbered to  
2344 deliver 25,000 annual service hours in addition to the 176,575 net new fixed route service  
2345 hours included in the executive's proposed 2019-2020 budget. The new annual service  
2346 hours must be consistent with the priorities in the 2018 or 2019 system evaluation report  
2347 and must contribute to geographic value within the system. Geographic value is a  
2348 defined transit system design factor found at page 22 of the 2015 update to the King  
2349 County Metro Strategic Plan for Public Transportation 2011-2021, which is Attachment  
2350 A to Ordinance 18301.

2351           ER10 EXPENDITURE RESTRICTION:

2352           Of this appropriation, \$200,000 shall be expended or encumbered solely to  
2353 support a report on implementation of a Ballard-to-downtown-Seattle water taxi route  
2354 required by Proviso P8 of this section.

2355           P1 PROVIDED THAT:

2356           Of this appropriation, \$1,000,000 shall not be expended or encumbered until the  
2357 executive transmits two Access paratransit service updates and a motion that should  
2358 acknowledge receipt of each Access paratransit service update and reference the subject  
2359 matter, the proviso's ordinance, ordinance section and proviso number in both the title  
2360 and body of the motion and a motion acknowledging receipt of each Access paratransit  
2361 service update is passed by the council.

2362           A. In recognition of the importance of Access paratransit to the passengers it  
2363 serves and to reflect the council's commitment to service excellence in Access paratransit  
2364 operations, each Access paratransit service update should include, but not be limited to:

- 2365           1. The contractor's compliance with contract terms;

- 2366           2. Performance metrics and trends over each reporting period, including, but not  
2367 limited to:
- 2368           a. on-time performance;
  - 2369           b. pick-up window, including early pick-ups, late pick-ups and excessively late  
2370 pick-ups;
  - 2371           c. missed trips;
  - 2372           d. drop-off window, including early drop-offs and late drop-offs;
  - 2373           e. on-board time and excessively long trips; and
  - 2374           f. will call;
- 2375           3. Areas of deficiency or improvement during each reporting period;
- 2376           4. Potential service improvements, including information about their budgetary  
2377 requirements; and
- 2378           5. Potential service innovations, such as increased opportunities for same-day  
2379 service using taxicabs or transportation network companies, including information about  
2380 their budgetary requirements.

2381           B. The following Access paratransit service updates shall be transmitted to the  
2382 council:

- 2383           1. A six-month oversight report by April 30, 2020; and
- 2384           2. An annual report by August 31, 2020.

2385           The executive should file each Access paratransit service update and the motions  
2386 required by this proviso in the form of a paper original and an electronic copy with the  
2387 clerk of the council, who shall retain the original and provide an electronic copy to all  
2388 councilmembers, the council chief of staff and the lead staff for the mobility committee,



2389 or its successor.

2390 P2 PROVIDED FURTHER THAT:

2391 Of this appropriation, \$1,000,000 shall not be expended or encumbered until the

2393 The Renton citywide transit access study shall be carried out in close coordination  
2394 with the city of Renton and shall include, but not be limited to:

2395 A. A review of the existing transportation and land use environment throughout  
2396 the city of Renton, assessing existing travel demand and cataloging existing access to  
2397 transit assets, and identifying high priority areas within the city to focus the work of the  
2398 study. The review should acknowledge existing and projected investment in the northern  
2399 area of the city known as The Landing and the city's restructure of downtown  
2400 infrastructure to create a business, transit and pedestrian-friendly area;

2401 B. Development of the Access Vision and Goals, which shall include a vision of  
2402 future fixed route service, including Lake Washington/Southport water taxi service, and  
2403 goals for customer access to transit. This should include consideration of already  
2404 identified future transit; specifically, the two planned RapidRide lines, the colocated  
2405 Sound Transit BRT and Metro transit department service at Rainier and Grady, facilities  
2406 and access improvements at I-405 and 44th to address planned bus service and transit-  
2407 oriented development redevelopment of the Vulcan "Pan Adobe" site, and examination of  
2408 service expansion during off-peak times and weekends in the Sunset/Highlands Area.  
2409 Using those goals, evaluation criteria to measure potential access investments shall be  
2410 developed;

2411 C. An analysis that identifies gaps in access between existing conditions and the

2412 vision;

2413 D. Identification of potential operating investments and capital projects that can  
2414 improve access, which shall include high level cost estimates for those investments;

2415 E. Evaluation of each project against the evaluation criteria identified in  
2416 subsection B. of this proviso; and

2417 F. Development of an implementation plan for the projects identified in  
2418 subsection D. of this proviso. For each project, the implementation plan should include  
2419 timing, roles, partners and potential funding.

2420 The executive should file the study required by this proviso by October 1, 2019,  
2421 in the form of a paper original and an electronic copy with the clerk of the council, who  
2422 shall retain the original and provide an electronic copy to all councilmembers.

2423 P3 PROVIDED FURTHER THAT:

2424 Of this appropriation, \$1,000,000 shall not be expended or encumbered until the  
2425 executive transmits an income-based fare program implementation plan and a motion that  
2426 should approve the income-based fare program implementation plan, and the motion is  
2427 passed by the council. The motion should reference the subject matter, the proviso's  
2428 ordinance, ordinance section and proviso number in both the title and body of the motion.

2429 A. The income-based fare program implementation plan shall be informed by:

2430 1. Input from an income-based fare stakeholder group convened by the Metro  
2431 transit department and that includes participants from populations that experience low  
2432 income, to include but not limited be to: representatives from communities of color,  
2433 immigrants and refugees and limited-English-speaking populations; youth; students  
2434 attending postsecondary educational institutions and in job training and apprenticeship

2435 programs; affordable-housing residents; low-income King County employees; and  
2436 representatives from human service providers. The Metro transit department shall solicit  
2437 from the councilmembers and the executive suggestions of possible participants for the  
2438 stakeholder group. The stakeholder group should provide input on: barriers to accessing  
2439 transit for low-income individuals; program alignment with the Metro transit  
2440 department's policy objectives; pricing; eligibility; verification and other business  
2441 processes; funding and partnership opportunities; and program evaluation. The  
2442 stakeholder group should consider and evaluate providing no or very low cost access to  
2443 transit for residents earning one hundred thirty-~~((five))~~ eight percent of the federal  
2444 poverty level or less;

2445           2. Guidance from academic or private sector experts in designing and evaluating  
2446 programs to improve access to economic opportunities for low-income individuals;

2447           3. Data and market research on the transportation needs and access barriers of  
2448 low-income populations in the Metro transit department's service area; and

2449           4. King County's Equity and Social Justice Strategic Plan.

2450           B. The income-based fare program implementation plan shall include:

2451           1. A description of an income-based fare program, including, but not limited to:

2452           a. individuals who would be served by the program, including income  
2453 eligibility and demographics;

2454           b. how the program would be designed, including fare media to be used and  
2455 income-verification methods;

2456           c. estimated program costs and proposed funding sources and potential  
2457 partners, including a discussion of tradeoffs between using resources for such a program

2458 compared to other purposes such as transit service hours. Proposed funding of the  
2459 program shall adhere to the Metro transit department's fund management policies,  
2460 including maintaining a farebox recovery minimum of twenty-five percent;

2461 d. potential policy changes that would be needed to implement an income-  
2462 based fare program;

2463 e. how the program would be marketed to eligible populations, including  
2464 enrollment goals and regular performance reporting. Enrollment shall be as low-barrier  
2465 as possible in terms of proof of qualifications and ability to enroll;

2466 f. how the Metro transit department will partner or seek partners to market the  
2467 program, enroll eligible populations, and whether there should be program cost sharing.  
2468 The program should be coordinated with human service provider agencies in order to  
2469 streamline participants' access to a range of income-based services; and

2470 g. how this broad income-based program is proposed to interface with existing  
2471 fare programs such as ORCA LIFT, the human services ticket program and the passport  
2472 and business choice account programs;

2473 2. A description of how the program will be evaluated, including collecting data  
2474 on rider demographics and travel needs, and will develop performance goals and  
2475 reporting; and

2476 3. A discussion of whether or how the income-based fare program will be  
2477 integrated with the ORCA system, including the financial, policy or technological  
2478 barriers to implementing an income-based fare program within the ORCA system and the  
2479 potential for future enhancements to an income-based fare program with implementation  
2480 of Next Generation ORCA.

2481           The executive should provide an oral briefing to the mobility committee, or its  
2482 successor, on the progress of developing the program by June 30, 2019, and should file  
2483 the income-based fare program implementation plan and a motion required by this  
2484 proviso by September 30, 2019, along with any necessary legislation to implement the  
2485 program by March 31, 2020, in the form of a paper original and an electronic copy with  
2486 the clerk of the council, who shall retain the original and provide an electronic copy to all  
2487 councilmembers, the council chief of staff and the lead staff for the mobility committee,  
2488 or its successor.

2489           P4 PROVIDED FURTHER THAT:

2490           No moneys restricted by Expenditure Restriction ER5 of this section shall be  
2491 expended or encumbered until the executive transmits a Metro transit department parking  
2492 facility user fee revenue expenditure plan and a motion that should approve the  
2493 expenditure plan and reference the subject matter, the proviso's ordinance, ordinance  
2494 section and proviso number in both the title and body of the motion, and a motion  
2495 approving the expenditure plan is passed by the council.

2496           The expenditure plan shall include, but not be limited to: the costs to implement  
2497 the transit parking facility user fee program to be implemented in accordance with  
2498 Ordinance XXXX (Proposed Ordinance 2018-0477), including costs and forgone revenues  
2499 related to implementation of the user fee program. The expenditure plan shall also include  
2500 a description of any proposed use of the user fee to increase access to the Metro transit  
2501 department's park-and-ride facilities or to expand the Metro transit department's network of  
2502 park-and-ride facilities, or the application of innovative technology and management  
2503 practices to the network.

2504           The executive should file the expenditure plan and a motion required by this  
2505 proviso in the form of a paper original and an electronic copy with the clerk of the  
2506 council, who shall retain the original and provide an electronic copy to all  
2507 councilmembers, the council chief of staff and the lead staff for the mobility committee,  
2508 or its successor.

2509           P5 PROVIDED FURTHER THAT:

2510           No moneys restricted by Expenditure Restriction ER7 of this section shall be  
2511 collected, expended or encumbered until the executive transmits a parking fee program  
2512 plan and a motion that should approve the plan and reference the subject matter, the  
2513 proviso's ordinance, ordinance section and proviso number in both the title and body of  
2514 the motion and a motion approving a plan is passed by the council.

2515           The parking fee program plan shall include, but not be limited to:

2516           A. A report on a rulemaking procedure carried out under the authority of K.C.C.  
2517 chapter 2.98, including a description of the public outreach process detailing outreach and  
2518 public meetings conducted in the affected communities listed in this subsection A. The  
2519 report should also address the specific ways in which the outreach process complies with  
2520 the goals of the King County Equity and Social Justice Strategic Plan. The report should  
2521 also describe how the rules promulgated by the department improve access to transit  
2522 parking for populations that experience low income, including communities of color,  
2523 immigrants and refugees, limited-English-speaking populations, transit-dependent  
2524 populations, individuals who work nontraditional schedules or during off-peak travel  
2525 periods and other transit riders;

2526           B. An implementation plan for the parking fee program, which shall include, but

2527 not be limited to: a timeline, criteria for determining which parking facilities may  
2528 participate in the plan; estimates of costs and fee revenues; and public notification and  
2529 communication plans;

2530 C. A performance measurement plan that describes the performance measures used  
2531 to evaluate parking fee program success or failure, its costs and benefits, and its goals,  
2532 which include: encouraging use of transit; spreading peak-of-the-peak demand for  
2533 transit; increasing ridership in the region; improving access to transit parking for low-  
2534 income populations as described in section A of this proviso; increasing carpooling; and  
2535 covering program costs; and

2536 D. A report on the department's proposed expenditures supported by parking fee  
2537 program revenues.

2538 The executive should file the plan and a motion required by this proviso in the  
2539 form of a paper original and an electronic copy with the clerk of the council, who shall  
2540 retain the original and provide an electronic copy to all councilmembers, the council chief  
2541 of staff and the lead staff for the mobility committee, or its successor.

2542 P6 PROVIDED FURTHER THAT:

2543 Of this appropriation, \$500,000 shall not be expended or encumbered until the  
2544 executive transmits two reports on the parking facilities user fee rules set in accordance  
2545 with Ordinance XXXX (Proposed Ordinance 2018-0477), Section 1.B. It is anticipated  
2546 that the department will utilize permits as part of the parking facilities user fee structure  
2547 rule it is authorized to establish under Ordinance XXXX (Proposed Ordinance 2018-  
2548 0477). The first report should be due December 31, 2019, and the second report should  
2549 be due June 30, 2020. Upon transmittal of each report, \$250,000 shall be released for

2550 expenditure or encumbrance.

2551           Each report shall include, but not be limited to, data on the number of single-  
2552 occupancy vehicle permits, single-occupancy vehicle ORCA Lift cardholder permits and  
2553 high-occupancy vehicle permits issued for each parking facility, permit usage, revenue  
2554 and how the parking facility user fee program contributes to achieving the department's  
2555 parking management goals, which include: encouraging use of transit; spreading peak-  
2556 of-the-peak demand for transit; increasing ridership in the region; improving access to  
2557 transit parking for low-income populations, communities of color, immigrants and  
2558 refugees, limited-English-speaking populations, transit-dependent populations,  
2559 individuals who work nontraditional schedules or during off-peak travel periods and  
2560 other transit riders; increasing carpooling; and covering program costs.

2561           Each report shall be filed in the form of a paper original and an electronic copy  
2562 with the clerk of the council, who shall retain the original and provide an electronic copy  
2563 to all councilmembers.

2564           P7 PROVIDED FURTHER THAT:

2565           Of this appropriation, \$1,000,000 shall not be expended or encumbered until the  
2566 executive transmits an implementation plan for expanding the number of locations where  
2567 individuals who qualify for regional reduced fare permit ORCA cards and youth ORCA  
2568 cards ("reduced fare ORCA cards") can apply for and receive those cards and a motion  
2569 approving the implementation plan, and a motion approving the implementation plan is  
2570 passed by the council. The motion should reference the subject matter, the proviso's  
2571 ordinance, ordinance section and proviso number in both the title and body of the motion.

2572           A. The implementation plan shall be informed by:



2573           1. Engagement with: (a) populations that would be eligible for a reduced fare  
2574 ORCA card, such as youths ages six through eighteen, seniors ages sixty-five and over,  
2575 and individuals with disabilities; and (b) parents of youth, schools, other stakeholders and  
2576 members of the public. The engagement process should solicit input on what are the  
2577 barriers to immediately accessing the existing reduced fare ORCA cards and suggestions  
2578 for more accessible and convenient procurement locations and enrollment processes for  
2579 these ORCA cards. The engagement may be carried out in conjunction with other Metro  
2580 transit department fares outreach and engagement efforts; and

2581           2. King County's Equity and Social Justice Strategic Plan.

2582           B. The reduced fare ORCA card procurement location implementation plan shall  
2583 include, but not be limited to:

2584           1. A description of the types of reduced fare ORCA card procurement locations  
2585 considered including but not limited to libraries, schools, retail locations and buildings  
2586 where government services are provided such as city halls, evaluation criteria used to  
2587 assess them, and how flexible delivery through the ORCA To-Go program integrates  
2588 with the plan;

2589           2. Estimated new and existing costs, FTE and contracting needs and proposed  
2590 funding sources, including fare revenue impacts, to implement the plan;

2591           3. Potential policy changes that would be needed to implement an expansion of  
2592 reduced fare ORCA card procurement locations, including policy changes that provide  
2593 for expanded locations for immediate issuance both of ORCA cards that require  
2594 photographs and those that do not;

2595           4. A summary of engagement efforts and stakeholder input required by

2596 subsection A.1. of this proviso;

2597 5. How the expansion of reduced fare ORCA card procurement locations would  
2598 be marketed to eligible populations;

2599 6. How the Metro transit department would partner or seek partners to serve as  
2600 reduced fare ORCA card procurement locations;

2601 7. A description of populations anticipated to be served at each reduced fare  
2602 ORCA card procurement location;

2603 8. A map of the potential and proposed reduced fare ORCA card procurement  
2604 locations; and

2605 9. A schedule for opening the new reduced fare ORCA card procurement  
2606 locations as early as 2020.

2607 The executive should file the reduced fare ORCA card procurement location  
2608 implementation plan and a motion required by this proviso by March 31, 2020, in the  
2609 form of a paper original and an electronic copy with the clerk of the council, who shall  
2610 retain the original and provide an electronic copy to all councilmembers, the council chief  
2611 of staff and the lead staff for the mobility and environment committee, or its successor.

2612 P8 PROVIDED FURTHER THAT:

2613 Of this appropriation, \$200,000 shall not be expended or encumbered until the  
2614 executive transmits a report on implementation of a Ballard-to-downtown-Seattle water  
2615 taxi route and a motion that should acknowledge receipt of the report and reference the  
2616 subject matter, the proviso's ordinance, ordinance section and proviso number in both the  
2617 title and body of the motion and a motion acknowledging receipt of the report on  
2618 implementation of a Ballard-to-downtown-Seattle water taxi route is passed by the

2619 council.

2620 The report on implementation of a Ballard-to-downtown-Seattle water taxi route  
2621 shall include, but not be limited to:

2622 A. An update on the assessment of facilities, ridership projections, and capital  
2623 and operating cost estimates provided in the 2015 ferry expansion options report;

2624 B. A discussion of planning efforts underway or needed to implement the route;

2625 C. An environmental impact analysis;

2626 D. A summary of coordination with local agencies, including potential lease  
2627 arrangements for facilities;

2628 E. A discussion of options for funding implementation of the route including  
2629 identifying grant opportunities;

2630 F. A summary of public outreach undertaken; and

2631 G. A description of next steps for moving forward.

2632 The executive should file the report on implementation of a Ballard-to-downtown-  
2633 Seattle water taxi route and a motion required by this proviso by December 31, 2020, in  
2634 the form of a paper original and an electronic copy with the clerk of the council, who  
2635 shall retain the original and provide an electronic copy to all councilmembers, the council  
2636 chief of staff and the lead staff for the mobility committee, or its successor.

2637 SECTION 76. Ordinance 18835, Section 111, as amended, is hereby amended as  
2638 follows:

2639 WASTEWATER EQUIPMENT RENTAL AND REVOLVING - From the  
2640 wastewater equipment rental and revolving fund there is hereby appropriated to:
