1 AN ORDINANCE prohibiting law enforcement personnel
2 from questioning, except in limited circumstances, persons
3 under the age of eighteen when Miranda rights are
4 administered and prohibiting law enforcement personnel
5 from requesting permission from a person under the age of
6 eighteen to conduct a search of the person or property,
7 abodes or vehicles under that persons control unless legal
8 counsel is provided for that person; and adding a new
9 chapter to K.C.C. Title 2.

10 STATEMENT OF FACTS:

- 11 1. Developmental and neurological science concludes that the process of
12 cognitive brain development continues into adulthood and that the human
13 brain undergoes "dynamic changes throughout adolescence and well into
14 young adulthood." Regarding this, see Richard J. Bonnie, et al.,
15 Reforming Juvenile Justice: A Developmental Approach, National
16 Research Council (2013), p. 96 and Ch. 4.
- 17 2. As recognized by the United States Supreme Court in *J.D.B. v. North*
18 *Carolina*, 564 U.S. 261 (2011), children are "generally are less mature and

19 responsible than adults," "often lack the experience, perspective, and
20 judgment to recognize and avoid choices that could be detrimental to
21 them," "are more vulnerable or susceptible to... outside pressures than
22 adults" and "characteristically lack the capacity to exercise mature
23 judgment and possess only an incomplete ability to understand the world
24 around them." As stated in *Graham v. Florida*, 560 U.S. 48 (2010),
25 children "have limited understandings of the criminal justice system and
26 the roles of the institutional actors within it."

27 3. Under the Fifth Amendment to the United States Constitution,
28 according to *Miranda v. Arizona*, 384 U.S. 436 (1966), custodial
29 interrogation of an individual by law enforcement requires that the
30 individual be advised of their rights and make a knowing, intelligent and
31 voluntary waiver of those rights before the interrogation proceeds. The
32 individual must have "full awareness of both the nature of the right being
33 abandoned and the consequences of the decision to abandon it.," according
34 to *Moran v. Burbine*, 475 U.S. 412 (1986).

35 4. Article 1, Section 7 of the Washington Constitution and the Fourth
36 Amendment to the United States Constitution govern when an individual's
37 person or belongings may be searched by law enforcement. *Schneckloth*
38 *v. Bustamonte*, 412 U.S. 218, 219 (1973), states: "It is well settled under
39 the Fourth and Fourteenth Amendments that a search conducted without a
40 warrant issued upon probable cause is 'per se unreasonable ... subject only
41 to a few specifically established and well-delineated exceptions.'"

42 5. It is equally well settled that one of the specifically established
43 exceptions to the requirements of both a warrant and probable cause is a
44 search that is conducted under consent, as provided in *Davis v. United*
45 *States*, 328 U.S. 582, 593-594 (1947), and *Zap v. United States*, 328 U.S.
46 624 (1946).

47 6. If law enforcement asks for a person's consent, the government has the
48 burden of demonstrating the voluntariness of the consent, according to
49 *State v. Shoemaker*, 85 Wn.2d 207, 2710 (1975). To be valid, the consent
50 must be voluntary and the search must not exceed the scope of consent,
51 according to *State v. Hastings*, 119 Wn.2d 229, 234 (1992). Whether
52 consent is freely given is a question of fact dependent upon the totality of
53 the circumstances, which includes: "(1) whether Miranda warnings had
54 been given prior to obtaining consent; (2) the degree of education and
55 intelligence of the consenting person; and (3) whether the consenting
56 person had been advised of his right to consent," according to *Shoemaker*,
57 85 Wn.2d at 211-12.

58 7. A large body of research has established that adolescent thinking tends
59 to either ignore or discount future outcomes and implications and to
60 disregard long-term consequences of important decisions. See examples
61 in Steinberg et al., Age Differences in Future Orientation and Delay
62 Discounting, *Child Development*, vol. 80 (2009), pp. 28-44; William
63 Gardner and Janna Herman, Adolescents' AIDS Risk Taking: A Rational
64 Choice Perspective, in *Adolescents in the AIDS Epidemic*, ed. William

65 Gardner et al. (San Francisco: Jossey Bass, 1990), pp. 17, 25-26; Marty
66 Beyer, Recognizing the Child in the Delinquent, *Kentucky Children's*
67 *Rights Journal*, vol. 7 (Summer 1999), pp. 16-17; National Juvenile Justice
68 Network, *Using Adolescent Brain Research to Inform Policy: A Guide for*
69 *Juvenile Justice Advocates*, September 2012, pp. 1-2; and Catherine C.
70 Lewis, *How Adolescents Approach Decisions: Changes over Grades*
71 *Seven to Twelve and Policy Implications*, *Child Development*, vol. 52
72 (1981), pp. 538, 541-42).

73 8. An extensive body of literature demonstrates that juveniles are more
74 suggestible than adults, may easily be influenced by questioning from
75 authority figures and may provide inaccurate reports when questioned in a
76 leading, repeated and suggestive fashion. For examples, see *J.D.B.*, 564
77 U.S. 261. Recent research has shown that more than one-third of proven
78 false confessions were obtained from suspects under the age of eighteen.
79 See examples in Drizen & Leo, *The Problem of False Confession in the*
80 *Post- DNA World* (2004) 82 N.C.L. 11 Rev. 891, 902, 944-945. fn 5.

81 9. Black children commonly feel a great deal of fear and distrust when
82 interacting with law enforcement, as a result of their own experiences and
83 those of their friends, family and community members, especially those
84 who have been verbally or physically abused by the police. This is
85 discussed in Kristin Henning, *The Reasonable Black Child: Race,*
86 *Adolescence, and the Fourth Amendment*, 67 *American University Law*
87 *Review* 1513 (June, 2018).

88 10. In 2018 and 2019, the King County sheriff's office was responsible for
89 approximately twenty percent of the all filings in the King County
90 superior court's juvenile division.

91 BE IT ORDAINED THE COUNCIL OF KING COUNTY:

92 SECTION 1. Sections 2 through 4 of this ordinance should constitute a new
93 chapter in K.C.C. Title 2.

94 NEW SECTION. SECTION 2. The county finds this chapter necessary in order
95 to ensure that, as provided in this chapter, youth shall neither be subject to questioning by
96 law enforcement personnel nor be asked by law enforcement personnel to consent to or
97 authorize the search of the youth or any property, abodes or vehicles, under the control of
98 the youth until after legal representation has been provided for the youth. This chapter is
99 intended to honor the life of MiChance Dunlap-Gittens, who dreamed of one day going to
100 law school and championing the rights of young people.

101 NEW SECTION. SECTION 3. The definitions in this section apply throughout
102 this chapter unless the context clearly requires otherwise.

103 A. "Imminent threat" means an objectively reasonable need to protect persons
104 from an immediate danger consistent with the public safety exception to the Miranda rule
105 first announced in the United States Supreme Court case *New York v. Quarles*, 467 U.S.
106 656, 81 L. Ed. 2d 550, 104 S. Ct. 2626 (1984).

107 B. "Law enforcement personnel" means any King County sheriff's employee or
108 volunteer having as a primary function the enforcement of criminal laws in general,
109 including, but not limited to, commissioned sheriff deputies, and includes such
110 employees performing law enforcement services on behalf of a city pursuant to an

111 interlocal agreement. For the purposes of this subsection, "primary function" means that
112 function to which the greater allocation of resources is made.

113 C. "Miranda warnings" means verbal warnings given by law enforcement
114 advising the individual that the individual has the right to remain silent, the right to
115 consult with an attorney and have the attorney present during questioning and the right to
116 have legal counsel if the individual cannot afford legal counsel.

117 D. "Youth" means any person under the age of eighteen.

118 NEW SECTION. SECTION 4.

119 A. Except as otherwise provided in subsection D. of this section, after law
120 enforcement personnel administers Miranda warnings to a youth and before any further
121 questioning of the youth may occur, the youth must consult with legal counsel in person,
122 by telephone or by video conference. The consultation may not be waived.

123 B. Before law enforcement personnel requesting any required consent or
124 authorization from a youth to search the youth or any property, abodes or vehicles under
125 the control of the youth, the youth shall consult with legal counsel in person, by
126 telephone or by video conference. The consultation may not be waived and is required
127 regardless of the youth's custody status.

128 C. After the youth has consulted with legal counsel, the youth may choose to
129 either advise, have a parent or guardian advise or direct the legal counsel to advise the
130 law enforcement personnel whether the youth chooses to assert a constitutional right.
131 Except in the circumstances when the youth chooses to advise or have a parent or
132 guardian advise the law enforcement personnel, any statement by legal counsel regarding
133 the assertion of the youth's constitutional rights shall be treated by law enforcement

134 personnel the same as if it came from the youth.

135 D. Under the following limited circumstances, the prohibition in subsection A. of
136 this section shall not apply to questioning after Miranda warnings are administered, if
137 each of following criteria are met:

138 1. Law enforcement personnel reasonably believes the information sought is
139 necessary to protect life from an imminent threat;

140 2. Reasonable delay to allow legal counsel consultation by phone would hamper
141 the protection of life from an imminent threat; and

142 3. The questioning is limited to those matters that are reasonably necessary to
143 obtain information necessary to protect life from an imminent threat.

144 E. Law enforcement personnel shall prepare a written record for each instance
145 when subsection D. of this section is invoked. The record shall document the following:

146 1. The time the youth was advised of the Miranda warnings;

147 2. The time the youth was questioned without legal consultation;

148 3. The reasons that justified questioning the youth without prior legal counsel
149 consultation;

150 4. The questions posed to the youth;

151 5. Information related to the youth, including name, age and race;

152 6. Information related to the law enforcement personnel questioning the youth,
153 including the name and badge number of each of the law enforcement personnel.

154 F. Twice each year, the sheriff's office shall transmit copies of the records
155 required by subsection E. of this section to the prosecuting attorney and the director of
156 the King County department of public defense. The sheriff and these agencies will

157 collaborate on the protocols that the sheriff shall follow to transmit copies of the records.
158 Each quarter, the sheriff's office shall transmit copies of the records required by
159 subsection E. of this section electronically to the clerk of the council. The clerk shall
160 provide the electronic copy to all councilmembers, the council chief of staff and the lead
161 staff for the law and justice committee or its successor. The sheriff's office shall redact
162 the name of the youth and replace it with initials in the records transmitted under this
163 section.

164 SECTION 5.

165 A. On January 4 of each year, through 2023, the sheriff's office shall report on:

- 166 1. The number of youth arrests, by month, compared to the three years before
167 the effective date of this ordinance;
- 168 2. The number of times youth were administered their Miranda warnings;
- 169 3. The number of times Miranda rights were waived;
- 170 4. The number of times law enforcement requested permission from a youth to
171 conduct a search of the youth, their property, abodes or vehicles under the youth's
172 control;
- 173 5. The number of times youth consented to a search;
- 174 6. The number of times legal counsel were provided to youth; and
- 175 7. Whether this ordinance has resulted in any systemic problems in securing
176 safety in emergency situations or impaired investigations.

177 B. In preparing the report, the sheriff's office is requested to seek input from the
178 department of public defense and the prosecuting attorney regarding impacts, whether
179 perceived as positive or negative, from implementation of this ordinance. The sheriff's

180 office must file the report in the form of a paper original and an electronic copy with the
181 clerk of the council, who shall retain the original and provide an electronic copy to all
182 councilmembers, the council chief of staff and the lead staff to the law and justice
183 committee, or its successor.

184 SECTION 6. If any provision of this ordinance or its application to any person or

185 circumstance is held invalid, the remainder of the ordinance or the application of the
186 provision to other persons or circumstances is not affected.
