1 AN ORDINANCE authorizing the King County executive
2 to execute an amendment to the interlocal agreement with
3 the King County flood control zone district extending the
4 duration of the interlocal agreement through December 31,
5 2021.

6 **STATEMENT OF FACTS:**

7 1. King County and the King County flood control zone district entered
8 into the Interlocal Agreement Between King County and the King County
9 Flood Control Zone District Regarding Flood Protection Services,
10 effective January 1, 2016.

11 2. Over the next four years, the interlocal agreement has been amended to
12 extend the term of the interlocal agreement.

13 3. Currently, the interlocal agreement shall terminate on December 31,
14 2020.

15 4. The COVID response efforts have resulted in a delay in completing for
16 a negotiation on a new or amended interlocal agreement.

17 5. The county and the district desire to continue to operate under the
18 terms of the interlocal agreement until new interlocal agreement terms can
19 be finalized. To that end, and to preserve the status quo, it is anticipated

20 that at a meeting in October the district's board of supervisors will adopt a
21 resolution s approving the extension of the interlocal agreement to
22 December 31, 2021, consistent with proposed fourth amendment, which is
23 Attachment A to this ordinance.

24 6. Extending the current interlocal agreement is necessary for the
25 immediate preservation of the parties' ability to continue, unabated, to
26 provide flood management and protection services, which will preserve
27 the health and safety of the residents of King County and help protect
28 them from the ravages of flooding.

29 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

30 SECTION 1. The council supports and authorizes the executive to execute a
31 fourth amendment, substantially in the form of Attachment A to this ordinance, to the

**FOURTH AMENDMENT TO
INTERLOCAL AGREEMENT BETWEEN
KING COUNTY AND THE KING COUNTY FLOOD CONTROL ZONE DISTRICT
REGARDING FLOOD PROTECTION SERVICES**

THIS FOURTH AMENDMENT to the “Interlocal Agreement between King County and the King County Flood Control Zone District Regarding Flood Protection Services” (“Agreement”), is entered into by KING COUNTY, a home rule charter County in the State of Washington (“County”) and KING COUNTY FLOOD CONTROL ZONE DISTRICT, a quasi-municipal corporation of the State of Washington (“District”), and shall be effective upon execution by both Parties.

The Parties agree to amend the Agreement as follows:

- 1. The text of Section 13.1 is deleted and replaced with the following:

This Agreement shall take effect January 1, 2016 and shall remain in effect through December 31, 2021.

All other terms of the Agreement not amended by this Fourth Amendment shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this Fourth Amendment to be executed by their authorized representatives.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.
