1 AN ORDINANCE affirming the establishment of an
2 advisory committee to provide input to council during the
3 council's office of law enforcement oversight director
4 appointment process.

5 **STATEMENT OF FACTS:**

6 1. The council is in the process of appointing a new director of the office
7 of law enforcement oversight ("OLEO") through a nationwide search. As
8 a part of that process, the council approved Motion 15830 establishing the
9 office of law enforcement oversight director recruitment advisory
10 committee to provide input to the council during the process to appoint a
11 new director of OLEO.

12 2. Motion15830 provides for the committee to be comprised of members
13 who are employed by King County and members who are not employed
14 by King County.

15 3. K.C.C. 2.28.006 authorizes the council by ordinance to provide per
16 diem compensation for members of specific boards and commissions.

17 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

18 **SECTION 1.**

19 A. The office of law enforcement oversight director recruitment advisory

20 committee is established, consistent with Motion 15830. The duties of the recruitment
21 advisory committee shall include:

22 1. Providing input on the candidate profile which Ralph Anderson & Associates
23 will use to describe the director of the office of law enforcement oversight position to
24 attract qualified candidates;

25 2. Interviewing finalist candidates for the position of the director of the office of
26 law enforcement oversight as selected by a subcommittee of the employment and
27 administration committee of the council;

28 3. Providing input about each final candidate to the council based on the
29 recruitment advisory committee review of application materials and candidate interviews.
30 The committee shall not rank or score the candidates as a part of its evaluation process or
31 its submission of input to the council; and

32 4. Working in collaboration with Ralph Anderson & Associates and council
33 staff to provide timely reports to the council.

34 B. The membership of the recruitment advisory committee collectively represent
35 the expertise, viewpoints and perspectives needed to advise the council during its
36 recruitment of the office of law enforcement oversight director.

37 C. The recruitment advisory committee shall consist of the following members:

- 38 1. DeVitta Briscoe, Not This Time, codirector;
- 39 2. Michael Byun, Asian Counseling and Referral Services, executive director;
- 40 3. Sergeant Loi Dawkins, King County Police Officers Guild;
- 41 4. Angela Donaldson, Fall City Community Association, president;
- 42 5. Captain Mark Konoske; Puget Sound Police Managers Association;

- 43 6. Laura Philpot; Maple Valley, city manager;
- 44 7. Liz Rocca; King County sheriff's office, chief of staff;
- 45 8. Adrienne Wat; office of law enforcement oversight, interim director;
- 46 9. Abiel Woldu; community advisory committee for law enforcement oversight,
- 47 president; and
- 48 10. Sili Savusa; White Center Community Development Association, executive
- 49 director.

50 D. The council retains authority to decide which finalists will be interviewed and

51 which finalist will be appointed as the director of OLEO in accordance with Section 265

52 of the King County Charter and K.C.C. chapter 2.75.

53 SECTION 2. Members of the office of law enforcement oversight director

54 recruitment advisory committee who are neither employees of King County nor

55 employees of other municipal governments shall receive per diem compensation of one

56 hundred and fifty dollars for attendance at each meeting lasting two hours or less; or three

57 hundred dollars for each meeting exceeding two hours. Total compensation for each

58 committee member who is neither an employee of King County nor an employee of

59 another municipal government is limited to five hundred dollars for the entirety of the

60 member's service on the law enforcement oversight director recruitment advisory

61 committee. The purpose of the per diem compensation is to compensate those

62 nongovernmental employee committee members for their experience and expertise

63 contribution to the process of appointing a new director of the office of law enforcement

64 oversight.

65 SECTION 3. This ordinance expires September 1, 2021.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
