#### Ordinance 19350

**Proposed No.** 2021-0380.2 **Sponsors** Kohl-Welles 1 AN ORDINANCE relating to county funds; and adding a 2 new section to K.C.C. chapter 4A.200. 3 STATEMENT OF FACTS: 4 1. In 2018, Ordinance 18793 created the department of human resources 5 and started the process of moving employee administrative functions to 6 one central organizational location. 7 2. In 2020, Ordinance 19199 moved the benefits, payroll and retirement 8 operations section of the department of executive services to the 9 department of human resources to complete the centralization of all 10 employee administrative functions in order to create a single point of 11 accountability for all human resource business functions. 12 3. Pursuant to K.C.C. 2.16.036.E.6., the central employee services 13 division of the department of human resources is responsible for 14 administering the employer responsibilities for the deferred compensation 15 plan. 16 4. An administrative subfund, called the employees deferred 17 compensation administration subfund, pays the operational costs of the 18 deferred compensation board. The main source of revenue for the subfund 19 is from fees charged to employees through their investments in the 20 deferred compensation plan.

21	5. The employees deferred compensation administration subfund is
22	currently an administrative subfund of the general fund and managed by
23	the director of the department of executive services.
24	6. Creation of a new deferred compensation fund to be managed by the
25	department of human resources will support the centralization of all
26	employee administrative functions.
27	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
28	SECTION 1. The transfer of all net assets and fund balances related to
29	administering the employer responsibilities for the deferred compensation plans from the
30	general fund to the fund created in section 2 of this ordinance is approved and effective.
31	NEW SECTION. SECTION 2. There is hereby added to K.C.C. chapter 4A.200
32	a new section to read as follows:
33	A. There is hereby created the deferred compensation fund.
34	B. The fund is a first tier fund. It is a special revenue fund.
35	C. The director of the department of human resources shall be the manager of the
36	fund.
37	D. The fund shall provide for the receipt of revenues and disbursement of

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. # **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

# Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

# Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

#### All notices and disclosures will be sent to you electronically
