1 AN ORDINANCE specifying county policy for the
2 procurement of compost, as required by chapter 43.19A
3 RCW; and adding a new chapter to K.C.C. Title 18.

4 **PREAMBLE:**

5 In 2022, the Washington state Legislature passed, and Governor Jay Inslee
6 signed, Engrossed Second Substitute House Bill 1799, sections of which
7 were codified in chapter 43.19A RCW and which requires cities or
8 counties to adopt a compost procurement ordinance. King County has a
9 goal to achieve zero waste of resources by 2030, in accordance with
10 K.C.C. 10.14.020, the Strategic Climate Action Plan, and the 2019
11 Comprehensive Solid Waste Management Plan. In 2019, organic material
12 comprised approximately thirty-five percent of what was sent to Cedar
13 Hills regional landfill.

14 Diverting organic material and supporting end markets for those products
15 is an essential part of reaching King County's zero waste of resources goal.
16 Besides reducing the amount of material going to the landfill, processing
17 organic material into compost and applying it to land improves soil health
18 and reduces greenhouse gas emissions.

19 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

Ordinance 19552

20 SECTION 1. Sections 2 through 6 of this ordinance should constitute a new
21 chapter in K.C.C. Title 18.

22 NEW SECTION. SECTION 2. For the purposes of this chapter, unless the
23 context clearly requires otherwise, "compost" means a product created with "composted
24 material" as defined in RCW 70A.205.015(3). "Compost" includes, but is not limited to,
25 one hundred percent finished compost or blends that include compost as a primary
26 ingredient. Mulch is "compost" if it contains a minimum of sixty percent composted
27 material. Bark is not "compost."

28 NEW SECTION. SECTION 3.

29 A. Before issuance of a solicitation for bids or proposals in accordance with
30 K.C.C. chapter 2.93, departments shall consider whether compost can be utilized in a
31 county project as required in RCW 43.19A.120. In the event that a department identifies
32 that compost can be utilized, that department shall purchase compost for use in the
33 county project.

34 B. Departments shall plan for the use of compost in any of the following
35 categories that are applicable to the departments' operations and project types:

- 36 1. Landscaping projects;
- 37 2. Construction and postconstruction soil amendments;
- 38 3. Applications to prevent erosion, filter stormwater runoff, promote vegetative
39 growth, or improve the stability and longevity of roadways in accordance with K.C.C.
40 Title 9; and
- 41 4. Low-impact development and green infrastructure either to filter pollutants or
42 to keep water onsite, or both, in accordance with K.C.C. Title 9.

43 C. Notwithstanding subsections A. and B. of this section, departments are not
44 required to use compost products if:

45 1. Compost products are not available within a reasonable time or distance from
46 the project;

47 2. Compost products that are available do not comply with existing purchasing
48 standards;

49 3. Compost products that are available do not comply with federal, state or local
50 health, quality and safety standards; or

51 4. Compost purchase prices are not reasonable or competitive.

52 D. Departments shall give priority to purchasing compost products from
53 companies that:

54 1. Produce compost products locally;

55 2. Are certified by the US Composting Council or an equivalent nationally
56 recognized organization; and

57 3. Produce compost products that are derived from municipal solid waste
58 compost programs and meet quality standards comparable to standards adopted by the
59 Washington state Department of Transportation or adopted by rule by the Washington
60 state Department of Ecology.

61 E. Departments that use compost shall report the following information to the
62 solid waste division by each December 15:

63 1. The volume and cost of compost purchased by the department in that year;

65 2. The source or sources of the compost purchased by the department in that
66 year.

67 NEW SECTION. SECTION 4. The solid waste division is responsible for:

68 A. Providing technical assistance and education regarding the use of compost to
69 King County departments and staff;

70 B. Conducting educational outreach to inform residents and businesses about the
71 value of compost and how King County uses compost in its operations each year; and

72 C. Reporting the total estimated tons of organic material diverted from the King
73 County waste stream because of compost use under this chapter.

74 NEW SECTION. SECTION 5. The solid waste division is responsible for
75 compiling and submitting the report required by RCW 43.19A.150 to the Washington
76 state Department of Ecology by December 31, 2024, and each December 31 of even-
77 numbered years thereafter, with the following information:

78 A. The total tons of organic material diverted from the King County waste stream
79 throughout the year;

80 B. The volume and cost of compost purchased in that reporting period by the
81 county; and

82 C. The source or sources of the compost purchased by the county under this
83 chapter in that reporting period.

84 NEW SECTION. SECTION 6. The finance and business operations division is
85 responsible for:

86 A. Collaborating with departments to utilize specifications for compost products
87 in the use of sourcing and executing contracts for compost products; and

- 88 B. Assisting the solid waste division in annual reporting by providing
- 89 information about compost contracts.

Ordinance 19552 was introduced on 10/4/2022 and passed by the Metropolitan King County Council on 12/6/2022, by the following vote:



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

How to contact King County-Department of 02:

You may contact us to let us know of your changes as to how we may contact you electronically, to request paper copies of certain information from us, and to withdraw your prior consent to receive notices and disclosures electronically as follows:

We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from King County-Department of 02

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with King County-Department of 02

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to cipriano.dacanay@kingcounty.gov and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..

Required hardware and software
