1 AN ORDINANCE that adopts the 2026-2027 Biennial
2 Budget and makes appropriations for the operation of
3 county agencies and departments and capital improvements
4 for the fiscal biennium beginning January 1, 2026, and
5 ending December 31, 2027; and establishing an effective
6 date.

7 STATEMENT OF FACTS:

- 8 1. To the extent that the executive considers any proviso or expenditure
9 restriction included in the 2026-2027 biennial budget to be unduly
10 burdensome, the executive should notify the council as soon as possible if
11 the executive anticipates any difficulty in responding to proviso or
12 expenditure restriction direction in the budget and is encouraged to
13 transmit a supplemental budget in the first quarter of 2026 proposing
14 revisions to the content, deadlines, and restricted amounts.
- 15 2. It is the council's assumption that various new full time equivalent and
16 term limited temporary positions paid for by the general fund or general
17 fund overhead in the following appropriation units will be hired on July 1,
18 2026: adult and juvenile detention; jail health services; judicial
19 administration; superior court; prosecuting attorney; county auditor; office
20 of performance, strategy, and budget; office of emergency management;

21 and human resources. Should the executive or a separately elected official
22 determine a business need exists to hire those positions sooner than July 1,
23 2026, the executive or separately elected official may do so and request
24 any additional funding necessary in a future supplemental budget.

25 3. In 2024, the Washington State Bar Association ("the WSBA") Board of
26 Governors adopted revised standards for indigent defense services ("the
27 WSBA Revised Standards") and recommended that the Washington state
28 Supreme Court ("the Supreme Court") incorporate the WSBA Revised
29 Standards into the court rules governing indigent defense standards. On
30 June 9, 2025, the Supreme Court issued interim order In re Standards for
31 Indigent Defense Implementation of CrR 3.1, CrRLJ 3.1, and JuCR 9.2,
32 Ord. No. 25700-A-1644, adopting new attorney caseload standards for
33 indigent defense effective January 1, 2026, and requiring full
34 implementation no later than January 1, 2036, upon meeting certain
35 conditions. RCW 10.101.030 requires a county to adopt standards for the
36 delivery of public defense services and states that the standards endorsed
37 by the WSBA for the provision of public defense services should serve as
38 guidelines to local legislative authorities in adopting standards.

39 4. The 2026-2027 biennial budget is predicated on implementing the
40 Supreme Court's interim order regarding attorney caseload standards and
41 to achieve the caseload standards in accordance with the conditions and
42 timeline set forth in the interim order, continuing to use a case-weight

43 credit policy, and following Phase 1 of Standard 3.O. in the WSBA
44 Revised Standards.

45 5. It is the council's intent to review the county's standards for the delivery
46 of public defense services. It is also the council's intent for the county to
47 work with the state to address the adequacy of state funding for public
48 defense services.

49 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

50 **SECTION 1. Findings:**

51 A. The qualified electors of King County elected a new person to hold the office
52 of King County executive in the November 4, 2025, election. While it is the intent of the
53 council to approve the appropriation and FTE authority, including the appropriation
54 authority to support two term-limited temporary positions ("TLT positions"), for the
55 office of the executive, it is also the intent of the council to be clear the newly elected
56 King County executive may utilize the approved appropriation and FTE authority,
57 including the appropriation authority to support two TLT positions, as the newly elected
58 King County executive sees fits to advance the policies and priorities of the new
59 administration; however, the newly elected King County executive should not use the
60 appropriation and FTE authority for the office of the executive to advance any policy or
61 program that is inconsistent with the council's intent passed in Motion 16654.

62 B. Further, the council has approved appropriation authority to support a new
63 executive internal audit function to enhance accountability and oversight of executive
64 branch operations with the expectation that the newly elected King County executive will

65 determine where to house the function organizationally and transmit any legislation
66 necessary to effectuate such determination.

67 C. If the executive determines that the general fund beginning balance as of
68 January 1, 2026, is greater than projected in the financial plan transmitted with the
69 proposed 2026-27 biennial budget, the council directs the executive to transmit a
70 supplemental appropriations ordinance that allocates up to \$3 million dollars in general
71 fund underspend towards increased rental assistance funding for United Way of King
72 County. The council recognizes that the Seattle and King County region received
73 approximately \$67 million in federal Department of Housing and Urban Development
74 Continuum of Care funds from the Department of Housing and Urban Development's
75 competitive 2024 Continuum of Care Notice of Funding Opportunity. That funding
76 supports housing and essential services for more than 4,400 Seattle and King County
77 residents who are or were previously homeless. The 2025 Continuum of Care Notice of
78 Funding Opportunity limits the amount of funding for permanent housing to thirty
79 percent, resulting in the likely loss or reduction of Continuum of Care funding to Seattle
80 and King County for the fiscal biennium, putting housing and services for thousands of
81 people in King County at risk. Between Seattle, King County, and the King County
82 Regional Homelessness Authority, a contingency fund of at least \$36 million has been
83 identified as needed to sustain homes and supportive services that are immediately at risk.
84 Additional funding might be necessary if Department of Housing and Urban
85 Development makes more drastic reductions or limitations on Continuum of Care
86 funding. Following review of the impact that the 2025 Continuum of Care Notice of
87 Funding Opportunity release has on the Seattle and King County region, the council

88 requests the executive to transmit a supplemental appropriations ordinance to create
89 contingency moneys of available resources, to be paired with funding in partnership from
90 the City of Seattle, for a regional Continuum of Care contingency plan by March 16,
91 2026. The Continuum of Care contingency moneys should look at any available
92 additional revenue, available reserves, and any available general fund underspend from
93 the 2025 Annual Budget.

94 D. The 2026-2031 Parks Levy, Ordinance 19922, submitted to the qualified
95 electors of King County, was approved by the qualified electors of King County in the
96 August 5, 2025, election. Ordinance 19922, Section 5.F., directs that at least thirty
97 million dollars of levy proceeds be used for the healthy communities and parks grants
98 program. The council finds that, in addition to at least thirty million dollars being used
99 for the competitive portion of the grant program, an additional five million dollars of levy
100 proceeds shall be allocated to the healthy communities and parks grants program, to be
101 awarded to eligible entities as councilmanic climate resilience grants.

102 E. The council finds value in promoting arts and culture associated with local
103 production of music, digital, television, video, and film ("local production") and the
104 county expects to benefit from opportunities for increased training for local production
105 and other creative economy professionals, who in turn will contribute to building a
106 vibrant local production presence in the county. The council finds that the report
107 required in section 20, Proviso P1, of this ordinance will inform the council's
108 determination regarding ongoing support of the Harbor Island Studio, acknowledging
109 operations and maintenance support will end on or about June 30, 2026.

110 SECTION 2. The 2026-2027 Biennial Budget is adopted and, subject to the
 111 provisions hereinafter set forth and the several amounts hereinafter specified or so much
 112 thereof as shall be sufficient to accomplish the purposes designated, appropriations are
 113 hereby authorized to be distributed for salaries, wages and other expenses of the various
 114 agencies and departments of King County, for capital improvements and for other
 115 specified purposes for the fiscal biennium beginning January 1, 2026, and ending
 116 December 31, 2027, out of the funds of the county hereinafter named and set forth in the
 117 following sections.

118 SECTION 3. The fund appropriations are sums to cover merit pay and labor
 119 settlements. The county executive is authorized to distribute the required portions of
 120 these moneys among the affected positions in each operating fund beginning January 1,
 121 2026.

122 SECTION 4. Notwithstanding sections 2 and 3 of this ordinance, section 132 of
 123 this ordinance takes effect ten days after the executive's approval of this ordinance, as
 124 provided in the King County Charter.

125 SECTION 5. The definition in this section applies throughout this ordinance
 126 unless the context clearly requires otherwise.

127 "FTEs" means full-time equivalents.

157 general fund there is hereby appropriated to:

158 Office of law enforcement oversight \$6,793,000

159 The maximum number of FTEs for office of law enforcement oversight shall be: 14.0

160 SECTION 14. OFFICE OF ECONOMIC AND FINANCIAL ANALYSIS -
161 From the general fund there is hereby appropriated to:

162 Office of economic and financial analysis \$1,332,000

163 The maximum number of FTEs for office of economic and financial analysis shall be: 2.5

164 SECTION 15. COUNTY EXECUTIVE - From the general fund there is hereby
165 appropriated to:

166 County executive \$775,000

167 The maximum number of FTEs for county executive shall be: 1.0

168 SECTION 16. OFFICE OF THE EXECUTIVE - From the general fund there is
169 hereby appropriated to:

170 Office of the executive \$16,311,000

171 The maximum number of FTEs for office of the executive shall be: 21.0

172 SECTION 17. OFFICE OF PERFORMANCE, STRATEGY, AND BUDGET -
173 From the general fund there is hereby appropriated to:

174 Office of performance, strategy, and budget \$37,459,000

175 The maximum number of FTEs for office of performance, strategy, and
176 budget shall be: 72.3

177 P1 PROVIDED THAT:

178 Of this appropriation, \$750,000 shall not be expended or encumbered until the
179 executive transmits a permitting division permit funding and staffing model report and a
180 motion that should approve the report, and a motion approving the report is passed by the
181 council. The motion should reference the subject matter, the proviso's ordinance,
182 ordinance section, and proviso number in both the title and body of the motion.

183 The report shall include, but not be limited to:

184 A. A description of the existing funding model for permitting functions of the
185 permitting division of the department of local services, including:

186 1. A breakdown of the costs and revenue sources of the permitting functions, by
187 line of business that includes costs for overhead, staffing, permitting software, and other
188 administrative costs; and

189 2. A description of the financial position of the planning and permitting
190 appropriation unit, including a history of the ending fund balances, cost recovery, fee
191 increases, and efforts to increase efficiency;

192 B. A description of the current staffing model for the permitting functions, by
193 lines of business, including how the staff is organized, the approach to staffing permits
194 such as by project permit or complexity, how the division determines staffing levels for
195 this function, use of on-call consultants by discipline, how the division determines what
196 project permit applications are sent to on-call consultants, and how the division uses the
197 managed accounts team;

198 C. A description of the permit review process from preapplication and intake
199 through monitoring, including:

200 1. An inventory of the types and volumes of each project permit type the

201 permitting division reviews; a breakdown of the project types that are issued over the
202 counter or subject to field inspection, those that require review only by one discipline,
203 and those that require review by multiple disciplines in the division; and a description of
204 the permit application types that are submitted in person, rather through the online
205 application portal; and

206 2. A description of the number and discipline of the staff involved, for each land
207 use decision type in K.C.C. 20.20.020, at each part of the review process, including
208 preapplication conferences, application intake, application screening, application review
209 and approval, permit issuance, inspection, close out, and performance monitoring;

210 D. A comparative analysis of staffing and funding methods, including, to the
211 extent possible, information required by subsections A., B., and C. of this proviso, for
212 permitting functions, using at least three other jurisdictions. Jurisdictions shall be
213 identified and selected for comparison in collaboration and consultation with
214 councilmember offices representing unincorporated areas, and shall have similar permit
215 volumes to King County, and may also share some operational, land use, or demographic
216 similarities to King County. At least one jurisdiction shall use a funding method other
217 than full cost recovery from permit fees. The comparative analysis shall include any
218 information gathered from the other jurisdictions on whether they expedite review of
219 affordable housing projects or lower or waive permit fees to further market rate and
220 affordable housing development;

221 E. An analysis of whether the permitting division funding and staffing models
222 should be modified, based on the information collected in subsections A., B., C., and D.
223 of this proviso; and

224 F.1. Recommendations, if any, for changes to permit fees, the code, cost
225 allocations, organizational structure as a result of the analysis completed in subsection E.
226 of this proviso. The recommendations should meet certain goals which include, but are
227 not limited to: getting to positive fund balance within two biennia, complying with permit
228 review requirements in K.C.C. chapter 20.20 and chapter 36.70B RCW, and maintain
229 permit fees to encourage property owners to obtain permits. If the comparative analysis
230 required in subsection D. of this proviso includes information on ways to expedite
231 affordable housing permit review or fee waivers or reductions for housing development,
232 then the report shall also provide recommendations on ways to lower fees, through
233 waivers or reductions, for housing development in King County.

234 2. If recommendations are not proposed, then a plan to get to a positive ending
235 undesignated fund balance within two biennia shall be included.

236 The executive should electronically file the report, a motion required by this
237 proviso, a proposed ordinance to implement permit fees for 2027, and any proposed
238 ordinance or proposed ordinances required to implement the recommendations in the
239 proviso, by October 1, 2026, with the clerk of the council, who shall retain an electronic
240 copy and provide an electronic copy to all councilmembers, the council chief of staff, and
241 the lead staff for the local services and land use committee or its successor.

242 P2 PROVIDED FURTHER THAT:

243 Moneys restricted by section 60, Expenditure Restriction ER1 and section 90,
244 Expenditure Restriction ER1, of this ordinance shall not be expended or encumbered
245 until the executive transmits a legal services study for the civil division in the prosecuting
246 attorney's office and a motion that should approve the study, and a motion approving the

study is passed by the council. The motion should reference the subject matter, the proviso's ordinance, ordinance section, and proviso number in both the title and body of the motion.

The study shall include, but not be limited to, analyzing: the legal needs of client departments against current civil division capacity, how legal services are provided in other jurisdictions of similar size and scope, and when general counsels for individual departments provide more value or are necessary for the legal needs of client departments.

The executive should electronically file the study and a motion required by this proviso by October 1, 2026, with the clerk of the council, who shall retain an electronic copy and provide an electronic copy to all councilmembers, the council chief of staff, and the lead staff for the budget and fiscal management committee or its successor.

P3 PROVIDED FURTHER THAT:

Of this appropriation, \$500,000 shall not be expended or encumbered until the executive transmits a report analyzing the department of community and human services inflation rate adjustment policy for human services contracts dated September 1, 2024, which is anticipated to increase human services contract costs in 2026 and 2027, and a motion that should acknowledge receipt of the report, and a motion acknowledging receipt of the report is passed by the council. The motion should reference the subject matter, the proviso's ordinance, ordinance section, and proviso number in both the title and body of the motion. The report shall include, but not be limited to:

A. A description of how the policy was determined to be feasible to apply to each local human service revenue source including the veterans, seniors, and human services

270 levy, Best Starts for Kids levy, the crisis care center levy, and any other local revenue
271 source originating from a voter-approved levy or councilmanic tax;

272 B. An analysis of the financial compatibility of the inflation rate adjustment
273 policy for each revenue source identified in subsection A. of this proviso, and an analysis
274 of the long-term effects of this policy on each fund over each biennium from 2028
275 through 2033;

276 C. An exploration of how this policy could result in expenditures outpacing tax
277 revenues and whether an inflation rate adjustment policy creates a structural gap for the
278 funds for each revenue source identified in subsection A. of this proviso; and

279 D. Proposed mitigation strategies to address a possible structural gap, which may
280 include, but not be limited to, policies to:

281 1. Forgo program expansion to maintain inflation rate adjustment for existing
282 programs;

283 2. Institute a cap on inflation rate adjustments for locally funded programs and
284 services;

285 3. Establish a process through which possible cuts to programs and services are
286 made, including a description of the role of each fund's advisory committee in this
287 process; and

288 4. Prohibit or otherwise deem this policy incompatible with requirements of
289 each fund source.

290 The report should include different sections for each revenue source to clearly
291 explain the impacts on each individual revenue source. The report on the department of
292 community and human services inflation rate adjustment policy for human services

293 contracts should reference the subject matter, the proviso's ordinance, ordinance section,
294 and proviso number in both the title and body of the motion.

295 The executive should electronically file the report and a motion required by this
296 proviso by December 31, 2026, with the clerk of the council, who shall retain an
297 electronic copy and provide an electronic copy to all councilmembers, the council chief
298 of staff, and the lead staff for the budget and fiscal management committee or its
299 successor.

300 P4 PROVIDED FURTHER THAT:

301 Of this appropriation, \$100,000 shall not be expended or encumbered until the
302 executive transmits a county surveillance technology report.

303 The report shall include, but not be limited to:

304 A. A list of all surveillance technology currently in use by all county agencies
305 and departments;

306 B. A list of all the types of surveillance data currently collected, received, or
307 shared by all county agencies and departments, including but not limited to, demographic
308 data, protected classes as defined in K.C.C. chapter 3.12D, language proficiency, housing
309 status, financial status, citizenship, immigration status, or national origin;

310 C. A list of all third-party vendors providing surveillance services on behalf of
311 the county and a brief description of county agreements with those third-party vendors,
312 including the ownership, storage, and use of any data collected; and

313 D. A brief description of the intended purpose and operational use of any
314 surveillance technology currently being utilized by county agencies and departments and
315 by third-party vendors on behalf of the county, and any surveillance data collected,

316 received, or shared by county agencies and departments and by third-party vendors on
317 behalf of the county.

318 For the purpose of the report, "surveillance technology" means any electronic
319 surveillance device, hardware, or software that is capable of collecting, capturing,
320 recording, retaining, processing, intercepting, analyzing, monitoring, or sharing audio,
321 visual, digital, location, thermal, biometric, behavioral, or similar information or
322 communications specifically associated with, or capable of being associated with, any
323 specific individual or group; or any system, device, or vehicle that is equipped with an
324 electronic surveillance device, hardware, or software. "surveillance technology" includes,
325 but is not limited to: international mobile subscriber identity (IMSI) catchers and other
326 cell site simulators; automatic license plate readers; electronic toll readers; closed-circuit
327 television cameras; biometric surveillance technology, including facial, voice, iris, and
328 gait-recognition software and databases; mobile DNA capture technology; gunshot
329 detection and location hardware and services; x-ray vans; video and audio monitoring
330 technology, recording technology, or monitor and recording technology, such as
331 surveillance cameras, wide-angle cameras, and wearable body cameras; surveillance
332 enabled or capable lightbulbs or light fixtures; tools, including software and hardware,
333 used to gain unauthorized access to a computer, computer service, or computer network;
334 social media monitoring software; through-the-wall radar or similar imaging technology,
335 passive scanners of radio networks, long-range Bluetooth and other wireless-scanning
336 devices, radio-frequency I.D. (RFID) scanners, and software designed to integrate or
337 analyze data from surveillance technology, including surveillance target tracking and
338 predictive policing software.

339 The executive should electronically file the report required by this proviso no later
340 than April 1, 2026, with the clerk of the council, who shall retain an electronic copy and
341 provide an electronic copy to all councilmembers, the council chief of staff and the lead
342 staff for law and justice committee or its successor.

343 P5 PROVIDED FURTHER THAT:

344 Of this appropriation, \$100,000 shall not be expended or encumbered until the
345 executive transmits a report on root causes of recent evictions throughout King County
346 and a motion that should acknowledge receipt of the report, and a motion acknowledging
347 receipt of the report is passed by the council. The motion should reference the subject
348 matter, the proviso's ordinance, ordinance section, and proviso number in both the title
349 and body of the motion.

350 The report shall include, but not be limited to:

351 A. An analysis of the root causes leading to evictions in King County, focusing
352 on 2023 through 2025, if data is available;

353 B. A trend analysis of the rental market and evictions in King County, indicating
354 if root causes have changed over time or if there are emerging issues; and

355 C. Recommendations for King County to implement new or expand existing
356 programs to address the factors causing evictions and support successful tenancies.

357 The report shall be prepared in collaboration with relevant stakeholders,
358 including, but not limited to, tenant advocates, civil legal aid, housing providers, and
359 landlord groups.

360 The executive should electronically file the report and a motion required by this
361 proviso by December 31, 2026, with the clerk of the council, who shall retain an

electronic copy and provide an electronic copy to all councilmembers, the council chief of staff, and the lead staff for the health, housing, and human services committee or its successor.

P6 PROVIDED FURTHER THAT:

Of this appropriation, \$50,000 shall not be expended or encumbered until the executive transmits a proposal for implementation on the property tax exemption for accessory dwelling units rented to low-income households as authorized in RCW 84.36.400(2).

The proposal for implementation shall be conducted in consultation with the assessor's office and the cities of King County and shall include, but not be limited to:

- A. An estimation of the number of accessory dwelling units in King County which may be eligible for exemption;
- B. An analysis of the value of the property tax exemption for several hypothetical accessory dwelling units of differing sizes and assessed values;
- C. An estimation of how many units of housing could be created, or existing accessory dwelling units enrolled, if King County were to implement the property tax exemption authorized in RCW 84.36.400(2);
- D. A description of the administrative resources and an estimation of the associated costs to implement the property tax exemption program authorized in RCW 84.36.400(2), including options that allow cities to pay implementation costs for the program to proceed within their jurisdiction if King County is unable to fund the program; and

384 E. Estimated impact to the county's revenue collection under the various
385 scenarios considered.

386 The executive should electronically file the proposal by June 30, 2026, with the
387 clerk of the council, who shall retain an electronic copy and provide an electronic copy to
388 all councilmembers, the council chief of staff, and the lead staff for the budget and fiscal
389 management committee or its successor.

390 P7 PROVIDED FURTHER THAT:

391 Of this appropriation, \$250,000 shall not be expended or encumbered until the
392 executive transmits a victim support service improvement plan and a motion that should
393 acknowledge receipt of the plan, and a motion acknowledging receipt of the plan is
394 passed by the council. The motion should reference the subject matter, the proviso's
395 ordinance, ordinance section, and proviso number in both the title and body of the
396 motion.

397 A. The plan shall include, but not be limited to:

398 1. An inventory of services provided and funded by King County agencies that
399 are available to survivors of violence and victims of crime and their families, as well as
400 an inventory of such services provided by contracted services providers;

401 2. Evaluation of best practices, current gaps in the system, and the most
402 prevalent needs of survivors, victims, and their families; and

403 3. A plan to expand and improve services for victims of crime and survivors of
404 violence and their families, including the people themselves or family members of people
405 who have been harmed in interactions with law enforcement.

406 B. The plan should be developed in collaboration with community service
407 providers, those who have or may use such services, and collaboration across criminal
408 legal system agencies.

409 The executive should electronically file the plan and a motion required by this
410 proviso by June 30, 2026, with the clerk of the council, who shall retain an electronic
411 copy and provide an electronic copy to all councilmembers, the council chief of staff, and
412 the lead staff for the law and justice committee or its successor.

413 P8 PROVIDED FURTHER THAT:

414 Of this appropriation, \$100,000 shall not be expended or encumbered until the
415 executive transmits a plan to establish a Harborview Medical Center long-range planning
416 committee as described at Section 6.2 of the hospital services agreement and a motion
417 that should acknowledge receipt of the plan, and a motion acknowledging receipt of the
418 plan is passed by the council. The motion should reference the subject matter, the
419 proviso's ordinance, ordinance section, and proviso number in both the title and body of
420 the motion.

421 The plan shall include, but not be limited to:

422 A. The names of appointed committee members representing the county
423 executive, the county council, the Harborview Medical Center board of trustees and UW
424 Medicine;

425 B. A description of how the committee will facilitate long-range planning and
426 coordination in pursuit of opportunities to respond to the evolving healthcare industry,
427 improve population health, and have Harborview Medical Center become the provider of
428 choice for county and state residents;

429 C. A description of shared goals, clear criteria for when the committee has
430 completed its charge, and clear criteria for when a subsequent committee should be
431 constituted, established by the committee;

432 D. A description of committee processes which will ensure the governance
433 structures, accountabilities, and collective bargaining commitments of each committee
434 member's respective organization will be respected; and

435 E. The frequency in which the committee shall meet in order to facilitate strong
436 coordination and the identification and monitoring of the goals established among
437 committee members. The committee should recommend the length of time that the
438 committee shall meet.

439 The executive should electronically file the plan and a motion required by this
440 proviso by June 1, 2026, with the clerk of the council, who shall retain an electronic copy
441 and provide an electronic copy to all councilmembers, the council chief of staff, and the

1410 the requirements of the fund source due to the volatile nature of sales tax revenue;

1411 B. An analysis regarding the effect of the inflation rate adjustment policy on the
1412 mental illness and drug dependency fund, which is projecting an average future growth
1413 rate for mental illness and drug dependency of 2.7 percent per year according to 2025
1414 data from King County's office of economic and financial analysis;

1415 C. An exploration of how the inflation rate adjustment policy could result in
1416 expenditures outpacing sales tax revenues and whether inflation rate adjustment policy
1417 creates a structural gap for the mental illness and drug dependency fund; and

1418 D. Proposed mitigation strategies to address a possible structural gap due to the
1419 inflation rate adjustment policy which may include, but not be limited to, policies to:

1420 1. Forgo program expansion to maintain inflation rate adjustment for existing
1421 programs;

1422 2. Institute a cap on the inflation rate adjustment policy for mental illness and
1423 drug dependency sales tax funded programs and services;

1424 3. Establish a process through which possible cuts to programs and services are
1425 made, including a description of the role of the mental illness and drug dependency

1427 4. Prohibit or otherwise deem the inflation rate adjustment policy as
1428 incompatible with requirements of the mental illness and drug dependency fund as
1429 allowed by section 3.0 of the inflation rate adjustment policy.

1430 The mental illness and drug dependency sales tax implementation plan should
1431 reference the subject matter, the proviso's ordinance, ordinance section, and proviso
1432 number in both the title and body of the ordinance.

1433 The executive should electronically file the mental illness and drug dependency
1434 sales tax implementation plan and an ordinance required by this proviso by July 1, 2026,
1435 with the clerk of the council, who shall retain an electronic copy and provide an
1436 electronic copy to all councilmembers, the council chief of staff, and the lead staff for the
1437 committee of the whole or its successor.

3194 passed by the council. The motion should reference the subject matter, the proviso's

3198 A. Development of an economically progressive rental rate and lease-term
3199 schedule, to be reviewed and approved by the King County council for airport tenants,

3243 how those partnerships have contributed to both educational opportunities for the
3244 community and aviation and aerospace career development pathways;

3436 Of this appropriation, \$1,485,416 shall be expended or encumbered solely to
3437 support a pilot of a downtown Seattle shuttle service during the summer months of 2026.

3438 ER2 EXPENDITURE RESTRICTION:

3439 Of this appropriation, \$1,068,096 shall be expended or encumbered solely to
3440 support a pilot of a downtown Seattle shuttle service during the summer months of 2027.

3441 ER3 EXPENDITURE RESTRICTION:

3442 Of this appropriation, \$1,000,000 shall be expended or encumbered solely to
3443 continue to operate the Juanita Metro Flex pilot, using the same boundaries and service
3444 profile provided as of October 1, 2025, or with adjustments to the boundaries, which in
3445 no event shall exclude the Kenmore Park and Ride, or service profile if engagement
3446 between the Metro transit department and local jurisdictional partners results in

3455 Of this appropriation, \$300,000 and 1.0 FTE shall be expended or encumbered
3456 solely for the purpose of supporting a full-time employee for a regional issues coordinator
3457 position at the Metro transit department. The regional issues coordinator position shall be
3458 responsible for coordinating the work of the Metro transit department on regional issues,
3459 including, but not limited, to: implementing the recommendations of the regional fare
3460 forum; planning for and implementing transit service during the 2026 FIFA World Cup
3461 events; coordinating with Sound Transit, the Seattle department of transportation, Sound
3462 Cities Association, and other municipal partners; and implementing the recommendations
3463 of the transit safety task force, including, but not limited to, advancing regional

3464 coordination through formal frameworks to align transit with outreach providers, housing
3465 and behavioral health services, and public safety partners, expanding nonenforcement
3466 outreach and diversion strategies to connect frequent riders in crisis to essential services

3468 response deployments, enhancing system safety and coordination by extending successful
3469 safety pilots and by improving data sharing and cross-system exclusion policies,
3470 embedding staff and rider feedback into ongoing safety planning, assessments, and rider
3471 education initiatives, and ensure interjurisdictional coordination related to transit safety
3472 task force recommendations.

3473 ER6 EXPENDITURE RESTRICTION:

3474 Of this appropriation, \$500,000 shall be expended or encumbered solely to procure
3475 consultant support to coordinate the implementation of the recommendations developed by
3476 the King County regional transit safety task force, including, but not limited to, convening
3477 and staffing a multijurisdictional implementation review group, assisting in the development
3478 and execution of deliverables, tracking milestones, developing reporting mechanisms, and
3479 engaging partner transit agencies and jurisdictions.

3480 ER7 EXPENDITURE RESTRICTION:

3481 Of this appropriation, up to \$2,400,000 to be expended or encumbered solely to
3482 contract with an entity to provide pre-booking diversion services, also referred to as law
3483 enforcement assisted diversion, to referrals received from the Metro transit police and the
3484 Metro transit department's behavioral health teams.

3485 ER8 EXPENDITURE RESTRICTION:

3486 Of this appropriation, \$50,000 shall be expended or encumbered solely for the
3487 human services agencies fare payment program established by K.C.C. 4A.700.210 to

3490 to assist low income residents in that agency's service area who need transit service for

3493 payment media for purchase at the sale price of ten percent of the cash, or face, value by
3494 Kent Food Bank and Emergency Services and making \$12,500 in total cash, or face,
3495 value transit fare payment media for purchase at the sale price of ten percent of the cash,
3496 or face, value by Neighbor to Neighbor, both to assist low income residents in those
3497 agencies' service areas who need transit service for grocery needs resulting from the
3498 unexpected closure of the Fred Meyer store at 10201 SE 240th Street in Kent.

3499 ER9 EXPENDITURE RESTRICTION:

3500 Of this appropriation, \$400,000 shall be expended or encumbered solely for
3501 regional crisis response agency ("RCR") services at Metro transit department stops within
3502 the RCR service area, such as providing support to people experiencing a behavioral
3503 health crisis, coordinating with law enforcement to determine the best type of response to
3504 a person in crisis, or transporting a person experiencing a behavioral health crisis to a
3505 crisis care center.

3506 ER10 EXPENDITURE RESTRICTION:

3507 Of this appropriation, \$50,000 shall be expended or encumbered solely to prepare
3508 a sea-to-ski transit options report, which shall be an operational planning peer review and
3509 feasibility study exploring alternatives to driving alone to Snoqualmie pass in the winter.

3511 Moneys restricted by Expenditure Restriction ER1 of this section shall not be
3512 expended or encumbered until the county has received a commitment for reimbursement
3513 from partners external to the county to provide no less than five hundred thousand dollars
3514 toward the downtown Seattle shuttle service.

3515 P2 PROVIDED FURTHER THAT:

3516 Moneys restricted by Expenditure Restriction ER2 of this section shall not be
3517 expended or encumbered until the county has received a commitment for reimbursement
3518 from partners external to the county to provide no less than \$640,000 towards the
3519 downtown Seattle shuttle service. The Metro transit department is encouraged to engage
3520 with potential funding partners, including, but not limited, to the Port of Seattle, the city
3521 of Seattle, and local businesses and organizations, to seek the reimbursement
3522 commitment to offer the downtown Seattle shuttle during the summer months of 2027.

3523 P3 PROVIDED FURTHER THAT:

3524 Of this appropriation, \$100,000 shall not be expended or encumbered until the
3525 executive transmits a future of RapidRide report and a motion that should acknowledge
3526 receipt of the report, and a motion acknowledging receipt of the report is passed by the
3527 council. The motion should reference the subject matter, the proviso's ordinance,
3528 ordinance section, and proviso number in both the title and body of the motion.

3529 A. Between 2010 and 2014, the Metro transit department opened six RapidRide
3530 bus rapid transit lines (routes A, B, C, D, E, and F), which included relatively modest
3531 capital investments for bus stations and speed and reliability improvements, averaging
3532 between eight and eighteen million dollars per route. The Metro Connects long-range
3533 plan, as adopted by Ordinance 18449 and updated by Ordinance 19367, called for a
3534 higher level of capital investments for future RapidRide lines. The RapidRide lines that
3535 have opened or are planned to open between 2023 and 2032, which are routes G, H, I, J,
3536 K, and R, have included more extensive capital investments, averaging between eighty
3537 and one hundred eighty million dollars per route. This higher level of capital investment
3538 has required more time, more outside funding, more interjurisdictional coordination and
3539 permitting, more environmental review, and more property acquisition than the first six
3540 RapidRide lines. As the executive prepares to transmit an update to the Metro Connects
3541 long-range plan in 2028, as required by Ordinance 19367, it is appropriate to include in
3542 the planning for that update an analysis of the future of RapidRide and how RapidRide
3543 and other very frequent bus service can most effectively be incorporated into the transit
3544 networks proposed for the future using a service-led planning approach that focuses on
3545 planning capital improvements to support service goals, with the aim of making travel
3546 faster, more coordinated, and more convenient for passengers.

3547 B. The future of RapidRide report required by this proviso shall include, but not
3548 be limited to:

3549 1. An update on the implementation of Metro Connects, as adopted by
3550 Ordinance 19367, including progress toward the interim network for transit service
3551 identified in the Metro Connects plan;

3552 2. An update on the planned opening dates, total capital cost estimates, and
3553 planned capital investments for the RapidRide K and R lines, including a description for
3554 each line's planned reductions in the project scope and the corresponding reduction in
3555 project budget, comparing the adopted 2025 capital improvement program set forth in
3556 Attachment A to Ordinance 19861 and specifically in fund 3641, project numbers
3557 1134292 for the K line and 1132326 for the R line, to the executive's proposed capital
3558 improvement program set forth in Attachment A to this ordinance;

3559 3. An analysis of potential changes to the transit priority model currently used
3560 by the Metro transit department to identify opportunities to use a service-led planning
3561 approach that would prioritize capital investments in RapidRide or other very frequent
3562 service based on their ability to enhance speed, coordination, and convenience for a broad
3563 range of passengers, and to evaluate how targeted infrastructure improvements
3564 implemented systemwide could support fast, frequent, and reliable service without
3565 requiring full-scale corridor redevelopment, and to quantify the potential time and budget
3566 savings that could be achieved by implementing a more flexible, service-driven
3567 investment strategy; and

3568 4. A proposal for the development of RapidRide and other very frequent service
3569 between 2033 and 2050, based on the prioritized tiers of candidate RapidRide lines
3570 identified in the RapidRide prioritization plan accepted by Motion 16659, and within the
3571 context of how a flexible, service-led approach to transit network planning could inform
3572 the 2028 update to the Metro Connects long-range plan.

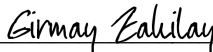

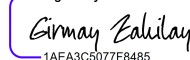

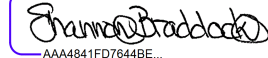

Getting paper copies
