## ordinance no. \_\_ 00274

WHEREAS, the City of Issaquah by Resolution No. 1003, has determined that the best interests and general welfare of Issaquah would be served by this annexation of unincorporated territory contiguous thereto as described in said Resolution No. 1003; and

WHEREAS, said resolution further satisfies the provisions of RCW 35.13.015 and prays that the King County Council call for an election to be held among the qualified voters therein upon the question of annexation; and

WHEREAS, said resolution further provides that upon approval of annexation by the electorate of the area described hereinafter, the City will thereby simultaneously adopt the Comprehensive Plan presently on file with the City Clerk concerning such area.

WHEREAS, said Notice of Intention to Annex has previously been deemed approved by the Boundary Review Board, and

WHEREAS, the King County Council fixed the 15th day of December, 1969 as the date of hearing on said proposed annexation and notice was published, in accordance with the law; and

WHEREAS, said hearing was held and all persons present were afforded an opportunity to be heard upon said petition; now, therefore,

BE IT ORDAINED BY THE KING COUNTY COUNCIL of King County, Washington, as follows:

- 1. That a special election be held on the 10th day of February, 1970, within the territory of said proposed annexation as hereinafter described, between the hours of 8:00 A.M. and 8:00 P.M. for the purpose of submitting to the qualified electors residing within the district the propositions of annexing said territory and the proposition of Assumption of Indebtedness to the City of Issaquah.
- 2. That the boundaries of territory proposed to be annexed to the City of Issaquah be and the same are hereby described in said Resolution No. 1003 as follows:

A portion of Section 28, Township 24 N. Range 6 East W.M. described as follows: beginning at the South 1/4 corner of said section; thence northerly along the northsouth centerline of said section to the east-west centerline of the south half of said section; thence westerly along said centerline to the north-south centerline of the west half of said section; thence northerly along said centerline to a point 50 feet southerly from northeast corner of the southwest 1/4 of the northwest 1/4 of said section; thence east to the northerly margin of the Issaquah Newport Road; thence southerly along said margin to a point 380 feet south of the north line of the southeast 1/4 of the northwest 1/4 of said section; thence easterly along said line to the west line of the east 1/2 of the east 1/2 of the northwest 1/4; thence easterly to a point that is 380 feet south and 600 feet west of the northeast corner of the southeast 1/4 of the northwest 1/4 of said section; thence northerly 380 feetto the north line of the southeast 1/4 of the northwest 1/4; thence easterly to the northeast corner of the southeast 1/4 of the northwest 1/4; thence south 80 feet; thence easterly along a line parallel to and south of the north line of the southwest 1/4 of the northeast 1/4 of said section a distance of 385.68 feet; thence south to the south line of Northwest Juniper Street; thence easterly to the centerline of Issaquah Creek; thence southerly along the centerline of Issaquah Creek to the south line of Northwest Dogwood Street; thence westerly along the south line of Northwest Dogwood Street to a point 110 feet east of the west line of the southeast 1/4 of the southeast 1/4 of said section; thence S. 1049'47" W. to the centerline of Issaquah Creek; thence southerly along the centerline of Issaquah Creek to the south line of said section; thence westerly along the south line of said section to the point of beginning.

3. That in submitting said propositions to the voters for their approval or rejection, said propositions shall be expressed on the ballot in the following terms:

For Annexation to the City of Issaquah Against Annexation to the City of Issaquah

For Assumption of Indebtedness Against Assumption of Indebtedness

4. That the notices of said election shall be published as required by law.
