

ORDINANCE NO. 00356, KING COUNTY TRAFFIC CODENO. 70-21

WHEREAS, by R.C.W. 46.61.415 the King County Council has the authority to establish speed limits on county roads outside any incorporated city or town, and,

WHEREAS, by virtue of King County Resolution No. 36096, King County passed a comprehensive traffic code, and,

WHEREAS, certain speed limits set forth in Schedules 1 through 5 should be changed, and,

NOW, THEREFORE, be it ordained that pursuant to traffic engineering studies, Schedule 3 setting maximum speed limit at 35 miles per hour should be and hereby is amended to add the following streets.

AUBURN-BLACK DIAMOND ROAD, between Auburn City Limits and east-west centerline of Section 16, Township 21, Range 5 East, W. M.

BUTTLES ROAD, between S.R. 522 and Northeast 180th Street.

COUGAR MOUNTAIN ROAD, between Newcastle-Coal Creek Road and Southeast 60th Street.

EAST SAMMAMISH ROAD NORTHEAST, between S.R. 522 and a point 670' north of 187th Avenue Northeast.

FISH HATCHERY ROAD, between S.R. 522 and 372nd Avenue Southeast.

MILITARY ROAD, between Des Moines Way South and Pacific Highway South.

MILITARY ROAD, between South 160th Street and South 192nd Street.

OLD CASCADE HIGHWAY, between U. S. 2 in Section 21, Township 26, Range 11 East, W. M. and Skykomish City Limits.

OLD CASCADE HIGHWAY, between Skykomish City Limits and U. S. 2 in Section 25, Township 26, Range 11 East, W. M.

OLD REDMOND ROAD, (Northeast 70th Street) between 116th Avenue Northeast and Redmond City Limits at 136th Avenue Northeast.

OLD REDMOND ROAD, between Redmond City Limits at 140th Avenue Northeast and Redmond City Limits at approximately 143rd Avenue Northeast.

RENTON-THREE TREE POINT ROAD, (Old S.R. 518) between approximately 28th Avenue South and Tukwila City Limits.

STILLWATER-CHERRY GARDEN ROAD, between S.R. 203 in Section 24, Township 26, Range 6 East, W. M. and Kelly Road.

1ST AVENUE SOUTH CONNECTION, (South 174th Street) between Ambaum Boulevard and 1st Avenue South (S.R. 509).

25TH AVENUE NORTHEAST, between S.R. 104 and Northeast 205th Street.

56TH AVENUE SOUTH, between South 316th Street and South 331st Street.

SOUTHEAST 60TH STREET, between 112th Avenue Southeast (Lake Washington Boulevard Southeast) and 119th Avenue Southeast.

61ST AVENUE NORTHEAST, between S.R. 522 and 61st Place Northeast at Northeast 197th Street.

61ST PLACE NORTHEAST, between 61st Avenue Northeast at approximately Northeast 197th Street and Snohomish County Line.

62ND AVENUE NORTHEAST, between Northeast 202nd Street and 61st Place Northeast.

64TH AVENUE SOUTH, between South 124th Street and South 128th Street.

SOUTHEAST 66TH STREET, between S.R. 522 and Mill Pond Road.

78TH AVENUE SOUTH, between South 258th Street and South 277th Street.

79TH AVENUE SOUTH, between South 258th Street and South 265th Street.

80TH AVENUE SOUTH, between South 277th Street and Auburn City Limits.

SOUTH 115TH PLACE, between South 116th Street and U. S. 99.

116TH AVENUE SOUTHEAST, between Southeast 60th Street and Southeast 68th Street.

NORTHEAST 116TH STREET, between Redmond City Limits and 154th Place Northeast.

SOUTH 116TH STREET, between Des Moines Way South and South 115th Place.

SOUTH 118TH STREET, between Glendale Way and Des Moines Way South.

NORTHEAST 122ND STREET, between 162nd Place Northeast and 172nd Avenue Northeast.

NORTHEAST 122ND PLACE, between Juanita Drive and Northeast 123rd Street.

NORTH 147TH STREET, between Northeast 122nd Place and 84th Avenue Northeast.

NORTHEAST 124TH STREET, between S.R. 522 and 162nd Place Northeast.

154TH PLACE NORTHEAST, between S.R. 522 and Northeast 124th Street.

162ND PLACE NORTHEAST, between Northeast 124th Street and Northeast 122nd Street.

NORTHEAST 180TH STREET, between Buttles Road and Bothell City Limits.

NORTHEAST 205TH STREET, between 15th Avenue Northeast and 30th Avenue Northeast.

NORTHEAST 205TH STREET, between 130th Avenue Northeast and Pitt Site Road.

SOUTHWEST 228TH STREET, between Vashon Island Highway and 107th Avenue Southwest.

308TH AVENUE SOUTHEAST, between Southeast 87th Street and dead end.

SOUTHWEST 342ND STREET, between 35th Avenue Southwest and F. B. Hoyt Road.


SOUTH 344TH STREET, between S.R. 18 and 42nd Avenue South.

372ND AVENUE SOUTHEAST, between Fish Hatchery Road and S.R. 522.


BE IT FURTHER ORDAINED by the King County Council that the maximum safe speed at which vehicles of any character may be operated on the described roads is hereby fixed as described.
