### SUBJECT

A Proposed Motion to confirm the appointment of the following individuals to the Harborview Medical Center Board of Trustees:

- Laura Zaichkin, who resides in Council District 8, as the District 8 representative, for a partial term to expire on July 31, 2026<sup>1</sup>, and
- Richa Malik, who resides in Council District 9, as the District 7 representative, for a partial term to expire on July 31, 2026.<sup>2</sup>

### BACKGROUND

Harborview Medical Center (HMC) serves as the Level 1 trauma center in the four-state region of Washington, Alaska, Idaho, and Montana. Harborview prioritizes serving the non-English-speaking poor, the uninsured and underinsured, people who experience domestic violence and or sexual assault, incarcerated people in King County's jails, people with behavioral health illnesses, particularly those treated involuntarily, people with sexually transmitted diseases, and individuals who require specialized emergency care, trauma care, and severe burn care. HMC is owned by King County and operated by the University of Washington.

The hospital is governed by the 13-member Board of Trustees. The Board, as the representative authority of the County, is entrusted to oversee the provision of health care services to assure that the county's priorities are addressed, and high-quality health care is made available to County residents irrespective of their ability to pay. Board membership is comprised of one member from each Council district and four at-large members. Nominees are appointed by the King County Executive and confirmed by the Council by motion.<sup>3</sup> Appointments shall be deemed to have been made on the date the letter of appointment is filed with the Council Clerk; appointments are subject to confirmation or rejection by the Council.

In accordance with King County Code 2.42, an effort should be made to assure that diverse geographic, social, cultural, ethnic, racial and economic backgrounds and perspectives are considered for candidate appointments. Candidates should possess demonstrated leadership ability, and recognized experience in management or administration, planning, finance, health service delivery, consumer representation or institutional operation; and the ability to work cooperatively with others of diverse backgrounds and philosophies. During the two years prior to appointment, candidates must not have held a salaried position in County government or any organization that holds a contract with the Hospital. Further, King County Code requires that candidates not be employed in a managerial capacity by, or serve on the board of, a UW Medicine competitor.

## **APPOINTEE INFORMATION**

**Laura Zaichkin.** Ms. Zaichkin currently serves as the Director of Market Competition and Affordability for the Washington Health Benefit Exchange. According to her application materials, she has "more than a decade of passion for and experience in health reform and health systems transformation." Previously, she served as Deputy Chief Policy Officer for the state Health Care Authority and led health benefit purchasing strategy for the state's long-term home caregiving workforce.

**Richa Malik.** Ms. Malik is the Principal Attorney with Malik Law Firm based in Renton which specializes in immigration law. Her application materials indicate that she has "extensive experience advocating for diverse communities, navigating regulatory requirements, and ensuring that organizational decisions prioritize fairness, transparency, and long-term impact."

### SUBJECT

Proposed Motion 2025-0341 would confirm the appointment of Karen Hartfield to the King County Board of Health to serve as the alternate seat representing public health, health care facilities, and providers for a three-year term.

### BACKGROUND

**King County Board of Health.** The King County Board of Health (KCBOH) sets county-wide public health policy, enacts local public health regulations, and carries out duties specified in RCW 70.05.060 including enforcing state public health statutes, preventing and controlling the spread of infectious disease, abating nuisances, and establishing fees for licenses, permits and other services. The KCBOH Code includes but is not limited to, requirements pertaining to food service, pesticides, the handling of solid waste and hazardous materials, on-site sewage, tobacco products, and swimming pools. The 2011 interlocal agreement<sup>1</sup> between King County and City of Seattle regarding Public Health—Seattle & King County (PHSKC) reinforces that the Board provides policy influence over PHSKC pursuant to RCW 70.05.060 and supervises matters pertaining to the preservation of the life and health of the people within its jurisdiction.

In 2025, the KCBOH was restructured in accordance with state law through Ordinance 20019<sup>2</sup> and BOH25-03.<sup>3</sup> The Board consists of King County Councilmembers, City of Seattle Councilmembers, elected members selected by the Sound Cities Association, representatives from the Snoqualmie Indian Tribe, the Muckleshoot Indian Tribe, and the Seattle Indian Health Board, and nonelected members. The nonelected members represent the following three categories, as defined by state law: public health, health care facilities, and providers; consumers of public health; and other community stakeholders.<sup>4</sup> The structure of the 20-member Board is shown in Table 1.

**KCBOH Vacancies and Recruitment.** The term for the Boardmember for the alternate position representing public health, health care facilities, and providers ended in 2025, and the Boardmember chose not to serve an additional term; therefore, the Board recruited for the vacant alternate position.

Public Health staff released applications for the vacant alternate position in June 2025 and closed recruitment in July. Public Health staff distributed notices of the vacancy to those subscribed to the Board of Health email distribution list, as well as posting on the PHSKC Blog<sup>5</sup> and advertisements in the local newspapers of record. Applications were made available in English and Spanish and other languages upon request.

A subcommittee consisting of Boardmembers Christopher Archiopoli, Butch de Castro, Lisa Chew, and Mustafa Mohammed volunteered to review applications and interview candidates for the vacant position. The Board received ten applications, four were invited for interviews, and three candidates participated in an interview with subcommittee members of the Board and PHSKC staff in September. Candidate Karen Hartfield was moved forward by resolution at the October 16, 2025, meeting.<sup>6</sup> Ms. Hartfield's appointment would be for a three-year term to expire December 31, 2028.

## **APPOINTEE INFORMATION**

**Karen Hartfield.** Karen Hartfield is a Clinical Assistant Professor at the University of Washington School of Public Health and recently retired from a 36-year career with Public Health – Seattle & King County. She has experience planning, implementing, and evaluating a wide range of public health programs, including HIV/STI/HCV, overdose

prevention, communicable disease epidemiology, chronic disease prevention, and reproductive health. Ms. Hartfield has also worked with community-based organizations and other community partners.

Ms. Hartfield holds a Bachelor of Arts degree from Harvard University and a Master of Public Health degree from the University of North Carolina at Chapel Hill.

## **ANALYSIS**

Staff has not identified any issues with the proposed appointment. It appears to be consistent with the requirements of county code and state law.

#### **SUBJECT**

Proposed Motion 2026-0012 would make an appointment to fill a judicial vacancy in position number one of the West Division of King County District Court.

#### **SUMMARY**

There is a judicial vacancy in the West Electoral District of King County District Court Position 1. Under state law, the King County Council, as the county legislative authority, is directed to fill district court vacancies by appointment.<sup>1</sup> The King County Code provides a merit selection process for filling such vacancies.<sup>2</sup> There are two eligible applicants to be interviewed during the January 27, 2026, Committee of the Whole meeting.

In its current form, proposed motion 2026-0012 has a blank for the name of the person being appointed. A verbal line amendment would be needed to insert the name of the selected appointee.

#### **BACKGROUND**

King County District Court is the County's court of "limited jurisdiction" and has responsibility for traffic infractions, small claims, and misdemeanor criminal offenses in the County's unincorporated areas, cities that do not have municipal courts and contract with the court to provide those services, and for the adjudication of "state" offenses (violations of state statute in the county or when the arresting agency is the Washington State Patrol or other state law enforcement agency). The District Court handles approximately 250,000 filings annually throughout the North, South, East, and West Divisions.

Position 1 in the West Electoral District was made vacant by the departure of Judge Lisa Paglisotti. After receiving official notice of the vacancy from District Court Chief Presiding Judge Rebecca Robertson on September 2, 2025, the Clerk of the Council published notice of the vacancy and judicial appointment application process in The Seattle Times. The deadline for the recruitment was October 23, 2025.

## **ANALYSIS**

In accordance with the merit selection process outlined in KCC 2.70.020, by the application deadline, eligible candidates must submit:

1. A current rating of, at a minimum, “qualified” for a district court judicial position from the King County Bar Association and at least one other eligible<sup>3</sup> bar association operating in King County;
2. A letter of interest and résumé;
3. A copy of the completed responses to questionnaires submitted to the King County Bar Association to obtain its rating; and
4. Any supporting information the individual would like the Council to consider.

In accordance with state law, the judge appointed through this process will fill the remainder of Judge Lisa Paglisotti’s term, which will end December 31, 2026.<sup>4</sup>

Two eligible individuals submitted applications. The applicants are listed in alphabetical order:

- Andrew Repanich

Pursuant to KCC 2.70.020.G.1.b(3) the Chair of the Committee of the Whole (COW) has determined the process by which the committee will receive recommendations for selecting final candidates to be interviewed. There are two eligible applicants for this position, and the process was determined to involve the distribution of the applications to all Councilmembers and interviewing candidates at the COW meeting on January 27, 2026. The Committee would need to make a recommendation for appointment, as provided in K.C.C. 1.24.055.D., to full council through a motion that would make the appointment. In its current form, the motion has a blank for the name of the person being appointed. A verbal line amendment will be needed to insert the name of the selected appointee.

## Judicial Candidate Evaluation Process

This is a brief summary of the King County Bar Association judicial candidate evaluation process for contested judicial elections and appointments.

The KCBA utilizes a representative body of its membership in this 85 member panel, to engage in an objective and comprehensive evaluation process designed to promote a high quality bench, and to assist the public by providing important information on judicial candidates in elections. The KCBA conducts evaluations for election and appointment for King County Courts of Limited Jurisdiction and Superior Court. The KCBA conducts evaluations for contested elections only for the Court of Appeals – Division I and the Washington State Supreme Court.

Several tools are used in the evaluation process including the Governor's Uniform Questionnaire, the KCBA supplemental questionnaire, a writing sample, an interview of the candidate, and reference checks. All required forms can be downloaded from the KCBA website at <http://www.kcba.org/For-Lawyers/Judicial-Resources/Judicial-Candidate-Evaluation-Ratings>. Candidates are asked to sign a release of information for WSBA disciplinary records as part of the KCBA supplemental questionnaire. For sitting judges, public Judicial Conduct Commission records are reviewed.

A copy of the KCBA Judicial Candidate Evaluation Screening Committee rules and procedures is also available on the website. **It is strongly recommended that you review the rules prior to submitting an application.**

Once you have completed all the evaluation materials, send them electronically to Anne Daly at [AnneD@kcba.org](mailto:AnneD@kcba.org) and Molly Gough at [MollyG@kcba.org](mailto:MollyG@kcba.org). You do not need to mail a hard copy. Once all your materials have been received, you will be scheduled for an interview with the Judicial Candidate Committee. Candidates may request a rating for one or multiple levels of the court.

Evaluation sessions are held two times a month, with 2-3 people evaluated at each session. Typically sessions are filled 2-3 months in advance. This means you should plan on submitting your materials and requesting a rating at least 8-12 weeks in advance of when you need your rating. For those considering an appointment to the bench, it is recommended you obtain a rating in advance a position becoming available. Due to the fairly quick turn-around time of appointments, especially in courts of limited jurisdiction, and the volume of individuals seeking appointment to open seats, ratings for appointment should be sought well in advance of a vacancy occurring.

About three weeks prior to your scheduled interview, committee members will be provided with your materials and assigned references to contact. References are advised of the confidential nature of the inquiry and their responses. All references are contacted by phone. We do not conduct reference checks by email. Because of the time required to contact all listed references, it is not possible to simply "plug" another candidate into a session slot when there is a cancellation.

A quorum of at least 12 committee members will be present at your scheduled interview. The interview will typically last 30 minutes and you will be given the opportunity to make some brief opening and closing comments. The areas of questions asked by the committee will vary from candidate to candidate however, they will focus on the same areas of judicial qualifications (objectivity; temperament; legal/trial/judicial experience; etc.) The committee may ask you to comment on concerns, if any, which have been brought to their attention during the reference check process.

Immediately following your interview, those committee members present at your interview will discuss your qualifications and vote on your rating.

The reference checks, your interview, and the committee deliberations are confidential and the information obtained during the process is not disclosed. During the reference check process, committee members will disclose your name and level(s) of court for which you are seeking a rating.

In issuing a rating, the Committee will take your completed questionnaire; writing sample; reference checks and your interview into consideration. The Committee may also take other sources of information into account, such as published opinions, referrals to other references, or disciplinary action.

Letters of recommendation will not be provided to or considered by the committee nor will supplemental materials such as journal articles other publications, other than the requested writing sample.

It is the candidate's responsibility to provide accurate contact information for listed references and to provide any updates to the submitted questionnaire.

Candidates will be notified of their rating within 24 hours of their evaluation session. A letter confirming the rating will be sent to the candidate as well.

Candidates are encouraged to read the KCBA Judicial Candidate Evaluation Screening Committee rules and procedures and to familiarize themselves with the criteria for each rating, prior to submitting their materials.

The KCBA publishes ratings for any candidate who has filed election paperwork with the state Public Disclosure Commission of the King County Elections Department. Ratings for appointment are shared with the appointing authority, however they are not published or shared publicly.

The KCBA Judicial Candidate Evaluation Committee has a diverse membership with regard to gender, race, age, type of practice, size of firm, geographic, and other factors considered relevant. Members at an individual evaluation session are selected ad hoc from the overall committee roster. Additionally, the committee roster includes a dozen non-attorney members and up to 2 non-attorneys may participate in a candidate's evaluation session.

KCBA realizes our process is a demanding one and we appreciate the time and taken by both candidates and committee members to ensure a high quality bench.

For those considering an appointment to the bench, it is recommended you obtain a rating in advance of a position becoming available. Due to the fairly quick turn-around time of appointments, especially in courts of limited jurisdiction, and the volume of individuals seeking appointment to open seats, ratings for appointment should be sought well in advance of a vacancy occurring.

About three weeks prior to your scheduled interview, committee members will be provided with your materials and assigned references to contact. References are advised of the confidential nature of the inquiry and their responses. All references are contacted by phone. We do not conduct reference checks by email. Because of the time required to contact all listed references, it is not possible to simply "plug" another candidate into a session slot when there is a cancellation.

A quorum of at least 12 committee members will be present at your scheduled interview. The interview will typically last 30 minutes and you will be given the opportunity to make some brief opening and closing comments. The areas of questions asked by the committee will vary from candidate to candidate however, they will focus on the same areas of judicial qualifications (objectivity; temperament; legal/trial/judicial experience; etc.) The committee may ask you to comment on concerns, if any, which have been brought to their attention during the reference check process.

Immediately following your interview, those committee members present at your interview will discuss your qualifications and vote on your rating.

The reference checks, your interview, and the committee deliberations are confidential and the information obtained during the process is not disclosed. During the reference check process, committee members will disclose your name and level(s) of court for which you are seeking a rating.

In issuing a rating, the Committee will take your completed questionnaire; writing sample; reference checks and your interview into consideration. The Committee may also take other sources of information into account, such as published opinions, referrals to other references, or disciplinary action.

Letters of recommendation will not be provided to or considered by the committee nor will supplemental materials such as journal articles other publications, other than the requested writing sample.

It is the candidate's responsibility to provide accurate contact information for listed references and to provide any updates to the submitted questionnaire.

Candidates will be notified of their rating within 24 hours of their evaluation session. A letter confirming the rating will be sent to the candidate as well.

Candidates are encouraged to read the KCBA Judicial Candidate Evaluation Screening Committee rules and procedures and to familiarize themselves with the criteria for each rating, prior to submitting their materials.

The KCBA publishes ratings for any candidate who has filed election paperwork with the state Public Disclosure Commission of the King County Elections Department. Ratings for appointment are shared with the appointing authority, however they are not published or shared publicly.

The KCBA Judicial Candidate Evaluation Committee has a diverse membership with regard to gender, race, age, type of practice, size of firm, geographic, and other factors considered relevant. Members at an individual evaluation session are selected ad hoc from the overall committee roster. Additionally, the committee roster includes a dozen non-attorney members and up to 2 non-attorneys may participate in a candidate's evaluation session.

KCBA realizes our process is a demanding one and we appreciate the time and taken by both candidates and committee members to ensure a high quality bench.
