SUBJECT

Proposed Motion 2024-0382 would confirm the Executive's appointment of Velma Veloria, who resides in Council District Two, to the King County International Airport Roundtable, as the Beacon Hill community representative. The term would be a partial term expiring on August 31, 2026.

BACKGROUND

The Council established the King County International Airport (KCIA) Roundtable in 1997.¹ The purpose of the Roundtable is to advise and make recommendations to airport management, the Executive, and the Council on the airport budget, programs, regulations, master plans and noise reduction strategies, and other related matters.

The Roundtable is comprised of eighteen regular voting members and one non-voting member representing the following interests:

- Communities directly affected by the airport (ten members). One each from South Park, Georgetown, Beacon Hill, Rainier Valley, West Seattle, Magnolia or North Seattle, Tukwila, Renton/Kent/South King County, unincorporated King County, and one at-large;
- **Airport tenants (four members).** One each from a cargo operator or scheduled air carrier, small general aviation and corporate tenants, and one from Boeing;
- Commercial enterprise, which is an off-site user or off-site provider of airport-related services (one member);
- Pilots' association (one member);
- Labor (two members); and
- Federal Aviation Administration (one ex-officio non-voting member).

Regular members of the Roundtable are appointed by the Executive and subject to confirmation by the Council, except for members representing Georgetown, Tukwila,

Beacon Hill, Rainier Valley, and South Park.² These five members shall be nominated for appointment by the Executive in consultation with the elected representative(s) of the respective county council district(s) and approved by the Council via motion.³

Roundtable members can serve up to two consecutive three-year terms or until a successor is appointed,⁴ and the terms are staggered consistent with the provisions of K.C.C. Chapter 2.28. The Roundtable is authorized to adopt bylaws and operating rules and appoint subcommittees. Subcommittee membership may include representatives who are not regular members of the Roundtable. The Executive may also appoint non-voting ex-officio members to serve at the Executive's discretion.

APPOINTEE INFORMATION

Ms. Veloria is a former Washington State Representative who resides in the Beacon Hill community. Her application materials indicate that her home there is under the flight path of KCIA and directly impacted by the noise and air pollution from the airport. According to her curriculum vitae, she has been a community organizer for more than 40 years. 5 Ms. Veloria continues to be active organizing for different causes and one of them is the King County International Airport Community Coalition (KCIACC). According to the organization's website, the KCIACC "works for health, climate and environmental justice to preserve the history and uplift the long-standing impacted communities in Allentown-Tukwila, South Park, Georgetown, Beacon Hill and Duwamish Valley Neighborhoods." According to Ms. Veloria's application materials, the KCIACC advocated for the December 2023 changes to the King County Code governing the KCIA Roundtable. The changes included expanding the size of the Roundtable to provide for additional representation from Beacon Hill and South Park and requiring the five members representing Georgetown, Tukwila, Beacon Hill, Rainier Valley, and South Park to be nominated for appointment by the Executive in consultation with the elected representative(s) of the respective County Council district(s) and approved by the Council via motion.8

ANALYSIS

Staff has not identified any issues with the proposed appointment. It appears to be consistent with the requirements set by the King County Code.

SUBJECT

Proposed Motion 2024-0399 would confirm the Executive's appointment of Harium Martin-Morris, who resides in Council District One, to the King County Museum of Flight Authority Board of Directors. The term would be a partial term expiring on December 31, 2026.

BACKGROUND

King County created the King County Museum of Flight Authority ("Authority") in 1985 to "provide for the development and operation of a first class air and space museum." The Authority is an independent legal entity governed by its Charter and By-laws. The Authority's Board of Directors consists of seven individuals appointed as follows by the King County Executive, subject to confirmation by a majority of the County Council:

- Three at-large members;
- Three members from nominations made by the Board of Trustees of the Museum of Flight or its successor; and
- One member from nominations of the Board of Directors.

Scope of Powers: Article V, Section 5.01 of the Authority's Charter sets forth its powers. These include the power to:

- Own and sell real and personal property;
- Contract for any corporate purpose with the federal government, a state, and any
 political subdivision or agency of either, and with individuals, associations and
 corporations;
- Lend and borrow funds:
- Perform all manner and type of community services and activities; and
- Issue negotiable bonds and notes.

Other powers and limitations on powers are set forth in Sections 5.01 and 5.02 of the Authority's Charter.

APPOINTEE INFORMATION

Harium Martin-Morris is a resident of Council District 1 and has been nominated for an Executive at-large position on the Museum of Flight Authority Board of Directors. He is currently retired but, according to application materials, has years of experience that blend public service, classroom teaching, and business. Mr. Martin-Morris retired from the Boeing Company in 2015 after 17 years in software development. He was also an elected member of the Seattle School Board from 2007 to 2015. Following his retirement from Boeing, he started and operated a consulting group focused on school district communication, equity, and school improvement.² Mr. Martin-Morris currently serves on numerous boards and commissions, including the Washington State Board of Education, the Washington State Charter Schools Commission, and the Board of Directors for the Boeing Employees' Flying Association Charitable Trust.

ANALYSIS

Staff has not identified any issues with the proposed appointment. It appears to be consistent with the requirements set by the King County Code and the King County Museum of Flight Authority Charter.
