A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF A COOPERATION AGREETMENT BETWEEN KING COUNTY AND THE HOUSING AUTHORITY OF THE COUNTY OF KING, WASHINGTON AND RATIFYING

DEREAS, the Housing Authority of the County of King, Washington, proposed to develop and administer a low-rent housing project or low-rent housing projects consisting of approximately three hundred (300) low-rent housing units and consisting of two hundred fifty (250) Elderly low-income units and fifty (50) Family low-income units; and

NHIRRAS, there exists in King County unsafe and insanitary dwelling accommodations of a number greatly in excess of said two hundred fifty (250) Elderly low-income units and fifty (50) Family low-income units which are occupied by families and senior citizens and which constitute a menace to the health, safety, morals, and wolfare of the inhabitants of the County; and

WHEREAS, there are now families and cenior citizens of low income in King County of a number greatly in excess of three hundred who are forced to inhabit such unsafe and insanitary dwelling accommodations, because private enterprise has not been able to make available to such families, safe and sanitary dwelling accommodations at rentals at which low-income families and senior citizens can afford to pay; and

WHEREAS, notice of a hearing to be held on <u>December 8, 1969</u>, 1969, was posted in three public places as required by RCW 35.83.030(10) and a public hearing was held on said date; and

WHEREAS, the County Councilmen unanimously voted to enter into a Cooperation Agreement with the Housing Authority of the County of King to develop and administer public housing for persons of low income consisting of a total of three hundred low-rent housing units consisting of two hundred fifty (250) Elderly low-income units and fifty (50) Family low-income units, and the County Councilmen thereupon immediately signed and executed said Cooperation Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Councilmen of King County:

Section 2. This Resolution shall take effect immediately, and need not be laid over or published or posted, pursuant to Section 35.83.060 of the Revised Code of Washington.
