WHEREAS, it is deemed necessary and in the best interests of King County and its inhabitants that the County issue and sell the remaining \$30,000,000 par value of the total not to exceed \$40,000,000 par value of authorized Multi-Purpose Stadium General Obligation Bonds, 1968, of the County, of which \$5,000,000 par value were heretofore issued as Series A under date of December 1, 1968, and \$5,000,000 par value were heretofore issued as Series B under date of July 1, 1969; and

WHEREAS, it is further deemed necessary that nationally recognized attorneys experienced in such matters be retained as bond counsel to participate with the King County Prosecuting Attorney in drafting the ordinances, notices and other documents necessary for the issuance, sale and delivery of such bonds, and to give their opinion as to the validity thereof at the time of their sale;

NOW, THEREFORE, be it moved by the Council of King County: that Roberts, Shefelman, Lawrence, Gay & Moch, attorneys at law of Seattle, Washington, are hereby employed by the County in drafting the ordinances, notices and other documents required by the County in connection with the issue and sale of \$30,000,000 par value "Multi-Purpose Stadium General Obligation Bonds, 1968, Series C";

THAT the service to be rendered by said law firm is participation in the drafting of all ordinances, notices and other documents through the issuance and sale of the bonds, and the furnishing of an approving legal opinion upon the validity of such bonds at the time of the delivery thereof to the purchasers;
