A MOTION providing authorization for King County to apply for funding assistance for open space land acquisition for the East Central Lake Sammamish Park with the U.S. Department of Housing and Urban Development as provided by Title VII of the Housing Act of 1961 as amended.

WHEREAS, by Motion No. 131, dated February 2, 1970, the King County Council approved East Central Lake Sammamish Park and authorized the submission of an application to the Department of Housing and Urban Development for grant assistance to acquire and develop the land under Title VII of the Housing Act of 1961, as amended, and

WHEREAS, it is now in the public interest to change the size of East Central Lake Sammamish Park to approximately 5.97 acres at a cost of approximately \$452,750, and to change the location, as follows: Portion of Government Lot 1 in Section 6, Township 24 North, Range 6 East, W.M., and the abutting shorelands as described in Sheriff's deed, recorded in Volume 1553 of Deeds, page 83, records of King County, Washington; beginning at the intersection of the north line of said Government Lot 1 and the westerly line of the Northern Pacific right of way; thence, southerly along said right of way 850 feet; thence, west to the shore of Lake Sammamish; thence, northerly along the shore of Lake Sammamish 850 feet more or less to a point on the north line of said Government Lot 1; and thence, east along said north line to the point of beginning. Also known as replat of Mason's Lakeside as recorded in Volume 37 of Plats, page 55, records of King County, Washington.

NOW, THEREFORE, BE IT MOVED by the Council of King County, Washington:

- 1. That an application be made to the Department of

1 Housing and Urban Development under Title VII of the Housing Act
 2 of 1961, as amended, for a grant in the estimated amount of
 3 \$226,375 for changing the size and location of East Central Lake
 4 Sammamish Park; the Applicant is to pay the balance of the cost
 5 from other funds available to it.

6 2. That the County Executive is hereby authorized and
 7 directed to make formal application to the Department of Housing
 8 and Urban Development, and to execute such contracts as are re-
 9 quired by above agency.

10 3. That the proposed acquisition and development are in
 11 accordance with plans for the allocation of land for open-space
 12 uses, and that, should said grant be made, the Applicant will
 13 acquire, develop, and retain said land for the use designated in
 14 said application and approved by the Department of Housing and
 15 Urban Development.

16 4. That the United States of America and the Department of
 17 Housing and Urban Development be, and they hereby are, assured
 18 of full compliance by the Applicant with regulations of the
 19 Department of Housing and Urban Development effectuating Title VI
 20 of the Civil Rights Act of 1964.

21 5. That the Federal/State Grant Coordinator is hereby
 22 authorized to provide additional information and to furnish such
 23 documents as may be required by the Department of Housing and
 24 Urban Development and to act as the authorized correspondent for
 25 King County.
