LONG-RANGE GOALS

- *Comprehensive planning in law enforcement, crime prevention and effective legislation in the area of criminal justice.
- *Development of a balanced program of parks, recreation and cultural opportunities.
- *Unified effort to establish and maintain a planning system under which man and nature can exist in productive harmony.
- *Plan for an orderly suburban development of the County; the movement of the industrial base from the central core; the spread and improvement of the economic base; and the relief of conjestion.
- *Consolidation of governmental units where feasible; coordination and cooperation with other governmental jurisdictions to provide effective, economical services.
- *Greater communication between the government and public to achieve a government that is responsive to the people and their communities.
- *Advancement toward an effective health delivery system, a comprehensive health plan and the coordination of public health service fields.
- *On-going study and planning in the area of public works, i.e., water and hydraulic control, solid waste, surface and air transportation.
- *Promotion of our history and cultural background through our educational system and tourist programs.
- *Participation in regional project decision-making.
- *De-emphasize County land taxes. Devise and develop a fiscal program to meet the needs of the public and the community through equitable taxation methods.

OBJECTIVES FOR 1973

- *Analysis of response-time and crime data in Public Safety for legislative implementation to reduce response-time and crime.
- *Develop a compatible comprehensive plan for the entire county utilizing the open space concept, and involvement by the Environmental Development Commission, Economic Development Council, and the citizens of the County.
- *Develop a coordinated mobile health unit system to serve the citizens in the incorporated and unincorporated areas of King County.
- *Re-evaluate the County budget and the fiscal operation of the County departments to provide and maintain the highest quality of service to the public at the lowest possible cost.
- *Develop a transportation system to include construction of new roads, a maintenance program for existing roads, construction of pedestrian walkways, and a plan for underground utilities and transmission lines.
- *Expand the county recreational and educational programs in the visual arts, music, dance and drama.
- *Consolidate all services to the public where feasible through intergovernmental agreements.
- *Provide for a plan to allow interpark trail connections, a pilot project for utilization of County parks for overnight camping and a study of a proposed park ranger system.
- *Implement a personnel system to provide an employee awards program, employee evaluation program, a merit pay plan and qualified women and minorities in every echelon of government.
- *Develop modern methods for the handling and recycling of solid waste to include site selection, transportation, and disposal systems.
