19 in the King-Snohomish Manpower Consortium, whose governing board
20 is composed of representatives of participating jurisdictions,

22 WHEREAS, King County has six votes on the governing board
23 of the King-Snohomish Manpower Consortium,


24 NOW THEREFORE, BE IT MOVED by the Council of King County:

30 have one (1) representative.

WHEREAS, King County has six votes on the governing board of the King-Snohomish Manpower Consortium,


NOW THEREFORE, BE IT MOVED by the Council of King County:


