MOTION NO.

A MOTION directing the County Executive to modify the proposed 1975-1980 Capital Budget and Program.

WHEREAS, the King County Executive has proposed to the Council the 1975 - 1980 Capital Budget and Program, and

WHEREAS, the Council has reviewed the Proposed 1975-1980 Capital Budget and Program during their review of the 1975 budget, and

WHEREAS, the Council has adopted in the 1975 budget appropriations to support a 1975 Capital Program but has not adopted the individual projects to be funded from those appropriations, pending compliance with Ordinance No. 2230, Section 69 provisos, and

WHEREAS, the review of the Executive's Proposed 1975-1980 Capital Budget and Program resulted in a number of proposed changes,

NOW THEREFORE, BE IT MOVED by the Council of King County:

The King County Executive is hereby directed to modify
the Proposed 1975-1980 Capital Budget and Program to include
the following:

- 1. A 1975 budget of \$10,000 in project 081732 Lake
 Forest Park;
- 2. A new project for a Shoreline Pool to be programmed in 1977 at a cost of \$900,000;
- 3. A new project for a Bellevue Pool to be programmed in 1976 at a cost of \$900,000;
- 4. A one year acceleration of the Marymoor Park Program (Project Number 030061) with a 1975 budget of \$100,000 and programmed expenditures of \$360,000 in 1976 and \$900,000 in 1977;
- 5. An acceleration of Steel Lake Park(Project No. 040021) including expenditures of \$450,000 each in 1976 and 1977;
- 6. An acceleration of North Des Moines Beach (Project No. 050191) to include program expenditures of \$698,000 in 1976

and \$2,007,000 in 1977;

- 7. A 1975 budget of \$235,000 for Valley Ridge Park (Project No. 070261);
- 8. A 1975 budget of \$50,000 for Northeast 104th Street
 (Project No. 201274);
- 9. A change in the scope of work of Lakemont Boulevard (Project No. 405571) to provide a split alignment and profile to provide a two-lane roadway except where the incline requires an uphill passing lane;
- 10. A 1975 budget of \$104,000 for South and Southwest 320th (Project No. 800576) and programmed expenditures of \$56,000 in 1976, and \$800,000 in 1977;
- 11. An estimated total project cost of \$997,000 for Peasley Canyon Road (Project No. 800973);
- 12. Reinstatement of Military Road South (Project No. 800473) with programmed expenditures of \$180,000 in 1976, \$311,000 in 1977 and \$695,000 in 1978;
- 13. Reinstatement of South 296th, 64th South and South 292nd (Project No. 800872) with programmed expenditures of \$86,000 in 1977, \$126,000 in 1978 and \$358,000 in 1979;
- 14. Reinstatement of 51st Avenue South extension (Project No. 800372) with programmed expenditures of \$78,000 in 1978, \$75,000 in 1979 and \$369,000 in 1980;
- 15. Reinstatement of South 360th Street (Project No. 800174) with programmed expenditures of \$135,000 in 1976, \$144,000 in 1977 and \$627,000 in 1978;
- 16. Provision to complete Echo Lake to Kerriston (Project No. 501969) by December 31, 1976. The right of way should be acquired by the Real Property Division as soon as possible and the Department of Public Works and Transportation is to

negotiate with the City of Seattle Water Department to establish a two-year program for construction of this road. 17. A 1975 budget and 1976 and 1977 programmed expenditures for design, construction and contingency only for Federal Way Community Park (Project No. 070011).
