MOTION NO.

A MOTION authorizing the County Executive to execute a contract between the Washington State Department of Social and Health Services and King County for the provision of alcoholism detoxification facilities at Fircrest School - South Campus.

WHEREAS, the Uniform Alcoholism Treatment Act mandates the provision of alcoholism treatment rather than incarceration, and

WHEREAS, the County Council recognizes the responsibility to provide adequate services and facilities for the treatment of alcoholism, and

WHEREAS, the County believes this action will further complement a full continuum of care in the area of alcoholism to King County residents,

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The County Executive is authorized to enter into contract between the Washington State Department of Social and Health Services and King County for the provision of alcoholism detoxification facilities at Fircrest School - South Campus. This action supercedes and replaces action approved in Motion No. 1809. This agreement is attached hereto and by this reference made a part hereof the motion.

ACTING

NONDISCRIMINATION

During the period of this agreement, the Occupant shall not, while occupying the space provided herein, on grounds of race, color, sex, religion, or national origin:

- a) Deny an individual any services or other benefits.
- b) Provide any service(s) or other benefits to an individual which are different or are provided in a different manner, from those provided to others.
- c) Subject an individual to segregation or separate treatment in any matter related to his receipt of any service(s) or other benefits of the Occupant.
- d) Deny any individual an opportunity to participate in any program provided by the Occupant or afford him an opportunity to do so which is different from that afforded others.

The Occupant will not utilize criteria or methods of administration which have the effect of subjecting individuals to discrimination because of their race, color, sex, religion, or national origin.

RIGHT OF ACCESS

The Occupant shall provide right of access to that space assigned under this agreement to the Department, or any of its officers or to any other authorized agency or official of the State of Washington or the federal government at all reasonable times insofar as such right of access shall, in the judgment of the Department, be required to safeguard the health, safety and welfare of any or all persons within a reasonable proximity thereof, or to insure the maintenance of an acceptable state of cleanliness and sanitation or to maintain, modify, remove or install any utilities or fixtures therein.

TERMINATION FOR CONVENIENCE

Occupant or the Department may terminate this agreement at any time during the period of agreement upon thirty (30) days written notice.

ALL WRITINGS CONTAINED HEREIN

This agreement contains all the terms and conditions agreed upon by the parties. All items incorporated by reference are attached. No other understandings, oral or otherwise, regarding the subject matter of this agreement shall be deemed to exist or to bind any of the parties hereto.

IN WITNESS WHEREOF. The parties have executed this agreement on this
