erty to the City of Issaquah, such lands  
2 known as Tax Lot 18, 20 (2 Parcels) and 46,  
Sec. 34, Twp 24 N., Rge 6 E., W.M.

3 WHEREAS, the City of Issaquah, a municipal corporation of  
4 the State of Washington, is authorized to purchase tax title prop-  
5 erty in accordance with the provisions of R.C.W. 84.64.320, and

6 WHEREAS, the City of Issaquah deems it necessary to purchase  
7 the subject lands for roadway purposes, and

8 WHEREAS, the City of Issaquah has offered \$133.22 for the  
9 property, and

10 WHEREAS, the King County Council does hereby determine it  
11 to be in the best interest of the citizens of King County to sell  
12 subject lands to the City of Issaquah.

13 NOW THEREFORE, BE IT MOVED by the Council of King County:

14 The King County Executive is hereby authorized to execute  
15 or cause to have executed the necessary instruments conveying  
16 the following described lands to the City of Issaquah:

17 PARCEL 1 - The East 600 ft. of the West 796 ft. of the  
18 South 20 ft. of the North 810 ft. of the NE 1/4 of the  
NW 1/4, Sec. 34, T. 24 N., R. 6 E., W.M. (Tax Lot 18)

19 PARCEL 2 - Beginning 150 ft. South and 958.5 ft. West  
20 of the North 1/4 Corner of Sec. 34; thence South 20  
21 ft.; thence West 50 ft.; thence North 20 ft.; thence  
East 50 ft. to the point of beginning; Sec. 34, Twp  
24 N., Rge 6 E., W.M. (Portion Tax Lot 20)


22 PARCEL 3 - The South 20 ft. of the North 490 ft. of  
23 the West 14 ft. of the East 972.5 ft. of the NE 1/4  
of the NW 1/4, Sec. 34, Twp 24 N., Rge 6 E., W.M.  
24 (Portion Tax Lot 20)


25 PARCEL 4 - Beginning 196 ft. East and 490 ft. South
