A MOTION to amend the 1976 King County Law and Justice Plan and to authorize the County Executive to submit a grant application to the State Law and Justice Planning Office for funds in the amount of \$146,980 for the support of the Youthful Offender Program, King County Grant File No. 658.

WHEREAS, \$146,565 in LEAA grant funds and \$8,043 of State buy-in programmed for Work Release in the 1976 King County Law and Justice Plan will not be used by the Work Release Project, and

WHEREAS, the Youthful Offender Program could operate in 1977 if grant funds were made available for it, and

WHEREAS, the King County Council recognizes that the Youthful Offender Program is a worthwhile project, and

WHEREAS, the County recognizes its obligation to provide as support for the Youthful Offender Program \$7,736 as a cash match.

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- The 1976 King County Law and Justice Plan is hereby amended such that funds originally programmed for the proposed Work Release project be used to provide for operation of the Youthful Offender Program during 1977;
- The King County Executive is hereby authorized to make 2. application to the State Law and Justice Planning Office for funds in the amount of \$146,980, to fund the Youthful Offender Program in calendar year 1977;
- The County Executive is hereby authorized to file and execute such application and contracts as are required by the State;
- The County Executive is also authorized to enter into 4. and execute such subcontracts as are necessary for the implementation of the project; and
