## GRANTS THE ARTS COMMISSION WILL SEEK FOR 1977

1. SOURCE: National Endowment for the Arts

2. AMOUNT: \$10,000

TITLE: Departmental Arts

PROGRAM DESCRIPTION: Artists will be hired to work in various institutions and health service facilities, including the jail, mental health day treatment centers, Children's Orthopedic Hospital and King County Youth Service Center. The grant is being requested to supplement existing arts commission programs by providing two artists from different disciplines at each facility.

MATCHING REQUIREMENTS: 50%. Matching funds will come from the arts commission program budget; this is a supplement to existing programs.

2. SOURCE: National Endowment for the Arts

AMOUNT: \$10,000

TITLE: Professional Services to Community Arts

PROGRAM DESCRIPTION: Professionals will be contracted by the commission to assist the many community arts organizations throughout the County with their own programs. These could involve guest choreographers, theatre directors, musicians, artists, attorneys and accountants. Programs will be worked out between the commission and the organizations.

MATCHING REQUIREMENTS: 50%. Matching funds will come from the commission's community arts budget; this is an extension of existing programs.

3. SOURCE: National Endowment for the Arts

AMOUNT: \$10,000

TITLE: Stadium Mural

PROGRAM DESCRIPTION: Funds are sought to double money available for the second stadium mural thereby to enhance its scale and give greater flexibility in materials.

MATCHING REQUIREMENTS: 50%. Matching funds will come from the commission's visual budget.

4. SOURCE: National Endowment for the Arts

AMOUNT: \$5,000

TITLE: Heritage Festival

PROGRAM DESCRIPTION: Funds are sought to maintain the festival at the high standard achieved during 1976 when Bicentennial funds were available.

MATCHING REQUIREMENTS: 50%. Matching funds will come from the arts commission and parks division budget.

5. SOURCE: Mobil Foundation

AMOUNT: \$5,000

TITLE: Heritage Festival

PROJECT DESCRIPTION: Same as number 4; this is a request for a second year of funding.

MATCHING REQUIREMENTS: None
