A MOTION authorizing execution of an agreement with the Municipality of Metropolitan Seattle for continuation of the shuttle bus service to the King County Domed Stadium.

WHEREAS, King County has entered into an interlocal cooperation agreement with METRO and the City of Seattle to implement the Domed Stadium Parking and Access Plan, which plan includes the operation of shuttle bus service to the Stadium; and

WHEREAS, by Resolution No. 2474 adopted March 4, 1976, the Council of the Municipality established such a shuttle bus service to the Stadium to compliment other forms of public and private transportation thereto; and

WHEREAS, the Municipality and King County have reviewed the requirements of said shuttle bus service and the cost thereof to the Municipality and have determined that the continuation of such service is in the best interests of citizens of King County; and

WHEREAS, the cost of Stadium shuttle service not recovered by fare box revenues has been determined to be approximately \$40,000 per annum; and

WHEREAS, it is equitable and in the public interest that this cost be divided equally between the City of Seattle and King County; and

WHEREAS, the City of Seattle has agreed to provide \$20,000 per annum for 1977 and 1978 for this purpose;

NOW, THEREFORE, BE IT MOVED by the Council of King County that the County shall enter into an agreement with METRO for payment of certain costs for continuation of shuttle bus service to the King County Domed Stadium said agreement to be in the form of Exhibit A attached hereto, and the County Executive is hereby authorized to execute said agreement on behalf of King County. AGREEMENT BETWEEN THE MUNICIPALITY OF METRO-POLITAN SEATTLE AND KING COUNTY FOR CONTINUA-TION OF SHUTTLE BUS SERVICE TO THE KING COUNTY DOMED STADIUM. 2993

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 1977, by and between KING COUNTY, herein called the "County", and the MUNICIPALITY OF METROPOLITAN SEATTLE, herein called "Metro";

### WITNESSETH:

WHEREAS, by Resolution No. 2474 adopted March 4, 1976, Metro established a shuttle bus service to the King County Domed Stadium (herein called the "Stadium") to complement other forms of public and private transportation thereto; and

WHEREAS, by Resolution No. 2483 adopted March 18, 1976, Metro authorized an interlocal cooperation agreement with King County and the City of Seattle to implement the Domed Stadium Parking and Access Plan, which plan included the operation of shuttle bus service to the Stadium; and

WHEREAS, pursuant to Section 10(b) of said interlocal cooperation agreement, Metro and King County have reviewed the requirements of said shuttle bus service and the cost thereof to Metro, and have determined that the concinuation of such service is in the best interests of the citizens of King County; and

WHEREAS, the County has agreed to participate in the costs of operation of said shuttle bus service during 1977;

NOW, THEREFORE, in consideration of the mutual covenants herein contained, it is hereby agreed as follows:

Section 1. Shuttle Bus Service to the King County Domed Stadium. During the term of this Agreement, Metro agrees to provide shuttle bus service to the Stadium according to the level of service and routes as generally shown on Exhibit "A" attached hereto. The County shall reimburse Metro for an equitable share of the operating costs of such shuttle bus service in accordance with Section 2 of this Agreement. Section 2. County Payments. For such shuttle bus service during 1977, the County shall pay to Metro the sum of TWENTY THOUSAND DOLLARS (\$20,000) within thirty-five (35) days after execution of this Agreement. This payment represents the best determination and estimate of the parties of the County's share of the cost of Metro operation of shuttle bus service to the Stadium as described herein.

Section 3. Implementation. Each party shall adopt such other resolutions and take other legislative and administrative action as is necessary to implement this Agreement. This Agreement and any provision thereof may be amended by written agreement of the parties.

Section 4. Term of Agreement. This Agreement shall be effective from April 1, 1977 through December 31, 1977. IN WITNESS WHEREOF, the parties hereto have executed this

Agreement as of the day and year first above written.

#### LEVEL OF SERVICE

Metro will provide shuttle bus service to the King County Domed Stadium for weekend sporting events and approximately six selected weekday events.

The level of shuttle bus service to each event will vary based on anticipated attendance. Full service will be provided to events with attendance in excess of 40,000 people. An appropriate level of reduced service will be provided to weekend sporting events with minimum attendance of 15,000 people.

### ROUTES

Metro will operate such shuttle bus service on two routes which are subject to change as traffic and/or ridership conditions warrant:

- 1. <u>CBD route</u>. Generally, north on 4th Avenue to Pine Street; west on Pine Street to 2nd Avenue; south on 2nd Avenue to the Stadium.
- '2. South loop route. Generally, south on 6th Avenue South to South Lander; west on South Lander to 4th Avenue South; south on 4th Avenue South to South Spokane Street; west on South Spokane Street to Ist Avenue South; north on 1st Avenue South to Atlantic via Occidental and Connecticut to the Stadium.
