A RESOLUTION relating to public safety; transferring jurisdiction of civil and criminal cases from the Town's Municipal Court to the Northeast District Court and establishing the Town's Violation Bureau.

WHEREAS, the Municipal Court of the Town of Skykomish was established at the time of the incorporation of the Town of Skykomish in 1909, and

WHEREAS, benefits relating to jurisdiction and execution of process would accrue to the public and to the Town of Skykomish by transfer of original jurisdiction of all defenses defined by ordinances and/or resolutions of the Town and all other actions brought to enforce or recover any license, penalty or forfeiture declared or given by any ordinance and/or resolution of the Town, and full power to forfeit bail bonds and issue execution thereon and full power to forfeit cash bail, to hear and determine all causes, civil or criminal, arising under the Town's ordinances and/or resultions, and to pronounce judgment in accordance therewith, NOW, THEREFORE,

BE IT ORDAINED by the Council of the Town of Skykomish, Washington:

SECTION 1. All cases, proceedings and matters pending before the Municipal Court of Skykomish shall be transferred to the Northeast District Court of King County, Washington, together with all files, records and proceedings relating to such cases. Such transfers shall not affect any appeal from the Municipal Court of Skykomish but such appeal may be conducted and concluded as though this Resolution had not been enacted, except that, if remanded from the Superior Court, the superseding court shall have the authority and power to forfeit bail or bond or impose sentence thereon.

SECTION 2. The enactment of this Resolution shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall be in existence at the date of such

SECTION 3. The Violations Bureau as permitted by Sections 9 and 52, Chapter 299, Laws of 1961, is hereby established and shall assist in processing traffic cases and such other specific

offenses under Town ordinances and/or resolutions as may be

designated by written order of the judge of the District Court and said Bureau shall have the authority and responsibility

authorized and specified by RCW 3.30.090.

SECTION 4. Notice of this election made by the Skykomish Town Council and the action taken hereby shall be given to the King County Justice Court Districting Committee by delivery of a certified copy of this Resolution to the King County Council.
