MOTION NO. 03373

A MOTION granting an easement and installed facilities in favor of King County Water District No. 61 over Seahurst Park.

WHEREAS, King County Water District No. 61, a municipal corporation of King County, Washington, has made application for the right to own, operate and maintain a water line under and across a strip of land which is a portion of Seahurst Park, and

WHEREAS, investigation reveals that it would be to the County's advantage to grant to Water District No. 61, the easement and installed facilities of a six inch pipeline approximately 2,500 feet long, with fire hydrants and connections as required by the King County Code and Water District No. 61 standards for the consideration of mutual benefits, and

WHEREAS, it is determined to be necessary and in the best interests of the citizens of King County that the said easement be granted,

NOW THEREFORE, BE IT MOVED by the Council of King County:

The County Executive is authorized to sign and deliver the necessary water line agreement, granting to Water District No. 61 the easement and installed facilities described as follows:

That portion of the S.E. 1/4 of Section 13, Township 23 North Range 3 East, W.M., described as follows:

A strip of land 10 ft. wide, extending 5 ft. on each side of the following described centerline:

Beginning at a pt. from which the S.W. corner of the S.E. 1/4 of Sec. 13, Twp 23 N., Rge 3 East, W.M., bears So. $30^{\circ}23'08''$ W. a distance of 1575.45 ft; said pt. being at the end of a previously installed water line; Thence N. $07^{\circ}50'19''$ W. a distance of 113.95 ft; Thence N. $26^{\circ}17'28''$ E. a distance of 193.02 ft; Thence N. $25^{\circ}54'35''$ E. a distance of 216.39 ft; Thence N. $26^{\circ}40'02''$ E. a distance of 76.56 ft; Thence N. $24^{\circ}24'14''$ E. a distance of 119.40 ft; Thence No. $23^{\circ}46'25''$ E. a distance of 92.11 ft; Thence N. $22^{\circ}02'33''$ E. a distance of 284.95 ft; Thence N. $41^{\circ}36'11''$ W. a distance of 65.76 ft; Thence N. $19^{\circ}49'47''$ E. a
