3 A MOTION AUTHORIZING THE PERFORMANCE OF
4 SNOQUALMIE FALLS FOREST THEATER PRODUCTIONS
5 DURING THE MONTHS OF MAY THROUGH OCTOBER
6 1978, 1979, AND 1980 ON CERTAIN PROPERTY
7 OWNED BY CHRISTIAN PLAYERS, INC.

8 WHEREAS, THE KING COUNTY COUNCIL HAS APPROVED, SUBJECT TO
9 CONDITIONS, A PRELIMINARY PLANNED UNIT DEVELOPMENT FOR CERTAIN
10 PROPERTY OWNED BY CHRISTIAN PLAYERS, INC., DESIGNATED LAND USE
11 MANAGEMENT FILE NO. 121-74-P; AND

12 WHEREAS, THE PURPOSE OF THE PLANNED UNIT DEVELOPMENT IS TO
13 ALLOW CULTURAL ACTIVITIES AT THE PROPERTY, INCLUDING THE FOREST
14 THEATER PRODUCTIONS WHICH HAVE BEEN PRESENTED AT THE SITE DURING
15 THE MONTHS OF MAY THROUGH OCTOBER IN PAST YEARS; AND

16 WHEREAS, THE CHRISTIAN PLAYERS, INC., CANNOT COMPLETE ALL OF
17 THE ROAD IMPROVEMENTS REQUIRED FOR FINAL APPROVAL OF ITS PLANNED
18 DEVELOPMENT UNTIL 1980; AND

19 WHEREAS, THE PERFORMANCE OF FOREST THEATER PRODUCTIONS AT
20 THE SITE DURING THE SUMMER OF 1978, 1979, AND 1980 WOULD NOT
21 BE UNREASONABLY DETRIMENTAL TO AFFECTED PROPERTIES AND THE GENERAL
22 PUBLIC IF THE CONDITIONS STIPULATED BELOW ARE SATISFIED;

23 NOW THEREFORE, BE IT MOVED BY THE COUNCIL OF KING COUNTY:
24 THE PERFORMANCE OF FOREST THEATER PRODUCTIONS ON THE CHRISTIAN
25 PLAYERS, INC. PROPERTY WHICH IS THE SUBJECT OF LAND USE
26 MANAGEMENT FILE NO. 121-74-P, IS HEREBY AUTHORIZED DURING THE
27 MONTHS OF MAY THROUGH OCTOBER, 1978, 1979, AND 1980 SUBJECT
28 TO THE FOLLOWING CONDITIONS:

- 29 1. CHRISTIAN PLAYERS, INC. SHALL OBTAIN APPROVAL BY THE
30 DEPARTMENT OF PUBLIC WORKS FOR A METHOD OF CONTROLLING
31 DUST ON THE ACCESS ROAD BETWEEN POWELL ROAD AND THE
32 SITE, AND ON THE ROADS AND PARKING AREAS WITHIN THE
33 SITE. PARTICULAR ATTENTION SHALL BE GIVEN TO THE
CONTROL OF DUST IN THE VICINITY OF THE EXISTING TWO
RESIDENCES ADJACENT TO THE ACCESS ROAD;

2. THE TRAFFIC GENERATED BY THE FOREST THEATER PERFORMANCES SHALL NOT EXCEED 310 VEHICLE ROUND TRIPS PER DAY.
