A MOTION authorizing the County Executive to make grant applications through the Puget Sound Council of Governments for United States Department of Housing and Urban Development Block Grant funds to support several programs furthering the objectives of the Regional Housing Opportunity Plan.

WHEREAS, the Housing and Community Development Act of 1974, as amended, provides for the award of grants to jurisdictions participating in an areawide Housing Opportunity Plan, and

WHEREAS, the Puget Sound Regional Housing Opportunity Plan has been awarded \$1.8 million in Community Development Block Grant funds to be used by participating jurisdictions and agencies to carry out the Regional Housing Opportunity Plan, and

WHEREAS, The county and several other jurisdictions in the region participating in the Regional Housing Opportunity Plan have jointly agreed upon a program for furthering the goals of that Plan by increasing the availability of housing assistance through a flexible land and housing cost writedown program, similar to and in continuation of a program successfully conducted over the past year, and

WHEREAS, in addition, the county has developed several programs, including Urban Self-Help Housing, Airport Home Relocation, and Condominium Purchase Program, which it wishes to carry out on its own in furtherance of the Housing Opportunity Plan.

NOW THEREFORE, BE IT MOVED by the Council of King County:

1. The King County Executive is hereby authorized to make application for funds to the Puget Sound Council of Governments for the following projects:

- A. Undertake a flexible and expanded land and housing cost writedown program for assisted housing with several other regional jurisdictions - \$650,000;
- B. Urban Self-Help Housing Project - \$250,000;
- C. Airport Home Relocation Project - \$25,000; PROVIDED

10 into and execute such subcontracts as are necessary for the  
11 implementation of the project;

12 4. The United States Department of Housing and Urban  
13 Development is hereby assured full compliance with Title VI of  
14 the Civil Rights Act in all activities undertaken in conjunction  
15 with these projects.
