A MOTION related to an amendment to the Snohomish Mediated Plan Intergovernmental Agreement in which King County is a participant.

WHEREAS, the King County Council passed Motion No. 3556 in June, 1978 authorizing the King County Executive to sign an Intergovernmental Agreement indicating King County's participation in the Snohomish Mediated Agreement, and

WHEREAS, the King County Executive signed the Intergovernmental Agreement on behalf of King County along with other governmental jurisdictions in the Snohomish Basin in October, 1978, and

WHEREAS, the Intergovernmental Agreement established the Snohomish Basin Coordinating Council which was to be made up of elected officials and private citizen appointees, and

WHEREAS, the Washington State Congressional Delegation chose not to make their four (4) citizen appointments to the Basin Coordinating Council as called for in the Intergovernmental Agreement, and

WHEREAS, on March 15, 1979, the Basin Coordinating Council unanimously decided to recommend to the original parties to the Intergovernmental Agreement that the Agreement be amended to allow the four (4) citizens to be appointed by government bodies other than the Congressional delegation.

NOW THEREFORE, BE IT MOVED by the Council of King County that:

The King County Executive is authorized to sign an Amendment to the

document entitled Intergovernmental Agreement for Implementation of the
Snohomish River Drainage Basin Mediated Agreement. Said Agreement and
Amendment is attached hereto.

AMENDMENTS TO THE INTERGOVERNMENTAL AGREEMENT
FOR IMPLEMENTATION OF THE SNOHOMISH RIVER
DRAINAGE BASIN MEDIATED AGREEMENT

Sections V.A.5 and 6 of the Intergovernmental Agreement are hereby deleted.

Sections V.A.4 and 7, regarding membership of the Basin Coordinating Committee, are hereby amended to read as follows:


V.A.4. "Four (4) private citizens, two from King County and two from Snohomish County, appointed by the Governor of the State of Washington."

V.A.7. "Six (6) private citizens, three appointed by the Snohomish County Commissioners and three appointed by the King County Council, of which two from each county must initially be drawn from the membership of the Interim Basin Coordinating Council."

These Amendments will become effective upon approval of the governing bodies of all cities, counties or other participating private entities.

As the County Executive of King County, Washington, I execute this Amendment, signifying that the King County Council has, by motion, approved the amendments to the Intergovernmental Agreement. A copy of the document by which this adoption was accomplished is attached.
