

MOTION NO. 4323

A MOTION authorizing the County Executive to make a grant application for funds in the approximate amount of \$195,750 to support acquisition of the Lake Geneva Park Site, Grant File No. 943:2.

WHEREAS, the Council of King County has approved a "Comprehensive Park and Recreation Plan" for the County which identifies a community park in the southwestern part of King County as a County priority, and

WHEREAS, under the provisions of the Land and Water Conservation Fund Act, state and federal funding assistance has been authorized and made available to aid in financing the cost of land for parks and the construction of outdoor recreational facilities of local public bodies, and

WHEREAS, the Council of King County considers it in the best public interest to acquire the Lake Geneva Park Site.

NOW, THEREFORE, BE IT MOVED by the Council of King County:

1. The King County Executive is hereby authorized to make application for funds in the approximate amount of \$195,750 to the Interagency Committee for Outdoor Recreation, on behalf of King County;

2. The King County Executive is hereby authorized to file and execute such application and contracts as are required by the grantor;

3. The King County Executive is also authorized to enter into and execute such subcontracts as are necessary for the implementation of the project;

4. The Interagency Committee for Outdoor Recreation is hereby assured full compliance with Title VI of the Civil Rights Act;

5. Any funding assistance so received be used in the acquisition of the Lake Geneva Park Site in the southwestern part of the County of King, Washington;

Any property acquired with financial aid through the Interagency Committee for Outdoor Recreation be placed in use as an outdoor recreation facility and be retained in such use in perpetuity unless as otherwise provided and agreed to by the County Council, the Interagency Committee for Outdoor Recreation, and any affected federal agency;

7. This resolution will become part of a formal application to the Interagency Committee for Outdoor Recreation.

Project: 007244 Maple Valley to Lake Wilderness Trail

Description:

Council District: No. 9
CIP Planning Area: S.E. Central

This trail includes approximately three and one-half miles of abandoned railroad right-of-way between Maple Valley and the NE shore of Lake Wilderness. It encompasses nearly 30 acres.

Unfunded: An amount of \$179,000 would include land adjacent to the right-of-way to the top of the ridge, where the trail is adjacent to Lake Wilderness, to maintain and enhance the integrity and aesthetics surrounding the trail and the Lake Wilderness Park complex.
